1	SUPPORTING THE APPLICATION AND RESPONSE TO THE REQUEST FOR
12	PROPOSALS ISSUED BY THE NORTH CENTRAL NEW MEXICO ECONOMIC
13	DEVELOPMENT DISTRICT, NON-METRO NEW MEXICO AREA AGENCY ON

19	WHEREAS, the residents of Santa Fe were afforded an opportunity to submit their
20	recommendations for senior services at an advertised public hearing; and
21	WHEREAS, the City of Santa Fe ("City") recognizes that there is a need to provide
22	services for the senior citizens; and
23	WHEREAS, the Division of Senior Services of the City ("DSS") currently administers
24	social services such as congregate meals, home delivered meals, housekeeping, respite
25	transportation, volunteer opportunities, and health promotion activities for senior citizens living

2	WHEREAS, every four years, the North Central New Mexico Economic Development
3	District, Non-Metro New Mexico Area Agency on Aging ("Area Agency on Aging") issues a
4	Request for Proposals for prospective vendors to provide services for senior citizens; and
5	WHEREAS, currently the DSS has a vendor agreement with the Area Agency on Aging
6	to provide services for senior citizens; and
7	WHEREAS, the current vendor agreement expires on June 30, 2022.
8	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
9	CITY OF SANTA FE that the Governing Body:
10	1. Desires to continue services to the senior citizens of our community;
11	2. Supports the application and response to the RFP issued by the Area Agency on
12	Aging; and
13	3. If awarded a vendor agreement, authorizes the execution of such agreement for the
14	2022-2026 funding cycle, July 1, 2022 through June 30, 2026.
