## City of Santa Fe Bulky Items and Yard Waste Collections

City of Santa Fe residential customers may request a fee-based, special pick-up by calling the Environmental Service Division at 505-955-2200. Callers will be scheduled for the next available collection slot, but no same day service is offered. Customers whose Public Utilities account is delinquent more than thirty (30) days are not eligible for service.

Collection is limited to eight cubic yards or less. If it is indicated that the ordered collection is more than eight cubic yards, an ESD staff person will assess the volume and determine additional fees on the Monday of the week of collection. Customer Service staff will place a courtesy call to confirm the collection and communicate any additional fees assessed to the customer for confirmation.

## Guidelines

- Items must be at the curb in an area free of obstructions no later than 7:00 a.m. on the day designated for collection.
- If an additional fee is assessed, follow the instructions given by ESD.
- The material must not obstruct sidewalks or vehicular and pedestrian traffic.
- Please keep the items a minimum of three to five feet away from your garbage and recycling containers, mailbox, fence, wall, water meter, telephone junction box, parked car, low hanging trees or other obstructions (the more space the better).
- Do not locate your large items under trees or low power lines or next to fences or walls.
- Containerize or bundle loose items such as construction debris, plywood, boards, sheet rock, and broken tile.
- Secure all containers and bundles, including boxes and bags, to avoid spillage.
- Containers or bundles must not exceed 50 lbs.
- Place broken glass, cactus plants and other sharp objects in a separate cardboard box and label accordingly.
- In the event the service is no longer required, the customer shall provide the city with advance notice of not less than one (1) city working day. Failure to notify the city shall result in charges to the customer as if collection took place.


## Fees

- $\$ 33.33$ for 8 cubic yards or less
- $\$ 4.17$ for each additional cubic yard beyond the first 8 cubic yards
- NOTE: Tax will be added to all charges

## Helpful Tips:

A cubic yard is the volume of a cube with the length, width and height of one yard ( 3 feet or 36 inches).
One city-issued green 96 gallon trash cart = $1 / 2$ cubic yard ( 2 carts $=1$ cubic yard )
The most common dumpster size is 8 cubic yards.
