10 **A RESOLUTION**

11 **APPROVING THE CITY OF SANTA FE'S PARTICIPATION IN A TRANSPORTATION**  
12 **FUND PROGRAM ADMINISTERED BY THE NEW MEXICO DEPARTMENT OF**  
13 **TRANSPORTATION FOR THE EXTENSION OF PASEO DEL SOL.**

14  
15 **WHEREAS**, the City of Santa Fe ("City") and the New Mexico Department of  
16 Transportation (NMDOT) intend to enter into a grant agreement under the Transportation Fund  
17 Program (TFP) for a local road project; and

18 **WHEREAS**, the total cost of the project is \$800,000 to be funded in proportional share by  
19 the parties hereto as follows:

- 20 1. NMDOT's share shall be ninety-five percent or \$760,000; and  
21 2. The City's proportional matching share shall be five percent or \$40,000; and

22 **WHEREAS**, the City shall pay all costs that exceed the total budgeted amount of  
23 \$800,000, to the extent permitted under law.

24 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
25 **CITY OF SANTA FE** that Governing Body hereby approves a cooperative agreement for Project

1 Control Number LP50022 with the NMDOT for the TPF Program for year 2022 for Paseo del Sol  
2 Extension to design the extension of Paseo del Sol roadway to includes two travel lanes, bicycle  
3 lanes, sidewalks, lighting, and landscaping within the boundaries of the City.

4 **BE IT FURTHER RESOLVED** that this project maintains priority status for the City.

5 **BE IT FURTHER RESOLVED** that the cooperative agreement terminates on June 30,  
6 2025 and the City incorporates all the agreements, covenants, and understandings between the  
7 parties concerning the subject matter and that all such agreements, covenants, and understandings  
8 have been merged into the written agreement.


