MINUTES OF THE SANTA FE MPO TRANSPORTATION POLICY BOARD Market Station June 25, 2015

CALL TO ORDER

The Santa Fe MPO Transportation Policy Board was called to order by Chair Carmichael Dominguez, at approximately 4:45 p.m., on June 25 2015, at Market Station 500 Market Street, Suite 200, Santa Fe, New Mexico.

At the time the meeting was called to order, there was not a quorum of the membership in attendance. The Chair said the Committee can receive reports, and he will move first to Item A, and then to Items D(1), D(2) and D(3), until there is a quorum. With the arrival of Councilor Ives there was a quorum of the membership for the conducting of official business, and following the completion of discussion under Item D(3), the Board completed the balance of the Agenda.

A. MATTERS FROM THE PUBLIC

There were no matters from the public.

D. MATTERS FROM THE MPO STAFF

1. UPDATE ON DRAFT PEDESTRIAN MASTER PLAN

A copy of MTP Review and Adoption Schedule, is incorporated herewith to these minutes as Exhibit "1."

Mr. Tibbetts said the Plan is complete and staff is looking at project ranking right now. He said the areas of critical concern have been developed through specific criteria over two years, and that process is now done. Staff is now working to develop a list of projects from that plan. He said some specific locations have been designated and defined. He said part of the Pedestrian Plan is complicated because everyone wants improvements done in every area now, and there just isn't funding to do that. He said they are very concerned about making sure we can find funding and that they incorporate pedestrian issues beyond just putting in sidewalks, but looking at all pedestrian issues as a part of that process.

Mr. Tibbetts reviewed Exhibit "2." Please see Exhibit "2," for specifics of this presentation.

Chair Dominguez asked if our first view of the Plan will be during the public review period.

Mr. Tibbetts said yes. He said we can schedule the MPO meeting in early August to review and present the entire Plan, and that will count as one of the open house public meetings, noting it has been several months since this Board has see it. We will schedule the Board meeting in early so staff can present it and the Board can review it, so you can get the full picture. He said August 13, 2015, is the suggested date.

Commissioner Stephanics asked if we move the public hearing to August 13, 2015, would that replace the MPO meeting on August 27, 2015.

Mr. Tibbetts said no, because staff is looking to deal with the Metropolitan Master Plan on August 27, 2015.

Commissioner Stephanics asked how much time we would need on August 27th – would we need the full meeting time.

Mr. Tibbetts said that meeting would be for the presentation of the Plan, but not for approval of the Plan. He said we are under a deadline to present an approved TIP amendment before the 15th of August. He said it would be an important meeting on August 13th, but not necessarily a long meeting. He said staff will do a presentation of the Pedestrian Plan to comply with the public review requirement and to do the TIP amendment. And then, if it is recommended by the TCC, on August 27th, it is possible we will be ready and prepared for a vote for final approval.

2. METROPOLITAN TRANSPORTATION PLAN 2015-2040 UPDATE

A copy of the Metropolitan Transportation Plan 2015-2040 update, is incorporated herewith to these minutes as Exhibit "2."

Mr. Aune reviewed the information in Exhibit "2." Please see Exhibit "2," for specifics of this presentation. He said hopefully you will have everything in draft form by next week. He is confident you can see the comments from July 13th at that time

Chair Dominguez said it looks like we may approving both at the same meeting on August 27, 2015.

Commissioner Stephanics asked what is the distribution of this brochure.

Mr. Aune said it is available digitally, so people can look at it online or download it. He said a limited amount will be made available in hard copy, and they will be available on demand as needed.

Commissioner Stephanics asked if this a final version of the Plan.

Mr. Aune said they have been working on it for a month, and this is a first draft, noting they may need to modify it sometime in the next month.

Commissioner Stephanics said some of the County Commissioners are having Town Hall meetings in July in connection with the ICIP plan, and it would be great to have this hand-out so we can explain it.

Mr. Aune said we can label that handout as a draft, and will be close to a final draft coming for public review, that we will use. He asked her to let staff know how many they will need.

Commissioner Stephanics said she needs 50 copies by July 21, 2015, and Mr. Aune said, "Done."

Mr. Wilson said this is a component of the final document.

Chair Dominguez asked if staff will be putting a "Draft" stamp on the Plan.

Mr. Aune said yes, and will get those to the Commissioners for their town halls.

Mr. Wilson said the public can access the plan on their website. He said we tried to interject graphics to capture public attention.

3. TRANSPORTATION IMPROVEMENT PROGRAM UPDATES

A copy of Santa Fe MPO – Transportation Improvement Program (TIP) Project Status Summary, is incorporated herewith to these minutes as Exhibit "3."

Mr. Wilson said this also is in your Board packet. He said staff didn't do any updates to this since the last meeting. He said the project has kicked off which is the diverging diamond at I - 25 and Cerrillos Road, noting there have been some ramp closures in the last two weeks, noting this project has an eighteen month time frame. He said a lot of the others have kicked into high gear. He said the Board can look though the list and get with him if you have any questions.

Councilor Ives arrived at the meeting

Chair Dominguez updated Councilor Ives on the agenda items that don't need approval, and said the Board just finished with Item D(3).

APPROVAL OF AGENDA

MOTION: Commissioner Stephanics moved, seconded by Councilor Ives, to approve the Agenda as presented.

VOTE: The motion was approved unanimously on a voice vote.

APPROVAL OF MINUTES - May 28, 2015.

MOTION: Commissioner Roybal moved, seconded by Councilor Ives, to approve the minutes of the meeting of May 28, 2015, as presented.

VOTE: The motion was approved on a voice vote, with Commissioner Roybal, Councilor Ives and Ms. Haas voting in favor of the motion, no one voting against and Commissioner Stephanics abstaining.

B. PUBLIC HEARING

1. APPROVAL OF THE FFY 2016-2021 TRANSPORTATION IMPROVEMENT PROGRAM (MPO STAFF)

A copy of FFY 2016-2021 Transportation Improvement Program Summary, for Policy Board review and approval on June 25, 2015, is incorporated herewith to these minutes as Exhibit "4."

Mr. Wilson said every two years we are required to create a new Transportation Improvement Program which is our short term funding. He said they have taken the projects listed in the Long Range Metropolitan Planning Organization Plan and tying funding to those and are beginning to move them forward. He said they started developing the TIP back at the beginning of the year. He said they did a call for projects from our member agencies and received applications for a number of projects for consideration. He they were then rated on the MPO Rating System to get a prioritized list of projects.

Mr. Wilson said this typically is a four-year funding program, and they are extending it to 6 years which is included as informational years, but the funding isn't specifically tied in.

Mr. Wilson reviewed the information in Exhibit "4." Please see Exhibit "4," for specifics of this presentation.

Mr. Wilson said your approval today gets this in line, moving forward, and staff will do an amendment.

Councilor Ives said at every City Council meeting Dave McQuarie comes and talks about ADA improvements all over the City, and he never knows how to respond to Mr. McQuarie. He said a lot of these items you are speaking about appear to be related to ADA improvements. He asked if staff could summarize what is going to be done in terms of ADA improvements and when, so we can provide that information to Mr. McQuarie and let him know things are being done.

Responding to Councilor Ives, Mr. Wilson said there are two DOT projects, noting DOT has its own transition plan, and this is part of fulfilling its ADA Transition Plan. He said the City projects go through the City's ADA committee for review, but the DOT has its own ADA Committee.

Councilor Ives said it would be great to be able to provide that information to him. He asked Mr. Wilson if he would send an update to our staff and for staff to work with the Mayor's Committee on Disability to confirm that these are coordinated efforts.

Councilor Ives asked, regarding Item #24 the Downtown Transit Center, if there are any bathrooms in these plans.

Mr. Wilson said no. He said the City applied for Transportation Alternative Program Funds and was awarded \$2 million, which is purely to improve the transit infrastructure at the bus stop.

Councilor Ives said when the Sheridan Avenue Center was before the Business & Quality of Life Committee, bathrooms have been a big issue. He said if the Sheridan Street facility is going to be the main transportation hub for downtown and the Convention Center closes at 5 p.m. then that is an issue. He said as this is moving forward, he would "love to figure out how to coordinate and solve that problem, and make it a very welcoming Transit Center," if you have that capacity. He said he would like to know how this is being coordinated with the City and the other things they are doing.

Mr. Wilson said that effort is being led by Santa Fe Trails, and Jon Bulthuis and his group would be the people to speaking with.

Councilor Ives said he would like to with Mr. Bulthuis in the next week or two and talk this through.

Public Hearing

There was no one speaking to this issue.

The Public Testimony Portion of the Public Hearing Was Closed

MOTION: Councilor Ives moved, seconded by Commissioner Stephanics, to approve this request, as presented.

VOTE: The motion was approved unanimously on a voice vote.

2. APPROVAL OF THE METROPOLITAN PUBLIC TRANSIT MASTER PLAN (MPO STAFF)

Mr. Aune said he is privileged to be standing here at this point. This is the first one of these plans that we have endeavored to do. It has taken a little over a year. He said there is information in the Board packets. He said on Monday, the TCC approved the plan on Monday. He said this Plan is a product of working together with transit providers. An example of how this plan is relevant and is already working is that we received two information requests from Chainbreakers to do a community wide analysis. Secondly, per the request of Santa Fe Community College [SFCC], next week staff, including Jon Bulthuis, himself and Ray from the County, will be joining the President of the SFCC to review recommendations and how to start implementing the plan recommendations. He said he was able to send information to the SFCC President and staff prior to the meeting. He said the KHF consultants and our MPO staff have done a tremendous job.

Mr. Aune thanked Ray who joined the county recently, commenting that he has been a big help during this process. He noted each of the service providers provided a detailed review.

Councilor Ives asked what happens with the Plan at this point in time – this Board approves it and then what happens with it.

Mr. Aune said it basically is the end game. He said staff will take the final product and make it available to the public. It is being incorporated, as we speak, largely into the MTP, the Bicycle Master Plan and the Pedestrian Master Plan. He said the MTP recommends how each plan will be updated within a 5 year period, so it is basically the end game here, but on ly the beginning.

Councilor Ives said so there are four separate plans rolling up into the overall Metropolitan Transportation Plan, and Mr. Aune said this is correct.

Councilor Ives said he would like to get electronic copies.

Chair Dominguez said they are on the website.

Mr. Aune said staff will make sure the Board has electronic copies.

Councilor Ives asked him to send him the link. He asked the timing for rolling the plans into the MTP.

Mr. Aune said basically the ultimate adoption date will be at the Board meeting on August 27, 2015, so presumably everything will be ready. However, they may or may not have the Pedestrian Master Plan, but the goal is to have all 3 Plans ready for the Master Plan review on August 27th.

Councilor Ives asked if it is too much to ask for a copy of each of those Plans, along with the schedule at the beginning of the binder.

Mr. Aune said they are happy to do, and then attach a briefing on the process of each of the Master Plans for the Board and for the record.

MOTION: Commissioner Stephanics moved, seconded by Councilor Ives, to approve the Metropolitan Transportation Plan 2040 Update.

VOTE: The motion was approved unanimously on a voice vote.

Chair Dominguez thanked staff and the others for their hard work on the Plan.

C. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

1. APPROVAL OF PROPOSED CHANGES TO THE NATIONAL HIGHWAY SYSTEM (NHS) ROADWAYS (MPO STAFF)

A copy of Summary of Criteria for proposed changes to the National Highway System, with attachments, is incorporated herewith to these minutes as Exhibit "5."

Mr. Wilson said these are high level roadways, and this project is to identify critical roadways in the nation for moving freight and such. He said all interstates are part of the National Highway System. He said until MAP 21 became effective two years ago, principal arterials were part of the National Highway System based on their importance to the nation in moving freight, the economy and such. He when MAP 21 became effective, there was a mandate in the language that all arterials were to become part of the National Highway System with a few criteria that would knock some of them out of the system. He said Richards Avenue to the Community College is a principal arterial, but because they only connected to another NHS Roadway it didn't get included.

Mr. Wilson said additional roadways were added to the NHS as part of that process. He said the roadway into the Airport is a principal arterial. He said Airport Road, Rodeo Road, Zia Road, St. Michaels and Old Pecos Trail were included. He said since this was done they did a reclassification of the roadways, so a number of roadways were rated as a part of the process last

March. The benefits of being on the NHS is that it makes you eligible for National Highway Preservation Program funds. The downside is that it comes with a lot of requirements – asset management on the facility, and if you are doing work on the roadway, you must meet the federal design standards for the National Highway System or get design exceptions from Federal Highway. Mr. Wilson said you want to be really careful if you are going designating locally maintained jurisdictional roadways that you know what you are taking on.

Mr. Wilson said there has been a reevaluation of NHS County Map 21, and based on the reevaluation of the criteria, he came up with some recommendations, noting those are in Exhibit "5." He said Old Pecos Trail is still an arterial, but there is no longer any connectivity. The other is Guadalupe Street, which is being downgraded to a minor arterial. He said Rodeo Road has been downgraded to a minor arterial. He said the road to the Airport doesn't meet the criteria for NHS designation.

Mr. Wilson said on Monday the TCC recommended approval of the map as it exists at this time. He said the next step after your approval is submission to the DOT for final approval. He said we are on solid ground on these changes and he is interested in the Board's comments.

Commissioner Stephanics said by moving nine roads from the list, we are lessening the federal funds that would come with those roads.

Mr. Wilson said the issue is they become eligible for NHS preservation but the reality of it is whether or not the funds actually would flow to these roadways.

Ms. Haas said roads will still be federally eligibility, but it will fall under the Surface Transportation pot of money. The amount of money for the MPO really isn't really going to change. She said they are working on asset management, looking at all of the requirements, and the *[inaudible]* that are coming out. She said if she was a City or County that could take a road off the list, she would do so, because of all of the requirements.

Councilor lives said he is trying to understand the cost benefit of taking them off, commenting that the road to the airport is a concern of his. He asked, given the location of the National Guard facilities at the airport, does it really make sense to pull that one from the list.

Mr. Wilson said the activity of the National Guard at the Airport is fairly minimal, and he doesn't think it rises to the criteria to keep it on the NHS. He said it still will be classified as a principal arterial and it is still eligible for other pots of federal money.

Councilor lves said if we find we made the wrong decision is there an opportunity to put it back on the list.

Mr. Wilson said yes, within the next month and a half, noting there are still a few months in this process.

Councilor lves said he is happy moving this forward. However, he would like for staff to provide a one sheet report that talks about the cost benefits, how the funding has been used in past years and what funds will not be available due to changes.

MOTION: Commissioner Stephanics moved, seconded by Councilor Ives, to approve the proposed changes.

VOTE: The motion was approved unanimously on a voice vote.

2. PROPOSED CHANGE TO 2015 MEETING SCHEDULE TO ADD JULY 30TH (MPO STAFF)

Commissioner Stephanics asked are we adding two dates or one date to the meeting schedule.

Mr. Tibbetts said staff is adding one date in August, August 13, 2015.

Chair Dominguez said the Pedestrian Master Plan needs a bit more time.

Commissioner Stephanics said she can attend only the first hour of the meeting.

Chair Dominguez said we need staff to call the members of the Board for this meeting and the rest of the meetings until we get into a steady schedule.

MOTION: Commissioner Stephanics moved, seconded by Councilor Ives, to approve the calendar changes as presented.

VOTE: The motion was approved unanimously on a voice vote.

E. MATTERS FROM THE SFMPO TRANSPORTATION POLICY BOARD

Chair Dominguez said he has an email saying that June 29th is the ground breaking for the diamond interchange.

Mr. Quintana said he understands that happened yesterday.

Commissioner Stephanics said she doesn't know anything about it and this is her District.

Mr. Quintana said he heard it in passing.

Chair Dominguez said he received an email from Celeste in the City Manger's Office saying that said Cabinet Secretary Church "invites you to the groundbreaking on June 29, 2015."

Mr. Quintana said he would go with that date.

Chair Dominguez said he has asked staff to follow up with that information and inform the Board.

Chair Dominguez departed the meeting and Vice-Chair Roybal assumed the duties of the Chair.

Mr. Aune introduced Nathan Todd, the MPO intern for the Summer.

Chair Roybal welcomed Mr. Todd to the MPO.

F. MATTERS FROM THE NMDOT AND FHWA

There were no matters from the NMDOT and the FHWA.

G. ADJOURNMENT – Next scheduled meeting August 27, 2015

There was no further business to come before the Board, and the meeting was adjourned at approximately 5:40 p.m.

<u>Summary of Criteria for Proposed Changes to the National Highway</u> System

FEDERAL REGULATIONS

§470.107 Federal-aid Highway Systems.

(b) National Highway System. (1) The National Highway System shall consist of interconnected urban and rural principal arterials and highways (including toll facilities) which serve major population centers, international border crossings, ports, airports, public transportation facilities, other intermodal transportation facilities and other major travel destinations; meet national defense requirements; and serve interstate and interregional travel. All routes on the Interstate System are a part of the National Highway System.

§470.113 National Highway System procedures.

(b) Proposed modifications to the National Highway System shall enhance the national transportation characteristics of the National Highway System and shall follow the criteria listed in §470.107. Proposals shall also consider the criteria contained in appendix D of this subpart.

§470.115 Approval Authority.

Section 103(b), of title 23, U.S.C., allows the States to propose modifications to the National Highway System (NHS) and authorizes the Secretary to approve such modifications provided that they meet the criteria established for the NHS and enhance the characteristics of the NHS. In proposing modifications under 23 U.S.C. 103(b), the States must cooperate with local and regional officials. In urbanized areas, the local officials must act through the metropolitan planning organization (MPO) designated for such areas under 23 U.S.C. 134. The following guidance criteria should be used by the States to develop proposed modifications to the NHS.

Appendix D to Subpart A of Part 470—Guidance Criteria for Evaluating Requests for Modifications to the National Highway System

- 1. Proposed additions to the NHS should be included in either an adopted State or metropolitan transportation plan or program.
- 2. Proposed additions should connect at each end with other routes on the NHS or serve a major traffic generator.
- 6. Proposals should include information concerning the possible effects of adding or deleting a route to or from the NHS might have on other existing NHS routes that are in close proximity.
- 9. Proposed modifications consisting of connections to major intermodal facilities should be developed using the criteria set forth below. These criteria were used for identifying initial NHS connections to major intermodal terminals. The primary criteria are based on annual passenger volumes, annual freight volumes, or daily vehicular traffic on one or more principal routes that serve the intermodal facility. The secondary criteria include factors which underscore the importance of an intermodal facility within a specific State.

PRIMARY CRITERIA

Commercial Aviation Airports

1. Passengers—scheduled commercial service with more than 250,000 annual enplanements.

PROXIMATE CONNECTIONS

Intermodal terminals, identified under the secondary criteria noted above, may not have sufficient highway traffic volumes to justify an NHS connection to the terminal. States and MPOs should fully consider whether a direct connection should be identified for such terminals, or whether being in the proximity (2 to 3 miles) of an NHS route is sufficient.

PROPOSE TO REMOVE THE FOLLOWING:

• Guadalupe Street – From St Francis Dr to Cerrillos Road

Justification: Guadalupe Street between Paseo De Peralta and Cerrillos Road is Functionally Classified as a Minor Arterial and does not function nor is it designed as a NHS Type Roadway

Cerrillos Road – From St Francis Dr to Guadalup Street

Justification: With Guadalupe Street removed there is no connectivity with other NHS roadways at both ends

• Alameda Street - From St Francis Dr to Old Santa Fe Trail

Justification: Alameda is a Functionally Classified as a Minor Arterial and does not function nor is it designed as a NHS Type Roadway

• Old Santa Fe Trail - From Old Pecos Trail to Alameda Street

Justification: Old Santa Fe from Paseo de Peralta to Alameda is Functionally Classified as a Major Collector. Although Old Santa Fe Trail from Old Pecos Trail to Paseo de Peralta it does not function nor is it designed as a NHS Type Roadway. Additionally with Alameda Street removed there is no connectivity with other NHS roadways at both ends.

Old Pecos Trail – From St Michaels Drive to Old Santa Fe Trail

Justification: With Alameda Street removed there is no connectivity with other NHS roadways at both ends.

Old Pecos Trail – From Interstate to Rabbit Road (Frontage Road)

Justification: Does not function as a NHS Type Roadway and there is no connectivity with other NHS roadways at both ends.

Rodeo Road – From Old Pecos Trail to Zia Road

Justification: Rodeo is a Functionally Classified as a Minor Arterial.


• Aviation Drive – From Paseo Real to Airport



• Paseo Real - From NM599 to Aviation Drive



National Highway System: Santa Fe, NM EXISTING




