### MINUTES OF THE SANTA FÉ MPO TECHNICAL COORDINATING COMMITTEE July 20, 2015

### **CALL TO ORDER**

A regular meeting of the Santa Fé MPO Technical Coordinating Committee was called to order on the above date by John Romero, Chair, at approximately 1:30 p.m. in the Large Conference Room, 500 Market Station, Suite 200, Santa Fé, New Mexico.

### **ROLL CALL**

Roll call indicated the presence of a quorum as follows:

### APPROVAL OF AGENDA

Ms. Lucero moved to approve the agenda as presented. Mr. Quintana seconded the motion and it passed by unanimous voice vote.

### APPROVAL OF MINUTES - June 29, 2015

Mr. Matthew moved to approve the minutes of June 29, 2015 as presented. Mr. MacPherson seconded the motion and it passed by unanimous voice vote.

### 1. COMMUNICATIONS FROM THE PUBLIC

There were no communications from the public.

### 2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION:

a. Review and Release for Public Review of a Proposed Amendment to the FFY 2016-2021 Transportation Improvement Program – MPO Staff

Mr. Aune explained that the proposed amendment for the Interstate Pavement Preservation is being split into 2020 and 2021. The handout showing the amendment is attached to these minutes as Exhibit 1.

Mr. Quintana moved to approve the public review of the proposed amendment. Mr. MacPherson seconded the motion and it passed by unanimous voice vote.

### b. Review and Release for Public Review of the Draft Metropolitan Transportation Plan 2015-2040 – MPO Staff

Mr. Aune showed the Table 7-1, Regional Roadway Priorities. He thanked everyone for providing their priorities last week. He indicated that nothing has substantively changed in the plan except these charts and the financial plan.

Mr. Matthew provided comments to clarify the County's plans and another item to discuss later. He said it wouldn't hold up the process.

Mr. Aune reviewed the tables for the Committee using projected slides. He explained that the table defined the constrained list. With the consultant, they fleshed out the table for user friendliness. They translated the numbers into a graphic scoring, using pie chart symbols. It is based on projected revenue and estimated costs. Left in Chapter 8 for constrained projects, there were only three projects. The financial plan articulated a calculation of the base revenue projection.

- Mr. Quintana said that in order to build Richards, we have to add that to the list.
- Mr. Tibbetts said that was the \$30 million item on the chart. The auxiliary lanes are constrained. They were called out as a separate project.
- Mr. Quintana anticipate configuring the Richards interchange any time soon. They re-decked St. Francis. But he didn't think that configuration would be changed again for 25 years.
- Mr. Tibbetts reasoned that the St. Francis interchange should go out of the constrained list and allow us to stay within the bounds.
- Mr. Quintana agreed. We don't have the same weaving concerns we had with Cerrillos Road. The safety concerns are not like at Cerrillos. If we need to do something in the future, it will be more than 25 years from now.
- Mr. Tibbetts said there was the condition of the bridge at St. Francis and weaving to get to Sawmill Road. We can pull it out of the list and note it outside of the table.
  - Mr. Quintana agreed just take it out of fiscally constrained portion but leave it on there.
  - Chair Romero asked if, as part of the plan, we have to note the fiscal constraint.
  - Mr. Tibbetts said no. It just gives more headroom if something else happens.
  - Mr. Matthew asked how much we would have left if those two are taken off.
  - Mr. Quintana said it would be a lot.
- Mr. Tibbetts said they could score them and put them in where they rank. The plan can later be amended if needed. They are high priorities for the County.
- Mr. Matthew agreed. The County is embarking on a long-range plan for transportation. For now, let's carry them forward. It is a conceptual alignment at this point and we might do something different.
- Mr. Quintana moved to release the Draft Metropolitan Transportation Plan 2015-2040 for public review. Mr. MacPherson seconded the motion and it passed by unanimous voice vote.

### 3. MATTERS FROM THE MPO STAFF

Mr. Tibbetts reminded the Committee of the meeting on August 10 for approving the TIP amendment and an update on the Pedestrian Plan. They have been getting lots of comment and those are all duly recorded. He will send out the comments a week before the meeting. They will be taken up until two days before the meeting and be compiled more formally.

Mr. Aune said they will update the schedule of the MTP process based on the Committee's recommendation.

Mr. Tibbetts said by the second meeting, on August 24, they will have all documents in place. That is the goal. TCC still has to make recommendations for the Pedestrian Plan and the MTP.

### 4. MATTERS FROM TCC MEMBERS

There were no matters from TCC members.

### 5. ADJOURN - Next TCC Meeting: Monday, August 10, 2015
