MINUTES OF THE SANTA FE MPO TRANSPORTATION POLICY BOARD Market Station October 29, 2015

CALL TO ORDER

The Santa Fe MPO Transportation Policy Board was called to order by Chair Carmichael Dominguez, at approximately 4:30 p.m., on Thursday, October 29, 2015, at Market Station 500 Market Street, Suite 200, Santa Fe, New Mexico.

There was a quorum of the membership in attendance for the conducting of official business.

APPROVAL OF AGENDA

MOTION: Councilor Ives moved, seconded by Commissioner Stefanics, to approve the Agenda as presented.

VOTE: The motion was approved on a voice vote, with Commissioner Anaya absent for the vote.

APPROVAL OF MINUTES - AUGUST 27, 2015

MOTION: Commissioner Stefanics moved, seconded by Councilor Ives, to approve the minutes of the meeting of August 27, 2015, as presented.

VOTE: The motion was approved on a voice vote with Commissioner Ives absent for the vote.

A. MATTERS FROM THE PUBLIC

There were no matters from the public.

B. ITEMS FOR DISCUSSION AND POSSIBLE ACTION:

1. APPROVAL OF THE SANTA FE MPO 2016 SCHEDULE OF MEETINGS (MPO STAFF)

A copy of the proposed meeting schedule is incorporated herewith to these minutes as Exhibit "1."

Mark Tibbetts reviewed the proposed schedule which was presented via slide, noting the meeting dates were shifted in November and there will be no meeting in July. Please see Exhibit "1" for specifics of this presentation.

Commissioner Anaya arrived at the meeting

Commissioner Stefanics noted that the County selects and appoints its members to Committees in January, so there may be some changes.

MOTION: Commissioner Stefanics moved, seconded by Councilor Ives, to approve the Santa Fe MPO Schedule of meetings for 2016, as presented.

DISCUSSION: Chair Dominguez said, for the record, the City Committee appointments will be made in March following the Municipal Election, so there is the possibility of a change. He asked about the terms of the Chair and Vice Chair, and if it is done by the calendar year.

Mr. Tibbetts said that is done in January, because the County usually has assignments by then and Tesuque Pueblo has decided its governor by the end of January.

Chair Dominguez said you might want to start thinking about not doing that until March, because the City's committee assignments won't be done until then.

VOTE: The motion was approved unanimously on a voice vote.

2. UPDATE ON TRANSPORTATION IMPROVEMENT PROGRAM (TIP) PROJECTS (MPO STAFF)

A copy of the Santa Fe MPO Transportation Improvement Program (TIP) Project Status Summary, updated October 26, 2015, is incorporated herewith to these minutes as Exhibit "2."

A copy of the proposed Draft Amendment 1 to the FFY2016-2021 Transportation Improvement Program Summary, dated October 29, 2015, is incorporated herewith to these minutes as Exhibit "3."

Keith Wilson reviewed Exhibits "2" and "3." Please see these exhibits for specifics of this presentation. Mr. Wilson noted these are informational items only, and this Board will be taking action at its November 19th meeting.

Commissioner Stefanics asked Mr. Wilson if he has any information on the Highway bill in Congress, and what he thinks will happen. She said that affects everything for which we are planning.

Mr. Wilson said it is his understanding that it will be extended for 3 weeks, noting the current resolution will be expiring in the next 2 days. He said there is a 6-year bill in the House. He said both the House and Senate are considering extension of the continuing resolution for another 3 weeks to allow them to get into conference to discuss the 6-year bill. He doesn't know if 3 weeks is sufficient to do that. He said he gathered from the summary he read, that there didn't seem to be much disagreement between the House and the Senate. He said they did passed a budget this week.

Mr Wilson said the Amendment will be put out for a 15-day public review tomorrow, noting at the November 19th meeting, there will be a public hearing and then approval of the amendment. It will then go forward to the State STIP and to the Federal Highway Transit Administration for overall approval of the State-wide STIP by the end of the year.

Commissioner Anaya asked about the Southwest Connector.

Mr. Wilson said the Southeast Connector and the Northwest Connector, were approved by DOT in the last two weeks, so it is moving into Phase C which is the environmental evaluation of the alignments. And once that is done, they can start the design process, noting the information on page 2 of Exhibit "2."

Mr. Dave Quintana agreed.

Mr. Wilson noted that the interchange is significantly complete, but it will not open until the stub-out at Jaguar Road is connected to the interchange, and the water lines are complete, and that probably will be sometime next summer.

Mr. Wilson said the divergent diamond interchange at I-25 and Cerrillos is 6 months into construction. He said a website, www.santafeddi.com, has been set up to provide weekly progress updates on the project.

Mr. Wilson said the Board can look through the document, and he is happy to answer any questions.

Commissioner Stefanics asked what is the ADA Feasibility Study on NM 14 - what part of the road that is.

Mr. Wilson said that is on St Michaels to St Francis.

Chair Dominguez said he received an email about a non-motorized project by the Zocalo Apartments.

Mr. Wilson said there is a City GO Bond funding project to do a trail connection from [inaudible] to Calle Mejia.

Chair Dominguez asked if there has been any public discussion on that.

Mr. Wilson said it was identified on the Bicycle Master Plan when they reallocated the River Trail underpass funding of \$2 million, and it was one of the projects that was funded. He said there is a pedestrian easement already in place in that location. He noted there is a public input meeting on November 12, 2015, regarding that project.

Commissioner Anaya said he would like to invite Steve Burns to attend the November meeting to provide a presentation and provide information about S-100 410 and the planning around the 3 trails initiative.

Mr. Wilson said staff has been meeting with Mr. Burns and incorporating information on the historic trails in the Plan, and they talked about the next work program which began October 1, 2015 of this year and incorporating planning for some of that work.

Commissioner Anaya said he will be sponsoring a Resolution for that and a Resolution for a National Monument that will connect to the 3 Trails [Old Santa Fe Trail, Spanish Trail and El Camino Real]. He said he will ask Chris Barela to visit with staff and some of the other players. He said some of the other Commissioners have had discussions with interested parties. He said the Congressional Delegation is waiting for us to do something from a County and City perspective. He wants to put it on the record and try and have some discussions as well as to have that as a part of the presentation at the next meeting.

[Dave Quintana's remarks here were inaudible]

Chair Dominguez said he will work with staff to see what we can do.

Commissioner Anaya said Councilor Ives wants to do something on the City side, and he and Councilor Stefanics will cosponsor that on the County side. He wants to have a broader discussion on that here at the MPO, because he is hearing that this is this best place to do that.

Mr. Tibbetts said it is in the Transportation Plan, and they discussed it with Steve Burns, and the Commissioner is correct that this probably is the best venue to start initiating some specific projects.

Commissioner Anaya said we also need to figure out how they share connectivity.

Councilor Ives said he believes across the U.S./Mexican border south, the Camino Real is designated as a World Heritage site or structure in some fashion, and it might be very interesting to pursue a similar designation for El Camino Real in the United States.

Chair Dominguez said he will sure to get these things on the agenda so we can have those discussions.

C. MATTERS FROM THE MPO STAFF

Mr. Tibbetts said at the November meeting there will be an amendment to the two-year work program. The main changes will be that we have finished the plan and will be moving toward implementing those plans and to be more specific in the work program. He said they will be incorporating the special projects/ special studies into the existing planning efforts. He said staff is trying to consolidate and make things more simplified. He said this will be coming to this Board through the TCC for its recommendation for approval, noting they will get copies out well in advance of the November meeting.

Mr. Tibbetts said the Bus Stop/Sidewalk Connectivity study will begin on Monday, noting this is our last significant study. He said KFH will be doing the study, noting KFH did the Public Transit Master Plan, noting KFH will be here for about 5 weeks. They will look at all 500 bus stops in the City area, taking photos and doing a complete workup on ADA accessibility to give a solid data base for improvements and ADA compliance. He said he is involved in reviewing transition plans which will bring all public rights-of-way and all sidewalks in the City to ADA compliance. He said by the end of November KFH should have selected the team to start on that project.

Mr. Tibbetts said the Pedestrian Master Plan is on line at our website, as are all of our Plans, and we can print copies.

Mr. Aune said an application was made to the APB to host its conference in June 2017, noting that would bring 300-400 professionals from across the nation to Santa Fe. He said we should hear back on that within 7 months.

Mr. Aune said the RTD has issued a draft of its Long Range Strategic Plan, which includes a lot of work the County has done with them, noting he currently is reviewing that draft.

Mr. Aune said in the evening of November 19, 2015, at the Iconic Café, we will be hosting a critical discussion about bicycle share programs. He approached the City's Bicycle and Trail Advisory Committee [BTAC] at its last meeting, in response to BTAC's request to give them an update. He said he spent 40-45 minutes at the podium at the Committee meeting talking about bike share. He said there is critical concern by the City about bicycle share anyway. He said the Chainbreaker Collective is represented on BTAC, and the Collective has serious concerns about the need for a credit card or a smart phone, etc., to participate in that program.

Mr. Aune said the purpose of the meeting on November 19th, is to talk about the potential and how we might *[inaudible]*. He said they will discuss how to partner with Affordable Housing complexes and building bike share facilities, and how that might look. He said they are working with the Regional COG on a grant with PNM. They also spoke with staff from the McCune Foundation, which is very interested and there might be some funding opportunities there. He said the goal would be to create some pilot project money, and develop a program here like Albuquerque has done which was not publicly funded. As a result, there was an expansion from 5 bicycles to 76 bicycles in May which was done without direct public funds. He said if the Board is interested, he would be happy to talk to the County about it.

Chair Dominguez asked who is on the panel.

Mr. Aune said there would be members of the Chainbreakers Collective, people from Albuquerque, and he has invited one of the co-founders of the Zagster Bicycle group that actually makes the bicycles. He said he will be attending as well.

D. MATTERS FROM THE SFMPO TRANSPORTATION POLICY BOARD

Commissioner Anaya said he wants to thank the staff at all levels at the DOT for project development, implementation and construction. He said the County has a lot of projects happening not only in the MPO, but just outside of the MPO. He said there were two bridges that were part of the worst bridges in New Mexico in Galisteo. He said it took a long time, but DOT did a great job on those structures and it is a testament to their work and the quality and effort they took to that project, and all the projects.

Commissioner Stefanics departed the meeting

Commissioner Anaya thanked his colleagues on this and past Commissions, and said he is excited to announce a groundbreaking tomorrow for the construction of a 54,000 sq. ft. in-door facility in the Stanley area which will serve the whole region. He said there will be equestrian events, youth agricultural events and anything "we can dream up to use the facility." He said they are working closely with the schools in the County and the region to access and utilize those facilities as well as people from equi-tourism and equestrian facilities. He said he, Commissioner Stefanics and a former Commission worked on an equestrian facility in Edgewood that will lead to a COLPAC trail project in Edgewood that is being utilized heavily, noting it is an outdoor facility. He said they are finding that equi-tourism in New Mexico, and the Santa Fe region in particular, is becoming a bigger and bigger thing. He said we have done a lot of bicycle and pedestrian work on the MPO, as well as some equestrian work, and this project is an example that will incorporate some equestrian components. He would like this Board to engage in that discussion in coming

months to elevate the importance of that endeavor, commenting it is an economic engine for this region. He asked comment from staff on this item relative to equi-tourism and equestrian trails as it ties into our Metropolitan Plan.

Mr. Wilson said in developing the Bicycle Master Plan, they talked about the equestrian community in Santa Fe, given that the bulk of our work is in the urban area and very few people will be riding horses on the trails. He said they did consider the need to incorporate the equestrian users on the I-25/Cerrillos interchange project which will have a trail connection from north to south. He said we tend to not get too heavily involved in recreational side of things – who would use things and how they would be used. He said they do get involved in thinking about the connections to those locations. He said it wouldn't be at the top of the priorities, but it isn't something we ignore.

Commissioner Anaya said there is a very strong, very active horse coalition in Santa Fe, and he would like to bring them to the upcoming meeting, noting the La Cienega area, and all the way to Cerrillos and Cerrillos Hills are within the MPO boundary. He thinks we have plenty of components to complement what they are doing. He said he wants the rest of the Board to understand the dynamics of what is out there and begin to have those discussions at the Board level.

Jessica Griffin said they are getting ready to do the BTE Plan for the State Bicycle, Trails and Equestrian Plan for the State DOT, so they would like to get more equestrians involved in that. She will have their planner contact Commissioner Anaya to get his input.

Commissioner Anaya said he will be glad to help.

Mr. Wilson said that would help staff as well.

Ms. Griffin said they are riding horses on the River Trail.

Chair Dominguez said they are riding in the SWAN Park as well.

Mr. Tibbetts said they are crossing roads and equestrian crossings are of concern.

Commissioner Anaya said the people at the polo grounds are investing a lot of money and they've done some substantial shows there, trying to get more people interested and involved.

Councilor lves said he would be curious to see the statistics on bus routes as the City begins its budget discussions, in terms of usage as well as times of day ridership. He asked if that information would be available for the various bus routes.

Chair Dominguez said he is sure Jon Bulthuis has a lot of that data.

Mr. Aune said at its monthly meetings, the Transit Advisory Boards is given those numbers on a monthly basis for the City and he can provide those. He said the RTD also has current numbers and trends. He noted that bicycling hit an all time high in 2014.

E. MATTERS FROM THE NMDOT AND FHWA

There were no matters from the NMDOT and the FHWA.

F. ADJOURNMENT – Next scheduled meeting November 19, 2015

There was no further business to come before the Board, and the meeting was adjourned at approximately 5:20 p.m.
