MINUTES OF THE SANTA FÉ MPO TECHNICAL COORDINATING COMMITTEE August 26, 2013

CALL TO ORDER

A regular meeting of the Santa Fé MPO Technical Coordinating Committee was called to order on the above date by Chair John Romero at approximately 1:30 p.m. in the Councilors Conference Room, City Hall, 200 Lincoln Avenue, Santa Fé, New Mexico.

APPROVAL OF AGENDA

Mr. Smithson moved to approve the agenda as presented. Mr. Martínez seconded the motion and it passed by unanimous voice vote.

APPROVAL OF MINUTES July 29, 2013

Mr. Aune moved to approve the minutes of July 29, 2013 as presented. Ms. Lucero seconded the motion and it passed by unanimous voice vote.

Mr. McPherson arrived at this time.

1. COMMUNICATIONS FROM THE PUBLIC

There were no communications from the public.

2. ITEMS FOR DISCUSSION AND POSSIBLE ACTION:

a. Review and Recommendation of an Amendment to the FFY2014-2017 Transportation Improvement Program – MPO Staff

Mr. Wilson reminded the Committee of the amendment. There was a STIP amendment for November that actually would be done in October. The amendment concerned the signal head

Ms. Baer moved to approve the recommendation as presented. Mr. Aune seconded the motion and it passed by unanimous voice vote.

b. Transportation Improvement Program (TIP) Project Updates - Lead Agency Staff

Mr. Wilson briefly reviewed the updates [attached as Exhibit 1]. There was nothing substantially changed except the completion of 599/62 and all but the lighting was finished at Washington/475. The NE/SE Connection was awaiting traffic demand modeling. The I-25 & Cerrillos interchange was awaiting analysis of the three design options. Cañoncito was at finalization of administration and correcting markers and should be let soon. Caja del Rio was close to wrap-up sometime in mid-August. Beckner Road was complete and the I-25 repaving project was ongoing and probably completed.

Mr. Wilson reported the Old Santa Fé Trail bike lanes were at 90% design review last month and he thought it was almost finalized.

- Mr. Aune said it would be finalized within three weeks.
- Mr. Wilson said the Guadalupe Bridge and Defouri Bridge structure report s were completed.
- Mr. Martínez agreed. He anticipated having the design by year end. The two bridge rehabilitation projects would be let in October. There was a backlog on projects so these slipped a little.
- Mr. Wilson said Las Soleras was removed. Rabbit Road was completed in July and functioning. Santa Fé Place Mall has not responded within the 60 day limit.
- Mr. Smithson said they were relocating to the open space at Cerrillos and Camino Entrada. They had the federal commitment to not pull the money since they were showing progress. Santa Fé Place would be just a bus stop. The bus purchase hit a backlog so Santa Fé Trails should see them next year.
- Mr. Wilson said for the Santa Fé Southern crossing he had no confirmation of project progress. For the Santa Fé Rail Trail project, the County was pulling out all stops to see if they could get SHPO completion and sign off this week.
 - Ms. Baker said the consultant was preparing to submit that by tomorrow.
- Mr. Wilson said the Acequia Trail project design was underway and they would find out what NMDOT would require. For Safe Routes to Schools, the documents were submitted to DOT and awaiting their response. It was the same for the Santa Fé Trail retaining wall project.

The Committee had no questions or comments.

c. Review and Recommendation on Transportation Alternatives Program Applications – MPO Staff

Mr. Wilson handed out the results of scoring of the applications submitted [attached as Exhibit 2]. He reminded the Committee of the purpose of TAP which was for non-motorized funding through a competitive application process. High scores should get priority. Back on May 20th the MPO staff called for projects to be submitted with a deadline of August 2 and they received two applications from the City by that date. Both of them were sidewalk improvement projects. The first was a section of the River Trail from Alamo to Canyon Road for requested design funds in FY 14 with construction in FY 15.

- Ms. Baer asked if the money was allocated to the MPO and competitive within the MPO area.
- Mr. Wilson agreed. They had been allocated an amount of money for the competition internally within the MPO.

Mr. Wilson noted that on page 2 it showed the breakdown. Fifty percent of the MAP funding was to be allocated state-wide by population so the MPO had \$36,432 to be spent outside the urban area and \$120,021 within the urban area and the other 50% could be spent anywhere so Santa Fé ended up with \$211,282 to allocate. All of it was competitive.

The other City project submitted was for a sidewalk project for two segments on Cerro Gordo Road for sidewalks and stabilization at the first segment and for widening the pedestrian way in the second segment. The scoring was strict and was shown on the scoring handout. The applications were weighted for those that had gone through design. A score of 5 was for full documentation. The City provided minimal documentation so they got 2 points each and came out a little short.

Those two were the only ones submitted before the deadline and, if funded, would not use all TAP funds available and they didn't include any rural funding.

So on August 8 the MPO staff issued a second round for applications with an August 21 deadline and by then got one more from the City. It was for River Trail improvements that were identified in the Bicycle Master Plan and it identified potential shortfalls in funding (from the bond issue). It was split into two phases. Phase One would be widening of the sidewalk at St. Francis to Camino del Campo and a connection between Alto Park to La Madeira and trail connections from Conquistadora and Camino de Chelly. Phase Two would be for the River Trail from Defoun to Don Gaspar. The estimated cost would be \$1.29 million.

He also received one project from the County for the Santa Fé Rail Trail, Segment 4, from Avenida Vista Grande to Avenida Eldorado for trail improvements.

Those received before August 21 were secure and the one received after August 21 was secondary. He was confident there were no others hanging out there.

- Ms. Baer asked how the applicants identified the amount they requested.
- Mr. Wilson said the first projects were based purely on the estimated cost of the projects. For the River Trail they requested \$150,000 on a million dollar project.
 - Mr. Quintana arrived at this time.
- Mr. Wilson noted that page 2 of the handout showed three scenarios for funding. The first scenario was done when there were only two applications. Both would be funded but they could not fund just the design but must also show funding for construction. The response from FHWA was to ask what the STIP guidelines said. So it was likely they could allocate funds for construction for FY 16.
 - Mr. Martinez said the River Trail would go to the top anyway since it was all the same plan.
 - Mr. Wilson agreed and said the balance (rural funds) would to go to the County. FY15 small projects

funds were flexible.

Scenario #2 would remove the design funding from Cerro Gordo and transfer the FY 14 funds to the Santa Fé River Trail project for sidewalk improvements and construction funding in FY 15 for that project along with the flexible funds.

Scenario #3 would allocate \$250,000 for funding the Santa Fé River Trail and using flex funds.

- Mr. Wilson's recommendation was to choose scenario #2, based on timing of the project submissions.
- Ms. Baer asked if the Committee could hear from those proposing.
- Ms. Baker, Mr. Martínez and Mr. Aune said they were okay with that recommendation.

Ms. Baer moved to approve the funding using the allocation of scenario #2. Mr. Martínez seconded the motion and it passed by unanimous voice vote.

d. Discussion of the Roadway Functional Reclassification - MPO Staff

Mr. Wilson said he had promised to bring something on the reclassification to this meeting but was unable to do so. The deadline was March 2014. He was going to review the guidelines, then summarize for amendments and promised to bring it to the September TCC meeting. He invited others to review the draft document.

e. Update on the Highway Safety Improvement Program - MPO Staff

Mr. Wilson had no further updates from NMDOT regarding targets for HSIP funding. They talked about several prospective projects. He had a meeting with the data manager and also focused on crash data. He understood the Santa Fé Police Department would be a pilot for crash records. They were scanning all 2012 crash reports and would work with the MPO on accessing the data. So when something comes up on projects the MPO could access the data to speed up the process.

He said they should meet on the Agua Fria/Cottonwood intersection.

Ms. Baker agreed because anything done there affects the Santa Fé River Trail crossing there.

f. Update on the Development of the Travel Demand Model – MPO Staff

Mr. Wilson had no handout on the Travel Demand Model. We have worked with Bob Schul on the model. It was a computer model using demographics to build a base and calibrate it to mimic existing traffic

patterns so that we would feel confident on what would happen in reality; design a forecast including network improvements and then rerun the model to see what would happen. It would help predict how future development and road projects would improve traffic demand in the future. The consultant helped for several months. It was an intense process and becoming more complex. It was last constructed in 2006 and was simplistic then compared with the present work. He explained that "network" meant road system.

They were concentrating in the college district (NE/SE) and other major connectors, looking at demographic units. They still looked at dwelling units but also employment, income levels, matching low-income workers with low income jobs, etc.

The consultant was finishing the calibration and then would do runs for the NE/SE study. That left model network and further calibration. He hoped, in the next few months, they would finish that and make recommendations by June 2015.

The other major difference from the old model was in forecasting. The old one showed old estimates on development growth and now they had newer data on that. He hoped with all that work they could have more confidence in what would happen in the future. They were sharing with data in the cloud.

- Ms. Baer asked if he envisioned that helping us to know which way to go.
- Mr. Wilson agreed. They would use it for MTP but adding new ones as they were made. The TPB might ask for specific things to be monitored. A downfall last time was on the Richards connection issue. Policy makers were interested in those assessments. This model allowed them to do "what if" modeling.
 - Mr. Martínez asked if they could do it for the Siler Road connections.
 - Mr. Mortillaro asked if there was any way to determine if you needed to expand roadways for transit.
- Mr. Wilson said transit was built into the model. It should be easy to project traffic projections and at what point people would turn to transit. After the road piece they would work on transit, bicycle and pedestrian modes.
 - Ms. Baker reasoned that the model had the capacity, depending on the factors we include.
- Mr. Mortillaro suggested, since other places had that model, that this MPO could borrow from others rather than building our own. Mr. Wilson agreed.
- Mr. Tibbetts said the confidence level goes up although it was not an absolute. It was relatively effective but not a crystal ball. Having a reliable model was important and definitely worth the investment.
- Mr. Ken Vellon asked about its use on densities and peaks. Mr. Wilson talked about density circles briefly and said it definitely dealt with peaks both a.m. peaks and p.m. peaks. It looks at each area individually, modeling trip starts and stops. It was split into hourly chunks. Modeling that continues past the

hour were better.

Chair Romero pointed out that the school district had zones but a lot of kids didn't go to school in that zone.

Mr. Wilson said those were the questions that would be considered.

Chair Romero added that peaks change as school was in or out of session.

- Mr. Wilson said it was done in management chunks and they could refine it to the nth degree. What we think today might not happen in 5 10 years.
- Mr. Tibbetts said it was geared to starting times in school. Starting at a different time could change the whole congestion pattern. "Here was what happens now what do we do about it?"
 - Mr. Aune asked if he would present this at the TPB meeting.
 - Mr. Wilson thought it was on the agenda but it depended on their patience.
 - Mr. Aune asked if the information on college growth was adequate.
- Mr. Wilson said they based it on shorter term projections 6,000 to 12,000 in 25 years. It was the best they could do in this amount of time. He explained that for now they were just doing traffic projections. SFCC showed their projections were under the state average and they would try to bring that up. They were also seeing what that would do to the area.
- Mr. Aune suggested the update of the MTP might look at the model and he suggested taking responsibility for it.
 - Mr. Vellon asked if it could incorporate recession.
- Mr. Wilson said the master peaks were for 2009 and projections to 2012 showed below expectation. We asked the College to provide the data. That was part of the forecasting part. At the end we were pretty much on target with projections for community growth.

g. Update on the Title IV Plan - MPO Staff

Mr. Tibbetts reported this plan came from FHWA and DOT last year. Title 6 had a requirement for limited proficiency and under-served areas; to identify demographic mapping to make sure there was equity in service provided. The Plan would be sent tomorrow as a draft for DOT review and be on the September agenda for providing a 45 day public review and then presentation to TPB for approval. It included a complaint process. The City was the fiscal agent so he was dealing with HR here.

h. Update on the Pedestrian Master Plan - MPO Staff

Mr. Tibbetts reported that he and Mr. Wilson were busy last week on this. They had a meeting with consultant, Claudia Horn and Associates and they were doing GIS work. They had the meeting scheduled and then had a new request from the Mayor's Committee on Disabilities and the consultant was Sally Swanson. She was here on vacation but had complaints from the ADA Committee that the City didn't do an adequate job so he had to find out more with the consultant on developing our plan so that we were not duplicating effort and addressing the situation.

Creative Santa Fé originally was looking specifically at the Railyard and Downtown for way finding and pathways signage. They invited Jeff Speck who wrote a book on walkability. They had a workshop on Wednesday to hear from him. He mainly focused on downtown and addressed issues around the city. We followed up with Sally Swanson and Mr. Martínez came to that one. It was good to find out what to do in defining our scope which involves a sidewalk inventory. The ADA Committee was focusing on a piece of sidewalk. We want both to coordinate for efficiency and productivity for sidewalks.

- Mr. Martínez asked if there was any overlap with the Title 6 plan at all.
- Mr. Wilson said he mentioned that. The Transition plan would be included.
- Mr. Martínez said it sounded like a pedestrian plan issue.
- Mr. Wilson said he supposed so. Lack of maintenance could be a finding in Title 6 and there was a possibility of improvement. It was the MPO area.
- Mr. Tibbetts pointed to a statement from them that the City was totally within the MPO. The City does have the contracts for it. But this was a document to clearly line out what the plan is.

The pedestrian plan was still moving along. They were meeting every two weeks with the consultant right now and mapping with GIS, looking at transit stops for Santa Fé Trails and NCRTD and also at schools. That covers 90% of the City and the surrounding County areas.

The public meeting would be toward the end of September or early October. They were working on locations for the agenda but it would be specific public input. It was on projects as well as policies (construction & maintenance). They would carry them forward as much as they could. It wouldn't sit on the shelf too long as it would be updated periodically.

- Ms. Baer was hoping the staff was looking at quality also and not just connectivity. Mr. Tibbetts agreed.
- Ms. Baer said they were working on the general plan and it was based on policy. It would be critical to include policies in the general plan and have it as a tool for adjuring the pedestrian plan. Then we could tell

developers everyone has to follow the pedestrian plan and that coordination has to happen.

Mr. Tibbetts said the MTP was referenced in both County and City plans. Anything we decide to add would go through this body.

Mr. Macpherson said they were doing the research.

3. MPO OFFICER REPORT

Mr. Tibbetts said the new hire ad went out on Friday for the third staff member. It would be advertised internally first (per union agreement) and that was now underway.

Staff was finishing responses on the MPO review. There were some County issues with their policies and a JPA issue on conflict resolution which might require a new JPA. They just had to address their concerns and make it as functional as possible. There was some accountability to assure the feds that what they were paying for was being done 100%.

On September 18 SFMPO would host the meeting on representatives from FHWA, DOT and all MPO'S for their quarterly meeting.

The MPO offices were moving on October 4 to the Railyard above REI and Flying Star was going on now.

He welcomed Joseph Gutierrez, Associate Director of Santa Fé County Public Works and has been designated as the County representative to TCC.

Mr. Wilson attended the National Highway Institute on bicycle design training in May. He was looking to do a two-day AASHTO training on bicycle facilities sometime in October. The first day would be for bicycle on-road and second day for off-road.

Mr. Aune announced the New Mexico Planning Association conference on October 2-4.

Mr. Wilson said he was working with Ms. Kozub on the training. The TCC meeting probably would be the 3rd week of October.

Mr. Wilson announced he was going to traffic monitoring training tomorrow including data collection and performance monitoring. In a couple of weeks he was going to Boulder for the Pedestrian and Bicycle Professionals Conference with up-to-date stuff.

4. COMMUNICATIONS FROM TCC MEMBERS

Mr. Martínez said the Rail Trail project was just waiting on DOT to put it out to bid.

Ms. Baker clarified that it was bounced back to her and now has to go back to the City.

Mr. Martinez said they needed it executed before they could award the contract.

Ms. Baker agreed to track it down.

Ms. Baer thanked Mr. Martínez and Mr. Aune for submitting the applications for funding.

Mr. Wilson - agreed. He appreciated all efforts on it.

Mr. Martinez thanked Ms. Kozub for helping to get through the questions.

Ms. Baker reported the County was going through lots of reorganization now and her title would change and didn't know what her role would be.

5. ADJOURNMENT - Next TCC Meeting - Monday, September 23, 2013

The meeting was adjourned at 3:10 p.m.
