

MINUTES OF THE SANTA FÉ MPO TRANSPORTATION POLICY BOARD August 29, 2013

CALL TO ORDER

A regular meeting of the Santa Fé MPO Transportation Policy Board was called to order on the above date by Commissioner Miguel Chávez, Chair, at approximately 5:00 p.m. in the City Council Chambers, 200 Lincoln Avenue, Santa Fé, New Mexico.

ROLL CALL

Roll call indicated the presence of a quorum as follows:

APPROVAL OF AGENDA

Commissioner Stefanics moved to approve the agenda as published. Councilor Trujillo seconded the motion and it passed by unanimous voice vote.

APPROVAL OF MINUTES - May 30, 2013

Ms. Kozub's name was misspelled.

Councilor Trujillo moved to approve the minutes of May 30, 3013 as amended. Commissioner Stefanics seconded the motion and it passed by unanimous voice vote.

A. MATTERS FROM THE PUBLIC

There were no matters from the public.

B. PUBLIC HEARINGS

1. Approval of the Amended FFY 2014-2017 Transportation Improvement Program (MPO Staff)

Mr. Wilson identified the TIP amendment.

Chair Chávez asked if this provided for pedestrian crossings at intersections.

Mr. Wilson explained how the heads worked by pushing a button and during the flashing hand sign it counted down to show the pedestrians how many seconds they had to get across before the solid hand came on.

Chair Chávez asked if it would enhance pedestrian safety at the problem intersections. Mr. Wilson agreed.

Councilor Trujillo asked if the City was going to take care of all the sites.

Mr. Wilson agreed, through an agreement with the state system, as well.

Councilor Trujillo moved to approve the amendment. Commissioner Stefanics seconded the motion and it passed by unanimous voice vote.

2. Approval of Project(s) for Transportation Alternatives program (TAP) funding (MPO Staff)

Mr. Wilson reminded the Board that they had discussed this over the previous months regarding new MAP 21. It went into effect October 1, 2012 as part of the reorganization of funding categories. NMDOT gave control to MPOs and RPOs and divided the money. They developed guidelines and scoring criteria for selection of projects and it was approved in May. On May 20th the MPO issued a call for applications. He provided a table and information regarding the applications.

The MPO could fund projects for FY 15 up to the amount allocated and had two applications received. The staff issued a second call for projects and received one additional application for the remaining money. Then they received another application a little late.

Commissioner Stefanics asked if the last one was still eligible since it was late. Mr. Wilson agreed sine they had rural funds remaining and that application was for a rural project.

Mr. Wilson went through the projects as outlined in the handout. He went over the table showing what projects were eligible for each category. There were three city projects and one county project. He reviewed the possible scenarios for funding the projects. The Santa Fé River Trail was the first priority and they recommended funding that project. For the number 2 project staff recommended no funding. They recommended funding for the number 3 project and that the number 4 project receive rural funds. They were all listed in the handout.

Mr. Wilson reported the TCC had reviewed the projects and this was their recommendation.

Commissioner Anaya asked, if the requested amount was \$250,000 for project 3, whether the Board could give the remaining balance to the county project number 4.

Mr. Wilson said that was one of the options. They established the priority to put that project last solely due to the fact that they applied after the deadline.

Commissioner Anaya moved to allocate the balance to the El Dorado project #4. Councilor Trujillo seconded the motion.

Commissioner Stefanics asked if the board was prohibited from over funding something. She asked why they would fund something for more than what was requested.

Mr. Wilson clarified that these requests were based on funding available. TAP funding required a 15% local match.

Commissioner Stefanics explained that she was asking about the procurement rule.

Mr. Wilson said it had nothing to do with the procurement rule. This was a reimbursement process with a 15% match.

Secretary Bender said what she understood was the reason for not giving the additional funding to #4 was because they did not meet the deadline. The reason they gave them money at all was that it was the only rural project submitted.

Mr. Wilson agreed. If the first three had allocated all the funds, #4 would not have gotten anything.

Chair Chávez asked for public comments. He stated that he was remiss in not asking for public comments on the last issue since this was a public hearing.

There were no public comments and the public hearing was closed.

The motion passed by majority (4-1) voice vote with Secretary Bender voting no.

Commissioner Anaya commented that he respected the Deputy Secretary's answers but he had more questions about why there was only one application from the County. He didn't think this was an overstep since the MPO opened up the process to them anyway.

Councilor Trujillo noted the MPO was both city and county so it was about working together. If money was needed somewhere else let's put it somewhere else.

Chair Chávez said he rides that trail and the improvements would make it much nicer.

Mr. Wilson said this approval would now be submitted to DOT for their concurrence. This would come back to you the TPB to be put into the transportation plan.

C. ITEMS FOR DISCUSSION AND POSSIBLE ACTION:

1. Transportation Improvement Program (TIP) Project Updates (MPO and Lead Agency Staff)

Mr. Wilson said no action was necessary here. Essentially they were tracking the status of all TIP projects. All the information was in the packet in a spread sheet. He offered to go through individually if the Board wished.

The Board indicated only a summary was needed.

Mr. Wilson went through the spread sheet in the packet.

Commissioner Anaya asked Mr. Gallegos regarding the NM 599/Jaguar Drive interchange if the project design cost was the interchange accommodating every possibility.

Mr. Gallegos agreed it was being built to NMDOT standards. The DOT was overseeing the project construction and doing the inspection - looking at everything.

Mr. Wilson reported that the NM599/CR62 interchange was finished. Chair Chávez and Commissioner Anaya congratulated everyone.

Mr. Gallegos said the NM 475/Washington Street project was being finished up now.

Commissioner Stefanics, on the NE/SE Connector study if Mr. Wilson could ask the contractors to have their next meeting at the Santa Fé Community College. Mr. Wilson agreed.

Mr. Wilson said the City was the lead agency on the Cerrillos Road Reconstruction.

Councilor Trujillo was very thankful that this was finally coming about. He was an inspector 20 years

ago on the first part of this work.

Secretary Bender asked who was awarded the contract.

Mr. Wilson didn't know.

Mr. Gallegos didn't recall either.

Mr. Wilson said the I-25 at Cañoncito Interchange was about to go out to bid.

Mr. Gallegos said they were turning that project in to the estimating unit. It should go out to bid in October and would be under construction next spring.

Commissioner Stefanics asked if it would not be under construction during the winter.

Mr. Gallegos said it wouldn't. It would go out to bid over the winter.

Mr. Gallegos said the NM 14 /Cerrillos Rd ADA upgrades were substantially completed.

Mr. Wilson said Beckner Road, Phase 1was either complete or close to being complete

Mr. Wilson said the I-25 pavement preservation was almost complete.

Mr. Wilson reported that the design plans for the Old Santa Fé Trail Bicycle Lanes were being reviewed.

On the design of the Guadalupe Street Bridge, the City was reviewing options

For the Santa Fé County Pavement Preservation Program they had to do an administrative modification with that done it should move along soon.

Mr. Gallegos said they were putting the bridge projects - US 84/285 and 1-25 and US 285 out to bid.

Mr. Wilson reported that the Las Soleras Rail Runner Station project was no longer moving forward at this time. The Rabbit Road Project was almost complete

He said the Santa Fé Place Transit Station negotiations had broken down and the City was now looking for other sites.

Councilor Trujillo said the City was working on the project list for the legislators and thought that was included. He asked if that would delay anything.

Mr. Wilson thought that was a question for Jon Bulthuis

Chair Chávez asked if this project was approved for the lists.

Councilor Trujillo said they were still working on the list to identify the top 5 now.

Mr. Wilson reported the Santa Fé Trails purchase of new buses was in process

Mr. Wilson said the Santa Fé Southern Railroad Line safety project did not have any time line for now.

For the Santa Fé Rail Trail project, everything was in order as of this afternoon and it would move forward.

The Acequia Trail/Railyard crossing was in the design phase.

Chair Chávez understood the \$400,000 was for design and asked how much the cost of construction would be.

Mr. Wilson said it likely would be \$3.5 to \$4 million.

Mr. Wilson said the City's Santa Fé Safe Routes to School identified a lot of projects around schools. Paperwork and designs were done and awaiting approval.

Councilor Trujillo asked if that middle one would be able to be funded.

Mr. Wilson said they made a judgment call to go for it if they could get all certifications done in time. The TCC felt there was not enough time for it for 2014.

Mr. Wilson said the Santa Fé Rail Trail Retaining Wall paperwork and designs had been submitted and awaiting approval.

2. Discussion of the proposed process for Roadway Functional Reclassification (MPO Staff)

Mr. Wilson referred to the final page in the Board packet which showed the functional classifications map. The MPO makes recommendations to the State. He had hoped to have started this process already. The timeline had slipped a bit. He would bring it to the February meeting for approval. There would be some changes. There were some things to look at and review. He would work with the TCC on it. They should be part way through this in November and he would provide an update.

Commissioner Anaya recalled he made several comments at the last meeting. He asked if staff did any background work on that.

Mr. Tibbetts said in terms of that change he hadn't specifically looked at it but it would be part of his review. He was working now on responses to the FHWA. In terms of incorporating and not splitting Cerrillos, that was an issue perhaps but that could come out when they looked at changing the boundary. When presented to Governor for approval in 2009 it was based on boundary lines. They could change but have to be approved by DFA and the Governor.

Commissioner Anaya said Santa Fé County had invested a lot on open space and trails. They had the Cerrillos State Park and open space along County Road 42. The hope was that they could have a linkage trail system to link those communities. Those were the reasons it made sense to have that discussion.

Mr. Tibbetts said as far as the functions, one was programing the federal transportation funds. We worked closely with the Northern Pueblos RPO. They were having annual meetings now together on connection of trail systems. The boundary was not necessarily the driving source. We get very little rural money but the RPOs get more because they were rural areas. He agreed to look into it. Those were good points. We were trying to get projects up and running.

Commissioner Anaya said he would like that.

Chair Chávez felt if they were not able to change the boundaries, they needed to look at the other scenario of coordinating the trails. If one did not happen they could be sensitive to the fall back position.

Commissioner Anaya asked Secretary Bender if the policy had changed for RPOs and MPOs.

Secretary Bender said that did not change. RPOs were more advisory. MPOs had more say in where money went. Albuquerque, due to its size, had more say. What DOT did for the RPO's was this TAP program to give the RPO's some say in where the money goes within their region.

Mr. Wilson clarified that the RPO's had the same control of the TAP funds as this MPO. If you were looking at funding for trails on Cerrillos you could apply for TAP funds.

Secretary Bender said DOT wasn't sure how the RPO's and Northern Pueblos were coordinated in applying for consideration. But it was the same process that they were going through to access the funds as the MPOs.

Commissioner Anaya said if you look at the southern half of the MPO (County Road 42) a large portion of the southern part of that road was open space that they were working on. He wanted to know, if one side of the road was in the MPO and other side was in the RPO, whether they would apply separately.

Secretary Bender said it was something that could be looked at. It could be looked at as two ways to ask for funding for the same area. Ask for one side for MPO funding and the other for rural funding RPO. You could say it was a connectivity issue and that could benefit the County.

Commissioner Anaya thanked her. He explained that he and Commissioner Stefanics shared this area. He thought they could have discussions on that issue and see if they could come back with more applications.

Chair Chávez said they would have to look at the numbers to see if that would make the project viable.

Mr. Wilson thought they would work out the cross boundaries issue with DOT.

D. MATTERS FROM THE MPO STAFF

1. Update on the Highway Safety Improvement Program (HSIP) (MPO Staff)

Mr. Wilson said the staff started adding some of these items as standing items to keep the Board abreast. They had \$20 to 25 million to allocate. And they had an annual request for projects. They would prioritize safety projects and Dot was still working through that process. He would contact them regarding MPO process or statewide submittals.

Secretary Bender said DOT staff was in the process of setting up the criteria and they were looking at the criteria set up of the TAP program to emulate for this program. She agreed to keep the MPO posted. It was a wonderful opportunity to give more power to rural areas and local areas.

Chair Chávez agreed. It took some of the competitive nature out and based it more on need.

Secretary Bender said it really levels the playing field.

2. Update on the Development of the Travel Demand Model (MPO Staff)

Mr. Wilson explained the travel demand model was a computer model to try to replicate travel patterns. It would allow the MPO to look at alternatives in districts. They were focused on the community college area now and had a consultant on board. He was excited to see how it would function. He would be happy to give further details at a future meeting.

Commissioner Stefanics asked if this consultant was local or out of town.

Mr. Wilson said he was in Seattle.

Commissioner Stefanics asked if one of the staff could meet with her on Richards Avenue. She would like to get a couple of projects modeled right away.

Mr. Wilson said he could meet with her.

3. Update on the Title VI Plan (MPO Staff)

Mr. Tibbetts said they were in the process of advertising for an additional transportation planner to help Mr. Wilson. This plan was a component of the public participation plan. It was another requirement for MPOs and it required equal employment opportunity compliance. A primary task was on how good our outreach was in bringing in public participation.

Mr. Tibbetts said that was seen when the MPO does its 5-year plans and was a component of that. Programming and planning were primary functions. He had completed a draft plan and would run it by folks to make sure they had everything they needed. It would provide an opportunity to look at ideas to bring folks into the planning and participation process. Title 6 was a requirement on how the MPO was going to draw more people in from economically undeserved areas etc.

Chair Chávez said that was the Board's interest - getting more public participation.

Mr. Tibbetts agreed. The MPO would be following this plan until it was updated again. He was trying to get the public to think proactively.

4. Update on the Pedestrian Master Plan (MPO Staff)

Mr. Tibbetts felt this Master Plan would be something that would draw out the public significantly. Staff met with several groups in the last few days. Creative Santa Fé was interested in their approach. Access to transit stops and schools was part of the pedestrian master plan. They would kick off the public meetings in October. It would be interesting to see the energy out there. He would report to the Board in the interim and provide notice of public meetings.

E. MATTERS FROM THE SFMPO TRANSPORTATION POLICY BOARD

Commissioner Stefanics asked a date had been set for the next public meeting on NE Connector.

Mr. Wilson said not yet.

Commissioner Anaya was at a meeting on Tuesday and had a presentation from the National Park Service about working with the County on "flat funding." He reported on their priorities of work along El Camino Real in La Cienega area and heading north to the old route. They were going to put on a presentation for the next COLTPAC meeting. It seemed likely they would apply for funding. He would like to put this on the TPB agenda for November and would like staff to work with the National Park Service to find out more about it.

Mr. Wilson said he was aware of the funding source. The call for projects would begin in October. There was a total of \$14 million. One idea was to potentially provide transportation up the ski area. He forwarded that to the transit agency. Whatever he could do as staff to get some understanding of it he would do.

Commissioner Anaya said Mr. Burns would be here to provide more information to the staff. Essentially it was trails that they were proposing.

Mr. Wilson said that definitely was something we should be involved in. He asked which county staff was involved on this.

Commissioner Anaya said they just talked about it on Tuesday. Steve Burns was the primary person

from the National Park Service.

Mr. Aune said he was tasked with being the county person for this.

Chair Chávez commented there were portions of El Camino Real that were undisturbed. The NPS was commemorating those areas traveled and the parts undisturbed that went back thousands of years. Re-tracing that would include a symposium in 2015 in Santa Fé. A historical and cultural thing that Santa Fé was fortunate to have. All of it was building to the 2015 symposium. The County had been marking the El Camino Real.

Commissioner Stefanics thanked staff and members of the audience for continuing to show up and be interested in what the TPB was doing.

F. COMMUNICATIONS FROM THE NMDOT AND FHWA

Secretary Bender thanked staff for getting a quorum together quickly

G. ADJOURNMENT - Next meeting, Thursday, November 19, 2013

Commissioner Anaya moved to adjourn the meeting. Commissioner Stefanics seconded the motion and it passed by unanimous voice vote.

The meeting was adjourned at 6:45pm.

CN:S100270 - Pedestrian Signal Head Upgrade

• New Project to upgrade 415 pedestrian signal heads at 58 intersections within the City of Santa Fe to the Countdown Type. This project was awarded Highway Safety Improvement Program funds as a recognized safety strategy to reduce pedestrian related crashed at intersections.

Federal Funds = \$277,920; State Match = \$22,080; Project Total = \$300,000
