The Purchasing Division is requesting approval to use the aforementioned State Price Agreement for the procurement of Athletic & Recreational Equipment, in the total amount of \$123,509.03. The Fitness Superstore is one of the authorized vendors on this State Price Agreement.

The management staff at the Ft. Marcy Complex has reviewed the itemized products list provided by The Fitness Superstore and are recommending this procurement.

By City policy, the City can use State or Federal Price Agreements without having to bid the items on its own. By City policy, procurement from State Price Agreements over \$50,000, require City Council approval (City Purchasing Manual Section 11.1).

Funding will be available in account number 12119.570500 (Fort Marcy -- Capital Outlay) in the amount of \$30,976.72, 12119.571900 (Fort Marcy -- Inventory Exempt -- Replacement Equipment) in the amount of \$89,816.31 and 12119.510310 (Fort Marcy -- Service Contracts) in the amount of \$2,716.00.
