**SUMMARY:** Purchase of 3 Hybrid Vehicles for Transit Division

The City of Santa Fe Transit Division has requested the procurement of three replacement vehicles for the administrative staff, from the aforementioned State Price Agreement, in the total amount of \$77,949.00. Bob Turner Ford/DBA. Power Ford is one of the authorized vendors on this agreement.

Item # 006: 2015 Ford Fusion Hybrid, Quantity 3 units at \$22,988.00 each. Total: \$68,964.00  
Item # 006 B: Warranty, five year: Quantity 3 units at \$ 1,795.00 each. Total: \$ 5,385.00  
MPG City: 47. Total: \$76,144.00

Funding for this procurement was approved in this year's Budget (13/14) and is available in the following Transit Division Business Unit 52421. 570950 ( Paratransit/Capital Outlay)

As required the Transit Division will be replacing three older vehicles to be identified at a later date. They will make the determination when the new ones arrive which are projected to be delivered in early September.

By City policy, the City can use State or Federal Price Agreements without having to bid the items on its own. By City Policy, procurement from State Price Agreements over \$50,000, require City Council approval (City Purchasing Manual Section 11.1).


