REQUEST APPROVAL OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF SANTA FE AND THE SANTA FE RAILYARD PARK STEWARDS FOR SERVICES PROVIDED AT THE SANTA FE RAILYARD PARK.

BACKGROUND:

Established in 2008, the Santa Fe Railyard Park Stewards is a non-profit organization working in conjunction with various departments within the City of Santa Fe, whose mission is to provide community stewardship and advocacy for the care and programming of the Railyard Park and Plaza.

In 2010 and 2011 the Railyard Park Stewards provided approximately 3600 hours equivalent to \$118,000 that the city did not provide including; specialized horticultural care and training (260 hours at \$25/hour totaling \$6,500); coordination for outreach, volunteers and fundraising (1484 hours at \$35/hour totaling \$51,940); programming, events and marketing (\$9,500); Railyard park care (754 hours at \$20/hour totaling \$15,080); direction and specialized skills (710 hours at \$35/hour totaling \$24,850); and community garden coordination (450 hours at \$35/hour totaling \$9,000) as well as donated materials (\$1,500). The above includes 1300 hands-on hours of care in the Railyard Park and community garden, with over 150 people participating totaling 90 community work days.

On April 25, 2012 the City Council approved an amended resolution supporting the Railyard Park Stewards efforts at the Railyard Park by directing staff to enter into a contract with the Railyard Park Stewards to provide services for the Railyard Park. The Railyard Park Stewards amended resolution includes a \$100,000 per year reimbursement from the city for next three fiscal years (12/13, 13/14 and 14/15) towards the ongoing and expanding efforts of the Railyard Park Stewards (See Attached Resolution 2012-46).

The Railyard Park Stewards accomplishments for the above referenced fiscal years are provided in a detailed report prepared by the Park Stewards. City of Santa Fe Railyard staff monitors the progress outlined in their Professional Services Agreements. (See Attached Report)

SUMMARY:

The Santa Fe Railyard Park Steward's Board and Linda Shafer, Executive Director, formally request funding for the second half of fiscal year 14/15. Railyard staff and the Park Stewards are requesting \$50,000.

The Santa Fe Railyard Stewards will provide the following services for the next six months. See Attached information regarding a detailed description of the services listed below:

- (a) **Yardmasters - Park Volunteer Program (\$21,500);**
- (b) **Youth Programs - Park Volunteer Programs (\$17,500);**
- (c) **Garden in the Park Workshop Series (\$7,000);**
- (d) **Community Food Programs (\$4,000);**
- (e) **Manage and coordinate the work of all volunteers providing services and monitor their progress to meet deadlines; and**
- (f) **Prepare a yearly program budget based on previous year's costs.**



Dear Mayor Gonzales, City Council Members and Robert Siqueiros:

The Railyard Stewards deeply appreciates the City of Santa Fe's support in our partnership to maintain the Railyard Park + Plaza - the City's largest cultivated Park. Through our Professional Services Agreement (PSA), the Stewards continue to provide a high level of horticultural care and maintenance in the Park; offer outstanding public education programs to our community; and recruit and manage a dedicated volunteer workforce.

In 2014, the City of Santa Fe received a value of \$317,255 through the Railyard Stewards work. Volunteers contributed close to 6000 hours of service with board members, workshop presenters, the Railyard Art Committee, and horticultural consultants contributing their time to the Stewards and the Park. This value offsets Parks Division costs for maintaining the Railyard Park, and fills a service gap by contributing to the Park's horticultural care in addition to offering public and educational programming for the community.

Our volunteer corps, both adult and youth in-service participants, acts as the workforce to keep the Park's gardens and landscapes beautifully cared for and maintained. In 2014, these volunteers logged 3810 hours of service which represents a 24% increase over 2013.


For the second half of the City's 2014-2015 fiscal year, the Railyard Stewards formally request a PSA in the amount of \$50,000 for services to be performed from January 1, 2015 - June 30, 2015. The Scope of Services to accomplish the goals of our request includes:

- **Yardmasters Adult Volunteer Program - \$21,500 per fiscal year. Goal:** Add more volunteers through a comprehensive recruitment and marketing initiative; maintain the part-time horticulturalist position to advise volunteers and youth groups in the Park.
- **Youth In-Service Volunteer Program - \$17,500 per fiscal year. Goal:** Recruit more youth groups to work in the Park including local churches, national conservation groups including National Community Conservation Corps, Rocky Mountain Youth Corps, Western Hardrock Watershed Team, and VISTA volunteers.
- **Horticultural Workshop Series - \$7,000 per fiscal year. Goal:** Extend workshop offerings to a year-round schedule by adding workshops, to increase visitation and participation in Railyard Park programming.
- **Community Food Program - \$4,000 per fiscal year. Goal:** Retain the volunteer farmer who provides agricultural guidance and advises in the gardens, and offer educational opportunities through customized projects for high school students from the Master's Program at Santa Fe Community College.





RALLYARD STEWARDS REPORT TO THE CITY OF SANTA FE November 2014



The Rallyard Stewards is a grassroots, nonprofit organization, working in partnership with the City of Santa Fe, whose mission is to provide community stewardship and advocacy for the care and programming of the Rallyard Park + Plaza. With a vision to build and maintain a vibrant, beautiful, popular, and safe community gathering place representing the history, values and aspirations of the people of Santa Fe, the Stewards accomplish this mission through a volunteer workforce.

Request: For the 2015/2016 fiscal year, the Rallyard Stewards requests a renewal of their Professional Services Agreement for \$100,000, as this amount is advised by City Councilors Bushee and Lindell, and Mayor Gonzales, citing budgetary constraints. Based on the Rallyard Stewards value added contribution of \$317,255 (see below), we originally planned to request an investment of \$150,000 from the City, since we match more than half of this funding through the services and programming we provide.

With a staff of two people, we are at full capacity to manage the programming and services we provide to the City and our community. With moderately increased funding from the City, that matches the volunteer in-kind services and value we contribute, we hoped to add more educational programming. Our plan was to host two elementary schools per semester in our Outdoor Classroom, with the goal of becoming a reliable educational resource for Santa Fe Public Schools. The program brings elementary school students to the Park, where children participate in lessons that supplement classroom instruction to increase science literacy and meet core curriculum standards and benchmarks.

- In 2014, the City of Santa Fe will receive a value of \$317,255 through the Rallyard Stewards work that includes the specialized horticultural care of the Park's landscape, fundraising and public programming. All volunteers - adult and youth groups, board members, workshop presenters, the Rallyard Art Committee, and horticultural consultants - contributed close to 6000 hours of service this year.
- Of the City's 60 scenic Parks, the Rallyard Park has the only dedicated volunteer corps for Park maintenance, with both adult and youth in-service participants acting as the labor force to carry out the specialized horticultural care and maintenance of the gardens and landscapes in the Park. In 2014, volunteers logged 3810 hours of service which represents a 24% increase over 2013.

- The horticultural scale of the Rallyard Park - 13 acres - is the largest cultivated park in the City, with 12 gardens and landscaped areas that include a rose garden, xeric gardens with native plants, an apple and apricot orchard, six Gabion Gardens, the Heritage Waffle and Community Garden, meadows, scented gardens, and two acequias. The \$317,255 of volunteer labor that the Stewards donate offsets Parks Division costs incurred if the department absorbed this responsibility. This value fills a service gap and Provides year-round Park care, in addition to public programming for our community and attracting visitors.

Rallyard Park Care – Hands-On Volunteers – The Stewards recruit and train a volunteer workforce that provides specialized horticultural care, landscape maintenance, and invasive species removal services year round in the Park. The Yardmasters adult volunteers work with a horticultural specialist twice a week, to meet the plant and maintenance needs of the gardens and Park landscapes. Caring for the Rallyard Park is an ongoing, 12-month/year effort.

Voluntourism and Youth In-Service Volunteer Programs – Youth groups, both local and nationally based, spent time in the Park this spring and summer and participated in conservation projects including: acequia maintenance, weed barrier removal and garden reclamation, trash removal, tree planting, weeding the grounds, removing invasive species including Siberian elm seedlings and bindweed, composting/mulching the Gabion Gardens, and maintaining the Heritage Waffle Garden.

Outdoor Classroom Program – The Rallyard Stewards works with the Santa Fe Public Schools and offered environmental and science literacy education activities for students in grades 1-5 from Ramirez Thomas, Nava, and McCurdy Elementary Schools. Instruction supplements the science curriculum taught in the classroom, and meets the Core Curriculum and New Mexico Next Generation Science Standards for each grade level, and is taught in the Rallyard Park's Outdoor Classroom.

Gardening Workshop Series – Features speakers and horticultural experts leading workshops in the Park on Saturday mornings, with topics ranging from rose care and pruning, proper tree planting, water conservation, planting to attract pollinators, soil science, and integrated pest management.

Community Food Garden and Heritage Waffle Garden – The Rallyard Stewards offers garden plot rental to local residents in the Community Food Garden, with weekly agricultural instruction from a local farmer. The Heritage Waffle Garden illustrates food production using an ancient Zuni technique to grow high value crops with attention to water conservation by using flood irrigation with water from both the Acequia Madre and Acequia Nina that run through the Park property.

Art in the Rallyard Park – The Rallyard Art Committee (RAC) performs outreach and juries applications from local artists and artist groups to place temporary, outdoor public art installations in the Rallyard Park.

Railyard Stewards Volunteer and Public Programming (cont'd)

Sustainability – Through a coordinated effort in Park maintenance and by working with the City's Parks Division, the Railyard Stewards supports and enhances the Railyard Park Master Plan for long-term sustainability of the trees and plantings in the Park.

Through these competencies, the Railyard Stewards fulfill our responsibility to ensure that the Railyard Park + Plaza are maintained in perpetuity "as a park, open space, community gathering place, Rail Line corridor, trail corridor and plaza area," as designated in the Railyard Master Plan.

Urban Land Institute - Urban Open Space Award Finalist – One of five finalists for the Urban Open Space Award, an annual competition that recognizes outstanding examples of successful large- and small-scale public spaces that have socially enriched and revitalized the economy of their surrounding communities. We hosted our ULI juror, Terrall Budge, for Railyard Park and Farmers Market tours, with participation by Mayor Gonzales, Councilors Bushee, Ives, and Lindell, SFRCC, Santa Fe Farmers Market Institute, and the Railyard Stewards board of directors.

Hands-On Volunteer Contributions - Provided 3810 hours of adult and youth in-service volunteer park care, which is a 24% increase from 2013 (3081 hours), for a dollar equivalent value of \$218,320.

Yardmasters Adult Volunteers donated over 1100 hours by working in the Park twice per week throughout the year. Volunteers are led and trained by a part-time horticultural specialist to implement the Railyard Park + Place Horticultural Guide.

Voluntourism and Volunteer In-Service Youth Groups - Youth groups, ages 15- 24, working on in-service volunteer projects in the Park included MFUGE Youth Group, Living Water Lutheran Church, Overland Youth Groups, National Community Conservation Corps, and Masters' Program high school students. They donated 1945 hours of service work that included 510 participants in the Park. Overland Youth Groups and MFUGE Youth Group are in-service summer camp programs based in Williamstown, MA and Nashville, TN respectively.

National Civilian Community Corps - Based in Denver, CO with volunteers from across the US, with assistance from the NCCC volunteers, the Stewards completed the reclamation project in the Gablon Gardens to remove weed barrier, dead shrubs and plants, composting, mulching the garden.

Community Garden – Coordinated weekly work days from April thru October with a volunteer farmer (contributed more than 50 hours of volunteer time) to provide agricultural instruction for individuals renting garden plots.

Railyard Park Horticultural Workshops - Organized and hosted 11 community workshops in the Park from February through June that covered topics including: fruit tree pruning, rose care, home water audit, proper tree planting, creating pollinator gardens and integrated pest management methods.

Earth Day Celebration April 26, 2014 in the Railyard Park on - hosted in partnership with more than 30 local conservation and environmentally related organizations to include the Santa Fe Botanical Garden, Earth Care, Santa Fe Watershed Association, Gaia Gardens, Forest Guild, Ampersand Learning Center, Permaculture Institute, Audubon Center, Sustainable Santa Fe, Farm to Table, March for Climate Action, Santa Fe Raptor Center and more.

Railyard Park Clean-Up Day - Hosted annual Clean-Up Day with Keep Santa Fe Beautiful, in conjunction with Earth Day - more than 100 community members joined us to remove trash from the Railyard Park.

Laps4Life Fitness Program - In partnership with Wings of America and Indian Health Services, hosted an initiative funded by the Santa Fe Community Foundation Native American Fund to encourage participants to develop healthy lifestyles by exercising regularly in the Railyard Park using the Prescription Trails and keeping a wellness journal. The program lasted 8 weeks this summer, with attendance totaling 125 Native American participants. We also offered free Tai Chi, capoeira, Zumba, or yoga instruction each week.

Outdoor Classroom Program - With the input and guidance of the science coordinator at Ramirez Thomas Elementary School, we developed an environmental science literacy curriculum for elementary school students who visited the Park each Tuesday. The programming meets Core Curriculum and New Mexico Science Standards and integrates with classroom science instruction. We hosted 490 students for 10 weeks in grades 1-5.

The goal of the **Outdoor Classroom Program** is to establish the Railyard Stewards as a reliable resource for the Santa Fe Public Schools, providing informal science education to increase literacy and support school curriculum based on standards and benchmarks set by SFPS and Next Gen Science Standards.

Farmers Market and SITE Coordinated School Field Trips - Continued our partnership with the Santa Fe Farmers Market Institute and SITE Santa Fe to coordinate visits and lead educational science activities in the Park for 160 students from Nava School and McCurdy Schools, for their spring field trips.

The Masters' Program at Santa Fe Community College visited the Park each Friday from March through June, and again from September through November, where high school juniors and seniors work on acequia clean-up and Park conservation projects. More than 200 students visited the Park to volunteer.

Youth Works! and Youth Shelters Civic Justice Corps – Hosted 20 youth volunteers in the Railyard Park and hope to increase participation through implementing a green jobs training initiative.


Community Room Rentals - Managed 20 rentals for meetings, birthday parties, and educational activities.

Tree Donations - Plants of the Southwest and Tracy Neal donated an Akane apple tree and a McDaniel oak tree to replace dead trees in the Park - planted by the MFUGE Youth Group.

The Railyard Art Committee juried five public art projects displayed in the Railyard Park, including:

- **CURRENTS 2014** presented works in interactive and fine art video installations using the buildings in the Railyard Park + Plaza, multimedia performances, projection mapping, single channel video, animation, digital dome programs, and experimental documentary movie features. With 40 national/international artists, the Park hosted more than 6,000 visitors for this week long event, with performers and panelists from 19 countries and 26 US states.
- **Home Is.....** A bi-lingual, chalk art installation with a 25'x 5' chalk board and colored chalk supplies that invited visitors to write, draw and express what Home means for them.
- **Convergence Plano Project** with Story of Place Institute – Students from Tierra Encantada Charter School sourced and, as a community project, painted and installed four pianos throughout the Park. During the summer, visitors to the Park would stop and spontaneously play the pianos to add music to the environment.
- **Renga Poetry Sign Installation** - The Renga Project is a new take on an ancient, collaborative form of Japanese poetry. 52 weekly stanzas were written by New Mexico poets accompanied by drawings by New Mexico artists and displayed on tiered panels attached to a large sign in the Santa Fe Railyard all year, with new stanzas added weekly.
- **Swing Set** – Live performances of Golden Age Jazz at the Railyard Park Plaza on Friday evenings in July.

The Rallyard Stewards work year-round through its volunteer corps, youth in-service groups, Rallyard Art Committee and board members to keep costs low, while providing quality services to the City of Santa Fe, our community, and visitors to the Rallyard Park.

- In 2014, the Railyard Stewards raised funds and received grants which assisted us in caring for and maintaining the horticultural gardens and landscapes in the Railyard Park, in addition to offering public and education programming to our community and Santa Fe Public Schools students.
- For 2015, we are writing a formal development and fundraising plan to more effectively reach and cultivate donors throughout the year, and make them aware of our programs and work, in addition to revamping our newsletter for more regular distribution to our 1600 subscribers.
- In addition to the City of Santa Fe, contributors included the Stranahan Foundation, LANL Foundation, and the Kindle Project Foundation for educational programming. Whole Foods contributed gift cards for volunteer refreshments, and the Santa Fe Community Foundation supported the Laps4Life Native American Fitness program. Plants of the Southwest and Tracy Neal contributed two trees to replace prominent dead trees in the Park, and several of our youth in-service groups planted these trees.
- The Railyard Stewards participated in *Give Grande New Mexico*, the state's inaugural fundraising program as part of the National Day of Giving on May 6. We will also kick off our end-of-year annual campaign in October, and conduct another campaign to coincide with the national philanthropy program *Giving Tuesday*, on December 2.



WASHINGTON (April 30, 2014) – Five finalists have been announced for this year's Urban Land Institute (ULI) Urban Open Space Award, an annual competition that recognizes outstanding examples of successful large- and small-scale public spaces that have socially enriched and revitalized the economy of their surrounding communities.

This year's finalists are the Columbus Commons and Scioto Mile in Columbus, Ohio; Guthrie Green in Tulsa, Okla.; Klyde Warren Park in Dallas, Texas; Rallyard Park + Plaza in Santa Fe, N.M.; and Washington Park in Cincinnati, Ohio.

An international jury – representing several facets of development expertise including finance, architecture, land planning and development, public affairs, design, and professional services – will elect one winner later in the year.


The winning project is scheduled to be announced at the ULI Fall Meeting, set for October 21-23, 2014 in New York City. A \$10,000 cash prize will be awarded to the individual or organization most responsible for the creation and upkeep of the winning open space project.

The five finalists were selected from an impressive collection of entries, representing urban areas throughout North America. While landscape architecture and urban design were factors in the judging, the jury selected finalists based on a broader set of criteria, including overall project design and how each impacted or revived their surrounding areas.

"This year's submissions reflect innovative ways that North American cities are financing and developing public destinations that create recreational experiences for residents, spur economic activity on adjacent sites, and often preserve historical and cultural heritage as well," said jury chair M. Leanne Lachman, president of real estate consulting firm Lachman Associates in New York, N.Y. "Perhaps more importantly, the design and popularity of these urban open space projects signal the industry's shift to building successful healthy places and helping encourage physical behavior through design."

The descriptions of the finalists, with the project's owner and designer in parentheses:

- **Columbus Commons and Scioto Mile, Columbus, Ohio (Project Owner: City of Columbus and Capitol South Community Urban Redevelopment Corporation; Project Designer: MKSK (formerly MSI), EDGE and Moody Nolan)** – In 2002, the City of Columbus tapped both the Columbus Downtown Development Corporation (CDDC) and Capitol South to help attract and retain both residents and business to the downtown area. After careful consideration, plans were made to develop two new parks – Columbus Commons, in place of a desolate mall, and Scioto Mile, which involved narrowing a thoroughfare along the Scioto River and renovating an existing park. At seven acres, Columbus Commons features formal gardens, a carousel, native trees, two cafés with ample seating, and a state-of-the-art performing arts pavilion. The 11-acre Scioto Mile features a multi-use trail, swings, benches, fountains, and seating pavilions along a promenade that leads to the showpiece of the park – a 16,000-square-foot interactive water feature adjacent to a café and stage.
- **Guthrie Green, Tulsa, Okla. (Project Owner: George Kaiser Family Foundation; Project Designer: SWA Group)** - Guthrie Green, a project built and managed by the George Kaiser Family Foundation (GKFF), transforms a 2.6-acre truck loading facility into a lively and highly programmed urban park. The space offers an outdoor amphitheater, performance stage, interactive fountains, and an 11,000-square-foot café pavilion. Sustainable components including walking paths over bioswales, an underground geo-exchange system that powers nearby nonprofits, and a series of water features are intended as catalysts for discovery. The park has become the area's leading destination since its 2012 opening, drawing 3,000 people every week to daily park activities and sparking \$150 million investment in a variety of public, commercial, and residential projects within the emerging 10-block Brady Arts District of downtown Tulsa.
- **Klyde Warren Park, Dallas, Texas (Project Owner: Woodall Rodgers Park Foundation; Project Designer: The Office of James Burnett)** – Spurred by a study in 2002 that confirmed the feasibility of a "deck park" over the freeway, leaders of the Dallas business community formed the nonprofit Woodall Rodgers Park Foundation to operate and maintain a new urban park. Built with a combination of public and private funds, the Klyde Warren Park features a flexible, pedestrian-oriented design that arranges a children's park, reading room, great lawn, restaurant, performance pavilion, fountain plaza, games area, dog park,



and botanical garden around a sweeping pedestrian promenade. Clyde Warren Park in Dallas's new town square that has literally and figuratively bridged the city's downtown cultural district with the burgeoning mixed-use neighborhoods to the north, reshaping the city and catalyzing economic development.

- **Railyard Park + Plaza, Santa Fe, N.M. (Project Owner: City of Santa Fe, N.M.; Project Designer: Ken Smith, ASLA, Landscape Architect, Frederic Schwartz, FAIA, Architect Missy May, Artist)** – Built in 1880, the original Railyard was a key component of Santa Fe's identity. The city of Santa Fe, with the help of the Trust for Public Land, purchased the land, and undertook a long public process of planning, design and implementation. The resulting Railyard Park + Plaza is the culmination of two decades of community activism that enabled citizens to retain control over the largest downtown development to conserve the open space in perpetuity as a community asset emphasizing local cultures, businesses and artists. The site's public promenade, art galleries, museums, a farmer's market, brewery, restaurants, retail shops, office space and the commuter rail station create a thriving mixed-use space that contributes to the local economy. The park includes a reflective circular ramada, walkways aligned with former rail tracks, biking and health trails, children's playground, picnic areas, a performance green, orchards, community and teaching gardens.
- **Washington Park, Cincinnati, Ohio (Project Owner: Cincinnati Park Board; Project Designer: Human Nature, Inc.)** – Washington Park was a cemetery before the city purchased the land in 1855, reinterred the remains elsewhere and turned it into a park. It has served as a park since, but in recent decades suffered from disinvestment and criminal activity. Recognizing the value of the neighborhood's historic buildings and the negative impact of the criminal element on the business district, the Cincinnati Center City Development Corporation (3CDC) and the city of Cincinnati began to turn the neighborhood around, ultimately leading Washington Park through a \$40 million renovation that would transform the neighborhood. Today the 6-acre park has been called the most democratic site in the region, attracting all strata of socioeconomic and demographics to its varied features, including a grand civic lawn the size of a football field, a permanent performance stage, a 7,000-square-foot water feature with 130 pop jets, a renovated civil war era bandstand, an enclosed children's playground, and a fenced-in dog park.



2011 Report to the City of Santa Fe

The Raillyard Stewards are honored to partner with the City of Santa Fe in the Raillyard Park + Plaza. The Stewards leverage funding through thousands of volunteer hours and shared resources. In 2011 we focused on deepening our horticulture and volunteer programs and solidified our structure: we formed a 501(c)3 non-profit organization separate from The Trust for Public Land (as planned), and increased our staff and annual budget. We also increased our community workshops and our green job training programs, and continued our community and youth service-learning programs.

Tasks Accomplished in 2011

The Raillyard Stewards had a very busy year in 2011. Thank you to the City of Santa Fe for making this possible! Our accomplishments include:

- Provided over 144 park care events with community and youth volunteers
- Provided over 2300 hours of hands-on park care with volunteers and the community
- Had a total of 736 youth individual volunteer visits and 256 individual adult volunteer visits
- Engaged over 15 schools and youth groups in direct programs

Prepared January 4, 2012. The Raillyard Stewards, www.raillyardpark.org - 1 -

- Increased our green job training hours with at-risk youth and young adults
- Secured awards for the Railyard Park + Plaza, including the Rudy Bruner Award for Urban Excellence
- Launched the Railyard Art Program with installations by Don Kennel (the Yard Dog sculpture) and Axel Contemporary Gallery; created online application system for applications
- Provided 22 community workshops and tours, a 55% increase from 2010
- Assisted the City and the Santa Fe Railyard Community Corporation (SFRCC) with coordination of the Railyard Community Room with the public
- Provided furniture and supplemented folding chairs and other amenities in the Railyard Community Room



Our budget shows direct costs (see attachment), and in-kind contributions, with a rate estimate of costs for these services, are listed on page 3.

CITY OF SANTA FE
PROFESSIONAL SERVICES AGREEMENT

THIS AGREEMENT is made and entered into by and between the City of Santa Fe (the "City") and The Santa Fe Railyard Park Stewards (the "Contractor"). The date of this Agreement shall be the date when it is executed by the City and the Contractor whichever occurs last.

WHEREAS, on February 24, 2010, the Governing Body adopted Resolution No. 2010-11 directing staff to identify funding and to enter into a three year agreement with the Railyard Stewards for \$25,000 per year to provide services for the Railyard Park; and

WHEREAS, on October 13, 2010, the Governing Body adopted Resolution No. 2010-82 to amend Resolution No. 2010-11 in order to authorize the city manager to increase the maximum amount paid to the Railyard Stewards for services to be performed to \$50,000 per year; and

WHEREAS, the City Council approved Resolution 2012-46 directing staff to amend the current agreement with the Santa Fe Railyard Park Stewards for continued services to be provided at the Railyard Park for \$100,000 per year for three years.

WHEREAS, this Agreement is entered into to settle the violation of the Anti-Donation Clause, Article IX, Section 14 of the New Mexico Constitution.

IN CONSIDERATION of the above recitals, the parties hereby agree to the terms and conditions set forth.

1. SCOPE OF SERVICES

During the term of this Agreement, the Contractor shall provide the following services for the City:

A. In Fiscal Year 2014/2015 the Santa Fe Railyard Park Stewards shall provide workshops, volunteer projects and funding programs for the Santa Fe Railyard Park in Santa Fe, New Mexico, as follows:

(1) Determine the definitive scope of work, coordinate, implement and provide specialized programs and oversee (i) the project administration for all phases of the programs.

(2) The Santa Fe Railyard Stewards shall provide the following:

(a) Yardmasters - Park Volunteer Program (\$21,500 per fiscal year);

(b) Youth Programs - Park Volunteer Programs (\$17,500 per fiscal year);

(c) Garden in the Park Workshop Series (\$7,000 per fiscal year);

(d) Community Food Programs (\$4,000 per year);

(3) Manage and coordinate the work of all volunteers providing services and monitor their progress to meet deadlines.

(4) Prepare a yearly program budget based on costs for previous years.

(5) Hire independent consultants to provide project coordination services as needed.

2. STANDARD OF PERFORMANCE; LICENSES

A. The Contractor represents that it possesses the personnel, experience and knowledge necessary to perform the services described under this Agreement.

B. The Contractor agrees to obtain and maintain throughout the term of this Agreement, all applicable professional and business licenses required by law, for itself, its employees, agents, representatives and subcontractors.

C. The Contractor shall obtain any necessary permits through the State of New Mexico Construction Industries Division required for the construction associated with the Santa Fe Railyard Park.

3. COMPENSATION

A. The City shall pay to the Contractor in full payment for services rendered a sum not to exceed fifty thousand dollars (\$50,000) for fiscal year 2014/2015 inclusive of applicable gross receipts taxes.

B. The Contractor shall be responsible for payment of gross receipts taxes levied by the State of New Mexico on the sums paid under this Agreement.

C. Payment shall be made upon receipt and approval by the City of detailed statements containing a report of services completed. Compensation shall be paid only for services actually performed and accepted by the City.

D. Contractor shall pay providers directly for reimbursement of construction services costs and project coordination services provided by independent consultants that are related to programs that are to be paid by the funds allocated for the Project.

4. APPROPRIATIONS

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the City's Capital Improvement Program. If sufficient appropriations and authorization are not made by the City, this Agreement shall terminate upon written notice being given by the City to the Contractor. The City's decision as to whether sufficient appropriations are available shall be accepted by the Contractor and shall be final.

5. TERM AND EFFECTIVE DATE

This Agreement shall be effective when signed by the City and terminate on June 30, 2015, unless sooner pursuant to Article 6 below.

6. TERMINATION

A. This Agreement may be terminated by the City upon 15 days written notice to the Contractor.

(1) The Contractor shall render a final report of the services performed up to the date of termination and shall turn over to the City original copies of all work product, research or papers prepared under this Agreement.

(2) If compensation is not based upon hourly rates for services rendered, the City shall pay the Contractor for the reasonable value of services satisfactorily performed through the date Contractor receives notice of such termination, and for which compensation has not already been paid.

(3) If compensation is based upon hourly rates and expenses, then Contractor shall be paid for services rendered and expenses incurred through the date Contractor receives notice of such termination.

7. STATUS OF CONTRACTOR; RESPONSIBILITY FOR PAYMENT OF EMPLOYEES AND SUBCONTRACTORS

A. The Contractor and its agents and employees are independent contractors performing professional services for the City and are not employees of the City. The Contractor, and its agents and employees, shall not accrue leave, retirement, insurance, bonding, use of City vehicles, or any other benefits afforded to employees of the City as a result of this Agreement.

B. Contractor shall be solely responsible for payment of wages, salaries and benefits to any and all employees or subcontractors retained by Contractor in the performance of the services under this Agreement.

C. The Contractor shall comply with City of Santa Fe Minimum Wage, Article 28-1-SFCC 1987, as well as any subsequent changes to such article throughout the term of this contract.

8. CONFIDENTIALITY

Any confidential information provided to or developed by the Contractor in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the Contractor without the prior written approval of the City.

9. CONFLICT OF INTEREST

The Contractor warrants that it presently has no interest and shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of services required under this Agreement. Contractor further agrees that in the performance of this Agreement no persons having any such interests shall be

employed.

10. ASSIGNMENT; SUBCONTRACTING

The Contractor shall not assign or transfer any rights, privileges, obligations or other interest under this Agreement, including any claims for money due, without the prior written consent of the City. The Contractor shall not subcontract any portion of the services to be performed under this Agreement without the prior written approval of the City.

11. RELEASE

The Contractor, upon acceptance of final payment of the amount due under this Agreement, releases the City, its officers and employees, from all liabilities, claims and obligations whatsoever arising from or under this Agreement. The Contractor agrees not to purport to bind the City to any obligation not assumed herein by the City unless the Contractor has express written authority to do so, and then only within the strict limits of that authority.

12. INSURANCE

A. The Contractor, at its own cost and expense, shall carry and maintain in full force and effect during the term of this Agreement, comprehensive general liability insurance covering bodily injury and property damage liability, in a form and with an insurance company acceptable to the City, with limits of coverage in the maximum amount which the City could be held liable under the New Mexico Tort Claims Act for each person injured and for each accident resulting in damage to property. Such insurance shall provide that the City is named as an additional insured and that the City will be notified within 10 days of cancellation for any reason. The

Contractor shall furnish the City with a copy of a "Certificate of Insurance" as a condition prior to performing services under this Agreement.

B. Contractor shall also obtain and maintain Workers' Compensation insurance, required by law, to provide coverage for Contractor's employees throughout the term of this Agreement. Contractor shall provide the City with evidence of its compliance with such requirement.

C. Contractor shall maintain professional liability insurance throughout the term of this Agreement providing a minimum coverage in the amount required under the New Mexico Tort Claims Act. The Contractor shall furnish the City with proof of insurance of Contractor's compliance with the provisions of this section as a condition prior to performing services under this Agreement.

13. INDEMNIFICATION

The Contractor shall indemnify, hold harmless and defend the City from all losses, damages, claims or judgments, including payments of all attorneys' fees and costs on account of any suit, judgment, execution, claim, action or demand whatsoever arising from Contractor's performance under this Agreement as well as the performance of Contractor's employees, agents, representatives and subcontractors.

14. NEW MEXICO TORT CLAIMS ACT

Any liability incurred by the City of Santa Fe in connection with this Agreement is subject to the immunities and limitations of the New Mexico Tort Claims Act, Section 41-4-1, et. seq. NMSA 1978, as amended. The City and its "public employees" as defined in the New Mexico Tort Claims Act, do not waive sovereign immunity, do not waive any defense and do not waive any limitation of liability pursuant to law. No provision

in this Agreement modifies or waives any provision of the New Mexico Tort Claims Act.

15. THIRD PARTY BENEFICIARIES

By entering into this Agreement, the parties do not intend to create any right, title or interest in or for the benefit of any person other than the City and the Contractor. No person shall claim any right, title or interest under this Agreement or seek to enforce this Agreement as a third party beneficiary of this Agreement.

16. RECORDS AND AUDIT

The Contractor shall maintain, throughout the term of this Agreement and for a period of three years thereafter, detailed records that indicate the date, time and nature of services rendered. These records shall be subject to inspection by the City. The City shall have the right to audit the billing both before and after payment. Payment under this Agreement shall not foreclose the right of the City to recover excessive or illegal payments.

17. APPLICABLE LAW; CHOICE OF LAW; VENUE

Contractor shall abide by all applicable federal and state laws and regulations, and all ordinances, rules and regulations of the City of Santa Fe. In any action, suit or legal dispute arising from this Agreement, the Contractor agrees that the laws of the State of New Mexico shall govern. The parties agree that any action or suit arising from this Agreement shall be commenced in a federal or state court of competent jurisdiction in New Mexico. Any action or suit commenced in the courts of the State of New Mexico shall be brought in the First Judicial District Court.

18. AMENDMENT

This Agreement shall not be altered, changed or modified except by an

amendment in writing executed by the parties hereto.

19. SCOPE OF AGREEMENT

This Agreement incorporates all the agreements, covenants, and understandings between the parties hereto concerning the services to be performed hereunder, and all such agreements, covenants and understandings have been merged into this Agreement. This Agreement expresses the entire Agreement and understanding between the parties with respect to said services. No prior agreement or understanding, verbal or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

20. NON-DISCRIMINATION

During the term of this Agreement, Contractor shall not discriminate against any employee or applicant for an employment position to be used in the performance of services by Contractor hereunder, on the basis of ethnicity, race, age, religion, creed, color, national origin, ancestry, sex, gender, sexual orientation, physical or mental disability, medical condition, or citizenship status.

21. SEVERABILITY

In case any one or more of the provisions contained in this Agreement or any application thereof shall be invalid, illegal or unenforceable in any respect, the validity, legality, and enforceability of the remaining provisions contained herein and any other application thereof shall not in any way be affected or impaired thereby.

22. NOTICES

Any notices required to be given under this Agreement shall be in writing and served by personal delivery or by mail, postage prepaid, to the parties at the
