Recently the citizens of the Sierra Bonita and Rincon Ranch subdivisions, located in Mora County, established a new volunteer fire department (SBR Volunteer Fire Department). I am sure you are aware that for the first year of a new fire department's existence it is on probation and the State provides no funding whatsoever. Even so, the new department has a list of equipment, tools and gear they must acquire in order to get off of probation and become eligible to receive state funding.

We at SBR VFD are contacting larger fire departments in our area to see if they have any surplus trucks, gear or tools that could be transferred to us to help us in this endeavor. If the Santa Fe Fire Department has any such surplus items we would greatly appreciate your help in acquiring them for our Department.

We will do fundraising on our own to supplement the Fire Excise tax funds we will receive, but some of the items we are required to obtain cost more than an entire years worth of Excise Tax revenue we can expect to receive.
