**SUMMARY:**

The Purchasing Division is requesting the purchase of Rock Salt for the Streets and Drainage Division from the aforementioned State Price Agreement, in the amount of \$44,083.70. New Mexico Salt & Minerals, is the authorized vendor on this State Price Agreement.

This procurement of Rock Salt is requested by the Streets Division to replenish the stockpile which was used during recent storms. Although this procurement request is under the \$50,000 threshold for small purchases, we are asking for preapproval to utilize this contract for the remainder of the year ending 6/30/2014, for additional purchases that may arise as a result of unforeseen weather related circumstances.

Funding for this purchase is available in Business Unit 32389.530200(Street Maintenance/ Operating Supplies).

Per City of Santa Fe Procurement Policy 11.1.1; any procurement transacted through a State or Federal Price Agreements exceeding \$50,000 shall be submitted to the City Council for approval.
