

The Purchasing Division is requesting the use of the aforementioned Cooperative Agreement for the procurement of Fire and Law Enforcement supplies, Medical, Rescue goods, equipment, etc, for all City wide divisions. Grainger, Inc, is the authorized vendor under this Cooperative Agreement.


