





ITEM & ISSUE

Request from New Mexico School for the Arts for a waiver of the 300 foot location restriction and approval to allow the dispensing/consumption of alcoholic beverages in the Georgia O'Keeffe Museum Education Annex Parking Lot, 123 Grant Avenue, which is within 300 feet of the First Presbyterian Church, 208 Grant Avenue.

BACKGROUND AND SUMMARY

Pursuant to §60-6B-10 NMSA 1978, a request from New Mexico School for the Arts for a waiver of the 300 foot location restriction has been submitted to allow the dispensing and consumption of alcoholic beverages at their Annual Fundraising Gala "ArtSpring". This event will be held on Friday, May 9, 2014 from 7:00 p.m. to 9:30 p.m.

The applicant is seeking to obtain a letter from the First Presbyterian Church with regard to this request. This letter shall be provided to the Governing Body upon receipt.

ACTION REQUESTED

I hereby request that the City Council indicate its decision on the request for a waiver of the 300 foot location restriction and approval to allow the dispensing/consumption of alcoholic beverages on Friday, May 9, 2014 from 7:00 p.m. to 9:30 p.m. in the Georgia O'Keeffe Museum Education Annex Parking Lot, 123 Grant Avenue.

Dear Mayor Gonzales and Council Members:

This letter will confirm that New Mexico School for the Arts (NMSA) seeks approval of a liquor license for its annual fundraising gala, *ArtSpring*, on Friday, May 9, 2014. All proceeds of this event support scholarships to NMSA to aspiring young artists throughout New Mexico.

NMSA is the only legislatively created, public, residential, arts-focused high school in New Mexico and serves more than 200 talented young artists from 37 different communities throughout the state. Since it opened, NMSA has achieved a 96% graduation rate, reading and mathematics scores that exceed state benchmarks, and 94% of students going on to post-secondary education.

The event will include a champagne reception at the Lensic Performing Arts Center and a performance featuring students from each of the Dance, Music, and Theater Departments, followed by an exhibition of the work of senior students in the Visual Arts department at the Georgia O’Keeffe Museum Annex at 123 Grant Street from 7:15PM-9:30PM. The O’Keeffe Museum has kindly granted NMSA permission to tent the area of the Grant Street parking lot in front of their Education Annex, where refreshments, including alcoholic beverages, will be served to our guests, most of whom are our high-level donors and supporters.

This event has been held in this location for the previous two years, and we respectfully request that this license be issued again, so that NMSA can hold a successful event that helps support our work on behalf of arts education in New Mexico.


