The Pledge of Allegiance was led by Doug Schocke and was recited by all present.

APPROVAL OF AGENDA

Mr. Gonzales moved to approve the agenda as published. Ms. Sanchez seconded the motion. The motion passed unanimously by voice vote.

APPROVAL OF MINUTES: May 21, 2014

Ms. Lucero moved to approve the Minutes of the May 21, 2014 meeting as submitted. Ms. Gonzalez seconded the motion. The motion passed unanimously by voice vote.

DIVISION OF SENIOR SERVICES DIRECTOR'S REPORT

a) Program Units of Service

Mr. Vialpando gave an update on the Program's Units of Services as follows:

- In the last month of the fiscal year, the Division of Senior Services is over, based on projections, in congregate meals by 3,925 units of services and over by 1,675 in Home-Delivered meals.
- The Division of Senior Services is short by 188 units for transportation services.
- The Division of Senior Services is also showing an overage in respite units by 1,981 units; and a shortfall of 166 units for homemaker services.
- The Division of Senior Services expects to close the gap in units of services by the end of the fiscal year.

b) Capital Outlay Pending Projects

Mr. Vialpando said these are the projects that the Division of Senior Services received agreements relating to the 2012-2013 Legislative requests. The projects include the Warehouse at the MEG Center; the computer lab for the MEG Center; a renovation of the kitchen at the Pasatiempo Senior Center; the computer lab at Luisa Senior Center and facility improvements at Luisa Senior Center and the Villa Consuelo Senior Center, as well as kitchen equipment for Villa Consuelo Senior Center. The plans are 90% complete and the Division of Senior Services is anticipating breaking ground on the construction of these projects sometime in August or September.

COMMITTEE REPORTS:

In-Home Support Committee

Mr. Alarid moved to accept the In-Home Support Committee monthly report as submitted, and include it as a part of the public record with the Minutes. Ms. Trujillo seconded the motion. The motion passed unanimously by voice vote.

Grant Reports/Updates

- We completed our final Progress Report for the three-year grant that closed out on March 31, 2014 and have since received formal notification that "all applicable final administrative and financial actions and other requirements of the above grant have been completed and, accordingly, the award may be considered closed out."
- For January March, 448 volunteers reported serving 29,465 at 60 volunteer stations.
- As of July 1, 2014, our volunteer insurance will cover volunteers only while they are driving as part of volunteering, but not to and from volunteering any longer.

Volunteer Recognition

- The Mayor's Senior Volunteer Celebration was a great success.
- We spent many days arranging for volunteers to be interviewed for a video to show at the celebration. We taped at MEG, at Kitchen Angels and St. Vincent Hospital.
- The video did not work so we are going to re-screen it at MEG on June 20th at 2:00pm with prizes, pictures, food and more.


May units of service are as follows:


- Homemaker 763 & 1/4 hours to 90 seniors
- Respite 889 & 1/2 hours to 43 caregivers
- Equipment 59 units
- Nutritional Supplements –124 6-packs (31 cases)

Year to date, we are **over** in Respite hours by 451 hours and **short** in Homemaker hours by 166 hours. IHSS providers took off a total of 205 & 1/2 hours in May. Additionally, Monday, May 26 (Memorial Day) was a holiday.

We need to provide 946 homemaker hours in June to meet our goal and 306 & ½ Respite hours to meet that goal. We will definitely exceed Respite goal.
