11	RELATING TO A LOCAL GOVERNMENT ROAD FUND COOPERATIVE AGREEMENT
12	BETWEEN THE CITY OF SANTA FE AND THE NEW MEXICO DEPARTMENT OF
13	TRANSPORTATION FOR IMPROVEMENTS TO ALAMEDA STREET BETWEEN
14	CAMINO ALIRE AND CALLE NOPAL; DIRECTING STAFF TO CAUSE SUCH
15	COOPERATIVE AGREEMENT TO BE EXECUTED ON BEHALF OF THE CITY OF
16	SANTA FE.
17	
18	WHEREAS, in recent years, Alameda Street has experienced a rapid pavement surface
19	deterioration due to many street utility cuts from residential development and utility repair, with
20	subsequent pavement substructure failures caused by moisture, recent harsh winters, and increases in
21	traffic volumes; and
22	WHEREAS, the City of Santa Fe plans to make roadway improvements to Alameda Street
23	between Camino Alire and Calle Nopal as part of its annual resurfacing program (2014 season); and
24	WHEREAS, such improvements shall include roadway pavement rehabilitation, drainage
25	and nedestrian improvements to include reconstruction of some deteriorated sidewalks, and manhole

2	WHEREAS, funding assistance for such improvements will be provided by the State upon
3	execution of a Local Government Road Fund (LGRF) Cooperative Agreement between the New
4	Mexico Department of Transportation (NMDOT) and the City of Santa Fe; and
5	WHEREAS, the improvements to Alameda Street shall enhance roadway and pedestrian
6	safety and improve ride ability; and
7	WHEREAS, funding from the NMDOT to aid construction shall consist of \$63,795.00
8	through the LGRF cooperative agreement; and
9	WHEREAS, the City, as part of the LGRF Cooperative Agreement shall match up to
10	\$491,345.10 to the NMDOT funds using the 2014 Capital Improvement Bond issue; and
11	WHEREAS, the City shall assume ownership, liability and maintenance responsibilities for
12	all amenities related to the completion of the project.
13	NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
14	CITY OF SANTA FE that staff is directed to cause a Cooperative Agreement between the City and
15	the NMDOT to be executed on behalf of the City to share in the funding for improvements or
16	Alameda Street between Camino Alire and Calle Nopal.
