12	MISSION OF MERCY PROGRAM ("NM MOM") TO PROVIDE NO COST DENTAL CAR		
13	TO THE RESIDENTS OF SANTA FE AND AUTHORIZING THE WAIVER OF FEES FO		
14	USE OF THE SANTA FE COMMUNITY CONVENTION CENTER FOR THE NM MON		
15	EVENT IN APRIL OF 2016.

17	WHEREAS, through the adoption of Resolution 2012-89, the Governing Body endorsed th		
18	efforts of the dental community to collaborate with local schools, health providers and state and local		
19	governmental entities to formulate a plan to provide increased services, education and outreach to th		
20	residents of Santa Fe county; and		
21	WHEREAS, there is a great need for dental care in our local community, in particular th		
22	underserved working-poor of Santa Fe; and		
23	WHEREAS, the City of Santa Fe is tasked with representing and addressing the needs of it		
24	residents; and		
25	WHEREAS, the New Mexico Missio	n of Mercy is a program of the New Meyico Dental	

1	Foundation and the Charitable Arm of the New Mexico Dental Association; and		
2	WHEREAS, the New Mexico Mission of Mercy is a large scale, free two day dental clinic at		
3	which services are provided free of charge for adults and children; and		
4	WHEREAS, the dental services include cleanings, fillings, root canals, extractions, and		
5	simple prosthetics by approximately 500 volunteer dentists and other dental professionals in addition		
6	to 1000 lay volunteers; and		
7	WHEREAS, New Mexico Mission of Mercy has had three events, Albuquerque-2010, Las		
8	Cruces-2012, and San Juan County-2013 at which nearly 4,700 new smiles have been created and		
9	over \$2.8 million in free dental treatment have been provided by 4,500 volunteers; and		
10	WHEREAS, the 2014 Central New Mexico event was held October 24th-25th at the Santa		
11	Ana Star Center in Rio Rancho; and		
12	WHEREAS, the New Mexico Dental Foundation desires to hold the next Mission of Mercy		
13	event in Santa Fe, New Mexico April of 2016.		
14	NOW, THEREFORE, BE IT THEREFORE RESOLVED BY THE GOVERNING		
15	BODY OF THE CITY OF SANTA FE that the Governing body endorses the efforts of New		
16	Mexico Dental Foundation to provide no cost dental care to the residents of Santa Fe and hereby		
17	authorizes the waiver of fees for use of the Santa Fe Community Convention center for the MOM		
18	event in April of 2016.		
19	BE IT FURTHER RESOLVED that staff is directed to:		
20	1. Coordinate the exact dates of the MOM event with the organizers, no later than		
21	January 31, 2015;		
22	2. Coordinate no-cost parking at the Santa Fe Community Convention Center for		
23	doctors and volunteers; and		
24	3. Coordinate transit services from area parking lots and/or bus stops to the Santa Fe		
25	Community Convention Center.
