**1. CALL TO ORDER**

## **2. NEW BUSINESS**

### **A. Election of Officers**

Mr. Vigil said one idea they had was to ask the Santa Fe Public Schools and the private schools as well (St. Michael's High School and SF Prep) to invite/assign a group of students from their schools to participate with the Mayor's Youth Advisory Board and/or the Youth Meeting. These can include students that are freshmen, sophomores, juniors and seniors.

Mr. Sanchez said they would like to see a wide variety of kids to participate in the Youth Meeting to get input from all youth.

Mr. Vigil mentioned that there are also youth serving on the Immigration Committee.

#### **4. DISCUSSION ITEMS FOR NEXT MEETING**

The Board was asked to think of issues for youth, ideas for activities and projects that they would like to see for youth in Santa Fe.

#### **7. ADJOURNMENT**

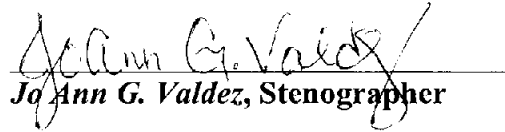
