APPLICABILITY: [The rates apply as per January 1, 2007] The water rate schedules reflect an increase of 8.20% per year. The applicable rate shall be based upon the character of service as set forth in Rule 3 of Exhibit A, Chapter 25 SFCC 1987. Service will be furnished in accordance with the City's Rules and Regulations covering water service, available at the City's offices and on file with the office of the City Clerk of the city of Santa Fe, which Rules and Regulations or subsequent revisions thereof are a part of this Schedule as if fully written herein.

SERVICE AREA: Within the corporate limits of the city of Santa Fe, New Mexico and those areas outside the corporate limits to which service has been authorized by action of the governing body of the city of Santa Fe.

FIRE PROTECTION CHARGE: If the customer has a fire service line or lines for standby fire protection, the appropriate rate as provided in Rate Schedule 6, Fire Service Line, shall also be charged.

<u>IRRIGATION METER:</u> If the customer has an additional meter installed primarily for irrigation or other outdoor uses such as, but not limited to, pool or spa filling or vehicle washing, the same commodity and system charge as set forth above shall apply.

SPECIAL TAX AND ASSESSMENT CLAUSE: Billings under this Schedule may be increased

2	Act and of all other taxes, fees, or charges payable by the City and levied or assessed by any
3	governmental authority on the public utility service rendered, or on the right or privilege of
4	rendering the service, or on any object or event incidental to the rendition of the service.
5	MINIMUM CHARGE: The minimum charge under this Schedule shall be the monthly service
6	charge.
7	<u>USE OF SERVICE</u> : Service shall not be resold or shared with others.
8	ADDITIONS AND EXTENSIONS: Additions or extensions under this Schedule shall be subject
9	to the availability of existing water lines of adequate capacity to provide the service requested.
10	The City shall not be required for purposes of supplying service hereunder to increase the
1	capacity of its mains or to make any extensions thereto. Subject to the foregoing provisions,
12	additional points of delivery may be requested, and the City, upon receipt of such requisition,
13	shall furnish the water service in accordance with the rates contained in this Schedule.
14	OTHER CONDITIONS: Other conditions pertaining to application of service, water taps,
15	disconnection and reconnection of service, responsibility for payment of bills, and other
16	conditions are provided for in the City's Rules and Regulations, available at its Water Services
17	Division's office.
18	SERVICE APPLICATION: All applications for services for one inch (1") and larger meters shall
19	be covered by written agreement on the City's standard application form.
20	Section 3. EFFECTIVE DATE. This Ordinance shall become effective March 1,
21	2009.
