5 AN ORDINANCE

6 CREATING A NEW SECTION 10-11 SFCC 1987 TO PROHIBIT THE SALE OF  
7 SINGLE SERVING CONTAINERS OF ALCOHOLIC BEVERAGES, IN SIZES OF  
8 EIGHT OUNCES OR LESS, WITHIN THE MUNICIPAL BOUNDARIES OF THE CITY  
9 OF SANTA FE.

11 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

12 Section 1. A new Section 10-11 SFCC 1987 is ordained to read:

13 10-11 [NEW MATERIAL] SINGLE SERVING ALCOHOLIC BEVERAGE SALES

14 10-11.1 [NEW MATERIAL] Short Title.

15 This section may be cited as the Single Serving Alcoholic Beverage Sales Ordinance.

16 10-11.2 [NEW MATERIAL] Legislative Findings.

17 A. In collaboration with Keep Santa Fe Beautiful Inc., the city of Santa Fe is  
18 dedicated to environmental education, litter awareness and prevention and beautification  
19 programs.

20 B. The governing body finds that small plastic and glass alcohol bottles are rapidly  
21 accumulating along our roadways, trails and public parks.

22 C. As a proactive approach to minimizing litter from small plastic and glass alcohol  
23 bottles, the governing body finds it necessary to ban the sale of single serving containers of  
24 alcoholic beverages in sizes of eight (8) ounces or less.

25 10-11.3 [NEW MATERIAL] Definitions.

1            *Alcoholic beverage(s)* means distilled or rectified spirits, potable alcohol, brandy,  
2 whiskey, rum, gin and aromatic bitters bearing federal internal revenue strip stamps or any similar  
3 alcoholic beverage, including blended or fermented beverages, dilutions or mixtures of one or  
4 more of the foregoing containing more than one-half percent alcohol, but excluding medicinal  
5 bitters.

6            **10-11.3 [NEW MATERIAL] Sale of Single Service Alcoholic Beverages Prohibited.**

7            In addition to the provisions of Chapter IV SFCC 1987, Alcoholic Beverages; unless  
8 contained in packages of four or more, as delivered by the distributor, single serving containers of  
9 alcoholic beverages, in sizes of eight (8) ounces or less, shall not be sold or offered for sale for  
10 off-site consumption, within the municipal boundaries of the city of Santa Fe.


11           **10-11.4 [NEW MATERIAL] Effective Date.** The provisions of this Section 10-11  
12 SFCC 1987 shall be effective six months from the date of adoption, October 8, 2015.

13           PASSED, APPROVED, and ADOPTED this 8<sup>th</sup> day of April, 2015.


