Section 6-17.1 SFCC 1987 (being Ord. #2005-5, §2) is amended to 17 read: 18 6-17.1 Creation; Purpose. 19 There is created the city business and quality of life advisory committee for the following 20 purposes: 21 Implementing the city's economic development plan (Resolution No. 2004-42 as A. 22 may be amended), including adopting a more business friendly attitude within city government

Assisting the governing body in understanding the potential impacts, including

and making recommendations to the governing body on applications for assistance for economic

development projects and for industrial revenue bonds;

Preventing unanticipated impacts from city actions, ordinances and regulations; and

D. Providing businesses and the community with the opportunity to review and comment on proposed actions, ordinances and regulations at an early stage.

Section 2. Section 6-17.2 SFCC 1987 (being Ord. #2005-5, §3) is amended to read:

6-17.2 Powers and Duties.

The powers and duties of the committee shall include (without limitation):

- A. At the discretion of the business and quality of life advisory committee, reviewing and making a recommendation to the governing body on proposed ordinances amending the city code, resolutions or other city regulations which may have a potential impact on businesses in the community. The committee shall conduct a public meeting regarding such proposed ordinances, resolutions or regulations as early as possible in their development. Items under consideration by the committee may be moved to another committee or to the governing body for appropriate consideration upon a majority vote of the governing body at any time.
- B. Providing timely information to businesses regarding those proposed ordinances, resolutions and regulations;
- C. Informing the governing body, in a timely manner, as to the potential impacts of proposed ordinances, resolutions or regulations on the business community;
- D. Initiating proposals, through an annual work plan, which would improve the business climate and the quality of life in the community as a whole including, but not limited to, modifications to city regulations and operations and staff responsibilities for the governing body's consideration;
 - E. Advising the governing body on matters of importance to the business

1	community and the community as a whole including, but not limited to, impacts on the business				
2	community and the community as a whole due to city regulations and operations and suggesting				
3	improvements for city services;				
4	F. [Supporting the implementation of the city's economic development plan; and]				
5	Reviewing and making recommendations to the governing body on implementing the				
6	economic development plan and the annual budget for implementing the economic development				
7	plan. The committee, in coordination with public groups, shall appoint working groups or				
8	advisory subcommittees, as needed, to implement the economic development plan.				
9	G. Reviewing the recommendations of the economic development review				
10	subcommittee and making recommendations to the governing body regarding:				
11	(1) Applications for assistance for economic development projects; and				
12	(2) Reviewing and making recommendations to the governing body on				
13	applications for industrial revenue bonds (IRB's) as set forth in Resolution No. 1995-83				
14	as may be amended.				
15	[G-]H. Adopting procedures, schedules and administrative policies for matters within the				
16	committee's powers and duties in order to provide information and assistance to city staff, the				
17	public and the governing body.				
18	Section 3. A new Section 6-17.6 SFCC 1987 is ordained to read:				
19	6-17.6 [NEW MATERIAL.] Economic Development Review Subcommittee.				
20	A. The economic development review sub committee shall review and make				
21	recommendations to the business and quality of life advisory committee on applications for the				
22	following:				
23	(1) Assistance for economic development projects; and				
24	(2) Industrial revenue bonds (IRB's) as set forth in Resolution No. 1995-83				
25	as may be amended.				

- B. The economic development review subcommittee shall be composed of five (5) members residing in the county and qualified by training, experience, and ability to exercise sound and practical judgment. Two members shall be members of the business and quality of life advisory committee and three members shall be from the business community. The members shall be appointed by the mayor with the advice and consent of a majority vote of all the members of the city council. The mayor shall designate a chairperson and vice-chairperson from among the subcommittee members. All subcommittee members may be removed by the mayor with or without cause.
- C. Of the members appointed initially to the subcommittee, two (2) shall have one (1) year terms and all others shall have two (2) year terms. Each subsequent term of a member shall be for two (2) years to maintain the original staggering of terms of membership. There shall be no limitation of the number of consecutive terms a member may serve on the economic development review subcommittee.
- D. The subcommittee shall meet as needed and shall conduct all meetings in accordance with adopted city policy and procedures. At least five (5) days prior to the meeting, staff shall post the tentative meeting agenda in city hall as well as on the city's website. The subcommittee shall keep minutes of its proceedings, showing the vote of each member on each question, or indicating absence or failure to vote and shall keep records of its review and official actions, all of which shall be filed in the city clerk's office.
- Section 4. [REPEAL.] Section 11-11.6 SFCC 1987 (being Ord. #1996-21, §6 as amended) is repealed.
 - Section 5. A new Section 11-11.6 SFCC 1987 is ordained to read:
 - 11-11.6 [NEW MATERIAL.] Economic Development Review Subcommittee.

The economic development review subcommittee of the business and quality of life advisory committee is established as set forth in Section 6-17.6 SFCC 1987.

25	determination whether the applicant is a qualifying entity.			

(7) Any other information required of the applicant.

Section 7. Section 11-11.8 SFCC 1987 (being Ord. #1996-21, §8 as amended) is amended to read:

11-11.8 Application Review Process.

- A. The economic development division, finance department, and such other city staff as are necessary and appropriate shall review the application and advise the economic development review [eommittee] subcommittee if the entity and the proposed project meet the definitions of this section and the policies and objectives of the city's economic development plan. The city may at its discretion engage independent consultants to assist in the review of applications.
- B. The economic development review [eommittee] subcommittee shall determine at a public meeting whether the entity and the proposed project qualify under this section.
- C. City staff shall then coordinate with the qualifying entity to develop a project participation agreement as set forth in subsection 11-11.11 SFCC 1987.
- D. The economic development review [eommittee] subcommittee shall consider the economic development project and the project participation agreement at a public meeting in accordance with the criteria set forth in subsection 11-11.9 SFCC 1987. The committee shall recommend to the [governing body] business and quality of life advisory committee that the proposal be adopted, conditionally adopted or not adopted.
- E. The recommendation will be forwarded with the project participation agreement, minutes of the economic development review [eommittee] subcommittee and the business and quality of life advisory committee [meeting] meetings and any other pertinent information to the [eity finance committee for recommendation to the] governing body for final consideration at a public hearing. Review of the application by the finance committee or other subcommittees of the governing body shall not be required unless otherwise directed by the governing body.
