11	SUPPORTING THE APPLICATION AND RESPONSE TO THE REQUEST FOR
12	PROPOSALS ISSUED BY THE NORTH CENTRAL NEW MEXICO ECONOMIC
13	DEVELOPMENT DISTRICT, NON-METRO NEW MEXICO AREA AGENCY ON
14	AGING FOR CONTINUATION OF SERVICES FOR THE SENIOR CITIZENS OF THE
15	CITY OF SANTA FE.

17	WHEREAS, the Older Americans Act of 1965, as amended, was enacted by Congress to
18	ensure provision of social services for America's elderly population; and
19	WHEREAS, the residents of Santa Fe were afforded an opportunity to submit their
20	recommendations for senior services at an advertised public hearing; and
21	WHEREAS, the City of Santa Fe recognizes that there is a need to provide services for
22	the senior citizens; and
23	WHEREAS, the Division of Senior Services of the City of Santa Fe currently
24	administers social services such as congregate meals, home delivered meals, housekeeping
25	respite, transportation, volunteer opportunities and health promotion activities for senior citizens

1	living throughout our city; and
2	WHEREAS, every four years, the North Central New Mexico Economic Development
3	District, Non-Metro New Mexico Area Agency on Aging ("Area Agency on Aging") issues a
4	Request for Proposals for prospective vendors to provide services for senior citizens; and
5	WHEREAS, currently the Division of Senior Services has a vendor agreement with the
6	Area Agency on Aging to provide services for senior citizens; and
7	WHEREAS, the current vendor agreement expires on June 30, 2016.
8	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
9	CITY OF SANTA FE that the Governing Body:
10	1. Desires to continue services to the senior citizens of our community; and
11	2. Supports the application and response to the RFP issued by the Area Agency on
12	Aging; and
13	3. If awarded a vendor agreement, authorizes the execution of such agreement for
14	the 2016-2020 funding cycle, July 1, 2016 through June 30, 2020.
