**A. CALL TO ORDER**

The Archaeological Review Committee Hearing was called to order by David Eck, Chair, at approximately 4:30 p.m., on June 2, 2016, in the City Councilor's Conference Room, City Hall, Santa Fe, New Mexico.

**BACKGROUND & SUMMARY**

The project is a submittal of a final monitoring report of the archaeological monitoring of ground disturbance.

**STAFF RECOMMENDATION**

Staff recommends approval of the monitoring report as submitted as it meets the intent of 14-3.13(B)(2)(c) and 14-3.13(B)(3)(c), and 14-3.13(C)(5)(d)(D)(iii).

Chair Eck thanked Ms. Ramirez-Thomas for the staff report, and asked if she has further comment.

Ms. Ramirez-Thomas said no.

Chair Eck asked Mr. Winters if he has further commentary.

Mr. Winters said he would first like to thank the Committee for selecting him to receive the Heritage Presentation Award, and said Mr. Rasch represented the City quite well, and spoke quite eloquently.

Mr. Winters said, with regard to the project, he wasn't surprised about the lack of cultural resources on this project, given how much disturbance these parks must have seen during construction, including grading, infilling, sprinkler systems and such. He said the project was very worthwhile given the results he has seen in the park, commenting the shade structures are very nice.

Mr. Winters provided a color photo of one of the photos in the packet, of the gentleman running the auger. Mr. Winters said he was able to move all of the dirt from the auger onto a tarp using a special technique. He said as a result, he saw every auger full of dirt. He said it was quite an effective procedure, commenting he has never seen that done before.

Chair Eck said then he would have seen any artifacts immediately if there had been such.

Mr. Winters said yes, noting there was one piece of modern glass. He said he felt like nothing was missed based on the procedure that he was using.

Chair Eck said given the volume of soil that was a workable procedure for him to do.

Mr. Winters commented that as you can see, he was quite effective at keeping the dirt in the auger.

Chair Eck said it sound like he understood Mr. Winters needs and modified accordingly.

Mr. Winters said that is correct. He urged the Committee members to go by the parks and look at the new shade structures, commenting they are very "cool."

### **Gary Funkhouser**

Mr. Funkhouser said it is a good report, and he has no further comment.

### **Jake Ivey**

Mr. Ivey said he is amazed he found only one piece of glass.

Mr. Winters said this is in the childrens' playground part of the Park.

Mr. Ivey said he has no further remarks.

**Chair Eck**

Chair Eck said he has nothing to add.

**MOTION:** Jake Ivey moved, seconded by Gary Funkhouser, with respect to Case #AR-22-15, to approve the Monitoring Report for the City of Santa Fe Parks Playground Shade Structures Project, requested by Ron Winters, Agent for the City of Santa Fe, owner, finding it meets the intent of 14-3.13(B)(2)(c), 14-3.13(B)(3)(c), and 14-3.13(C)(5)(d)(D)(iii), and to forward a copy of the report and notice of this approval to the New Mexico Historic Preservation Division, as per NMAC 4.10.7

**VOTE:** The motion was approved unanimously on a voice vote.

**G. DISCUSSION ITEMS**

Ms. Ramirez-Thomas said a press release will be issued by the City regarding filling the vacancy on the ARC, asking individuals who are interested to submit their letter of interest and resume to the Mayor. She said she has one person to express interest, but she is unsure she is on the City or the SHPO list.

Mr. Funkhouser said there would be a bigger pool of people if they would consider people living in the County.

Ms. Ramirez-Thomas said the Ordinance provides that people serving on this Committee must live within the City limits.

Ms. Ramirez-Thomas said she needs to work out the issues with the Chair's email, commenting it could be his email provider won't accept City emails.

Chair Eck said MSN moved to Hotmail status, and that could be the reason he can't receive emails from the City. He asked if there have been issues with Gmail, commenting he has a Gmail account as well.

Ms. Ramirez-Thomas said no.

Chair Eck said he will check for incoming City emails and if he hasn't received anything, he will email her from Gmail to send further items to that email address.

Chair Eck asked the status of the draft Ordinance.

Ms. Ramirez-Thomas said it is moving forward, but Mr. Shandler has been very busy. She said the next meeting of ARC will be exclusively for discussion of the draft Ordinance. She said they should have a good final draft at that time for discussion. She will send it out to the ARC Committee members prior to the meeting, so you can read and review it prior to the meeting.

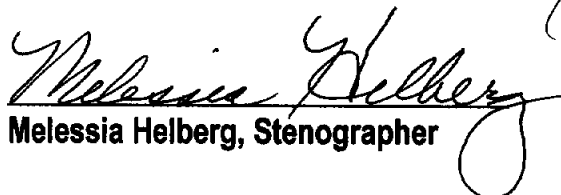

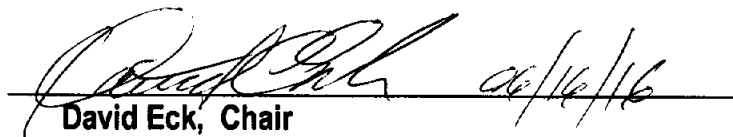
#### **J. ADJOURNMENT**
