1. Call to Order

The Chair, Carol Robertson-Lopez called the Santa Fe Sister Cities Committee meeting to order at 4:00 pm. A quorum was declared by roll call.

2. Approval of Agenda

Mr. Fernandez moved to approve the agenda as presented, second by Clara Padilla-Andrews, motion carried by unanimous voice vote.

3. Approval of Minutes – April 13, 2016

Page 4 – insert: Clara Padilla Andrews is happy to “help” with fund raising.

Mr. Olivas moved to approve the minutes of April 13, 2016 as amended, second by Ms. Padilla-Andrews, motion carried by unanimous voice vote.

4. Report of Staff

Ms. Bystrom noted that they are still working on the airport project and things are moving according to the timeline.

5. Report of Chair

The Chair received an email from Mr. Zach Benjamin who has had a conversation with Mayor Gonzales about having a sister city in Israel. The Chair explained the vetting process to Mr. Benjamin and asked if they have a group in Santa Fe that supports the Israel Sister City. Mr. Benjamin confirmed that they do have a group in Santa Fe. Albuquerque has created a sister city relationship with Rehovot which isn't far from Israel. The Chair would like Ms. Bystrom to send out the criteria to the Sister Cities Committee members and have this as an agenda item for next meeting. The Chair will provide the name of the proposed city in Israel at next meeting. Mr. Olivas suggested that if possible Mr. Benjamin should provide information on how the proposed city would connect with Santa Fe. The Chair met with Ms. Shara Greenberg who is the Chair of the Rehovot - Israeli Sister City. She is a dance teacher and an amazing individual; she is excited about the Santa Fe opportunity.

The Chair also noted that Letters to the Editor comments are important to assure that the cohesive relationship between the two cities can be detailed correctly showing the connection to the City of Santa Fe. We would like to acquire positive press coverage on all Sister City relationships.

Dr. Case has met with City Councilor Peter Ives who also mentions possible sister city relationships with other countries/cities. Dr. Case encourages the screening of sister city requests and agrees that the criteria is important. The Sister Cities Committee can then inform the Mayor of requests in a formal, vetted manner. Mr. Rubenstein would like to acquire the list of potential sister cities from Councilor Ives if it is available.

Ms. Andrews asked if the Sister City Committee makes the decision on all applications. The Chair noted that the Sister Cities Committee vets the requests. Staff Project Manager will provide the information to Ms. Garcia y Griego about the request and she in turn talks to the Mayor to confirm his approval. The Chair also asks the question; "do you have a group in Santa Fe that represents your country." Ms. Andrews asked if we have the same sister cities as Albuquerque. The Chair noted that normally we do not. The Chair also clarified that we don't get in to National Policy with other countries under a sister city relationship.

The Chair reported on her recent visit to Incheon, Korea. Ms. Garcia y Griego will be visiting there in 2 weeks and the sister city delegation in Korea are happy to discuss with her items of concern and interest. The Chair also provided information on the different location visits they took. Cho-Byung-don, Mayor of Incheon City, Korea plans to visit Santa Fe. The Chair would like to have Sister Cities members on board with the Folk Art Festival to serve on the VIP committee. Folk Art Festival is the second week in July, 2016.

6. Committee Updates

Rudy Fernandez: The dignitary visit from Spain was very successful. Dr. Case was with Mr. Fernandez when they signed the agreement to send students from Spain to SFCC. Mr. Fernandez sadly reported that after all the efforts made between SFCC and the Spain delegation to send students to Santa Fe based was declined based on cost. Dr. Case noted that in there was a newspaper article that reported Spain to enter into an exchange program with Western NM University in Silver City. Mr. Fernandez expressed his thanks to Carmen Gonzales and informed the committee that she is interested in becoming a member of the Sister Cities Committee.

Mr. Fernandez has spoken to the representative from Parral, Mexico and they have extended an invitation to the Sister City Committee. At this time the airfare is approximately \$1200 round trip. Options might be to travel to El Paso and take air transit from Juarez to Chihuahua. From Chihuahua the Parral officials pick up the group and get them to Parral, Mexico. July 18-23; the 20th is the day of the re-enactment. Discussion will continue at a future meeting.

Bernard Rubenstein asked if we have an anniversary date for our Sister Cities. We could possibly entertain the planting of a tree or plaque to honor our relationship with each city. There is a Cuban Dance Festival who will be performing in NY. There are many dance groups planning to come to the United States. We could investigate getting the wonderful group, The Holguin Dance company *Codanza* who has recently celebrated 20 years of intense work, to visit Santa Fe. The Lensic Theatre would be a perfect venue.

Dr. Jeff Case: Did a follow up on Travel Bug (Exhibit A) – guidelines were provided to the Sister Cities Committee for review. The guidelines recommend 75-200 pictures with a short description. These are all no fee presentations; there is a coffee shop where they present the power point image. The Chair would like to see Travel Bug placed on the next agenda for discussion.

Dr. Case met the new principal, Ms. Jin-Young Nam of the Korean Ceramic Arts High School during his recent visit and with City Councilor Mr. Kim in Incheon. Mr. Kim is also a member of Rotary International and a conversation was held on what type of relationship could be entered in to between our Sister Cities. Through the effort of the Chair, The Icheon Ceramic Festival was invited to the May 2016 Silk and Spice Market in Bukhara, Uzbekistan. Two topics of discussion were electronics and student exchange. Dr. Case would like to do a write up as an innovation for the Sister Cities. There were over 2,000 people at the Festival where a very formal and dignified introduction of Chair, Carol Robertson-Lopez was made. She and Dr. Case were the only westerners at this event and it was televised as they introduced Santa Fe, NM, USA. A link will be shared with the committee as it becomes available.

Dr. Case spent today with students from Zambia who competed in Robotics. These 8 students were from Lusaka (capital city of Zambia) and had their airfare and expenses paid for from Intel at the rate of \$4,000 per student. They placed 4th amongst 50 teams.

Loren Komer, Sister Cities Student Representative, is arranging a SKYPE conversation with an Icheon teacher, Mr. Ji Kim, to develop journal exchanges. Lauren was also honored with a notice in the New Mexican in regards to a vocal award at the Art Song Festival. Congratulations.

Dr. Case stated that Head learner; Tony Gerlicz extended an invitation to the Mandela International Day, and however the event was cancelled.

Clara Padilla-Andrews: Shared with the committee that she has met with a friend who lives in San Miguel de Allende and will visit that city in July. The Chair recommended that Ms. Andrews meet with Arts Commission Director, Debra Garcia y Griego to have her provide an update on the status of the relationship with San Miguel de Allende. This would be a nice opportunity to re-establish discussion with their officials. It was also recommended that we ask Mayor Gonzales to send a letter to the dignitaries there; it would open the doors for Ms. Andrews to officially visit. Ms. Andrews noted that all of the officials changed this year.

Mr. Olivas reported that the Japanese festival, Kabuki was a great success. This year they had more time to do the presentation called making your own tea, and it was successful. There were people who were disappointed that there wasn't a stage presentation. Feedback included that families brought more kids this year based on past years attendance. The Chair would like to have a booth for Sister Cities next year to strengthen the visibility. Mr. Olivas noted that his involvement with Sister Cities was after he saw an article in the newspaper that talked about a Sister Cities reception and he loved having that opportunity to participate.

The Chair reported on Bukhara, Uzbekistan - she is going to be an Honorary Citizen of Bukhara. This is a prestigious appointment, thank you to the Chair for her strong relationship. This appointment came through the Uzbek office in Washington. Santa Fe and Seattle, Washington are the only two US cities associated with Uzbekistan. The Ambassador is going to come to the Folk Art Festival in July.

7. Other Items

Mayor Gonzales asked the Sister Cities Committee members to coordinate and discuss a future program and receipt of art from Prado, Spain. This exchange will strengthen the Santa Fe de la Vega, Spain sister city relationship. The digital art will be available May - October. The Mayor will continue to keep the committee informed.





- Unless you object we will occasionally run your slide show on the monitor behind our sales counter.
- We would like to be able to give your contact information out to people who are interested in your presentation or your subject matter but will keep your information private if you request it. Anyway, thanks for offering to share your experiences!
