5. Reports and Project Updates

a) Ignite

Ms. Garcia y Griego – Hitch Project which is the bicycle parking meters is moving along very well. The meters have been fabricated; the deadline for the artists to give the coordinator their drawings was last week so they are going in to fabrication of the racks. Next week Rod is going with the Artist and the Parking Division to look at all of the meters that have been identified and make sure they will work. A dedication in front of city hall is scheduled for September 6th about 5:00 pm or 6:00 pm. There were 10 in the proposal and they are actually doing 11. The other two projects are being held up in procurement, essentially waiting for a purchase order and once that is acquired the project will start. Ms. Garcia y Griego provided information on the delay in the project with the two artists; they are still under contract negotiations. There have been some questions regarding their partnership, we cannot do a 3-party contact we need a single entity and we need to be assured both artist have their stakes in the project. No action has been taken on the free wall sculpture. At the end of May – Tom left town and he knew it would sit for the summer. We will follow up on next steps when he returns and we will meet with Parks.

b) Pilot Purchase Program

Three of five sculptures have been installed: Hitch, coordinated by Niomi Fawn, Anne Russell and Christy Hengst, Earthcare by Charles Mobbs. Purchase: Proud Outlook by Jill Schiwako, Joy of Life by Milton Hebald, Colossal Hummer by Don Kennell. There are still a few things that Parks is going to do including some mulching for Colossal Hummer.

Remaining to be installed: Rock Paper Scissors by Kevin Box, waiting for a purchase order to come through, the site visit has been done at Martin Luther King Park. Installation has been agreed upon.

Untitled by Andrew Davis, we are still working with the contractor.

c) Greg Beals Donation

It went straight to the Arts Commission and it was approved as a piece in the permanent collection, it will remain in front of the Library. Further coordination will continue by Ms. Garcia y Griego.

d) Sheridan Street

Kimberly the Artist has developed a way finding feature that will go at the opposite end of the street that follows the tin mark design on all the other shelters. There is a space that will be illuminated at night and will shine through the punched tin panels. Arts Commission approved as presented, it will need to go to Historic Design for further review and approval. Staff may have recommended modifications to the design, more information to follow.

Underpass Update: They are starting to schedule the public pre-construction meetings in the next 2 weeks, it will be October before they start construction with a tentative date of October and completion in December.

6. Action Items

a) Request for Approval of Revised Monthly Meeting Schedule. AIPP proposal is to move to the last Thursday of the month. The meeting scheduled for Thanksgiving could move to the Tuesday week before. December 29th is a date that we should consider an alternative date.

Mr. Chase Daniel moved to approve the modifications of the AIPP meeting schedule, second by Mr. Muchmore, motion carried by unanimous voice vote.

7. Discussion Items

The Chair asked about the recent discussion on identifying locations for Kiosks. Ms. Garcia y Griego noted that it did come up through Todd Lovato who served on the Nightime Economy Task Force and through Randy Randall from Tourism Santa Fe. It did also come up at Arts Commission and it was in the discussion stage. No formal action.

Ms. Garcia y Griego is working to hire a temporary person to assist with the workload, long term permanent hiring is being reviewed based on job responsibilities.
