4. NEW BUSINESS/ACTION ITEMS:

a.) Discussion and Approval of CYC Subcommittees

There is data available for many of the categories already. The Commission knows the needs in the community and can start focusing in the specific areas.

A brief discussion was held about information shared at a funder's meeting. Mr. Slavin agrees it would be more effective to make things simpler for the grantee.

a.) TA Training

Ms. Sanchez reported there were around 70 reps from the CYC and Human Services Committees in attendance. The schools were not present perhaps because of the summer.

Ms. Love briefly discussed the information given was great and it was well executed. Mr. Sanchez stated the feedback was great and very informative.

Ms. Love discussed a recent meeting she had with a funder that funds her foundation. They held a discussion with all of all the grantees to discuss common goals. It was very useful and groups were mixed together. It may something to consider in the future.

Mr. Sanchez suggested that once the subcommittees meet and select their indicators that the framework be kept as a draft and used as a tool to engage interests and ideas from the grantees.

Mr. Slavin suggested working along with the providers. Mr. Sanchez briefly discussed the visits he has had with organizations and has noted some type of territorial manners. A brief discussion was held about the training and the way it was facilitated, Ms. Sanchez stated it may be a good idea to have it made into a webinar for those who couldn't attend.

b.) Summer Retreat

Mr. Chris the date is locked down in September and will be meeting with Voices for Children, Christus St. Vincent's, Appleseed, and Santa Fe Community Foundation. One added for the afternoon session is the Mijo Project with the Santa Fe Fire Department. Mr. Sanchez explained the Fire Department can respond

to the same address several times. This will allow a discussion about a social worker that works 4 hours a week to check on the residents and children which helps with other calls.

c.) Scheduled Site Visits

Ms. Sanchez announced the next four site visits, they are as follows:
