6. INFORMATION / DISCUSSION / ACTION

a. RIVER COMMISSION PRIORITIES & GOAL SETTING FOR 2017

The Chair noted that there have been changes in commission operations from the last administration to present. Former Mayor would bring forth the priorities to the River Commission and Mayor Gonzales would like for the River Commission members to bring the priorities to him and the Council. The Chair provided a document with suggested priorities for review and discussion. Protocol will be to collect input from the Commissioners to discuss short term (1 year), medium term (2-3 years) and long term (3+ years).

The Chair will also welcome collaboration from the representatives of the Santa Fe Watershed and Sierra Club present at this meeting. It was also asked that if possible to identify the resources needed for each suggested priority.

Ms. Isaacson asked if the River Commission Chair or Staff Liaison know what the priorities are from the Mayor and City Council in order to list their requests. The Chair will check with Ms. McDonald to find out if she is already working with the Mayor and Council on any listed items.

Mr. Patorni asked if the River Commissioners role are as advisors to the Mayor and Council and/or are they to make suggested policy recommendations. Mr. Hook said his recommendation was to do a 2:2, either meet with or invite 2 councilors to a meeting, which often results in a more open dialogue. It also eliminates any possibility of a quorum on either side if individual meetings are conducted. The results are positive when reaching out to the councilors for their input.

The Chair noted that another resource to attain date/information could be communicating with NMSU in some areas where their expertise could help meet the River Commission goals.
