10 **A RESOLUTION**

11 **REQUESTING THE CITY MANAGER TO DIRECT STAFF TO FACILITATE AN**  
12 **OUTDOOR DISPLAY OF CURATED REPRODUCTIONS OF SOME OF THE FINEST ART**  
13 **OF THE MUSEO DEL PRADO FROM MADRID.**

14  
15 **WHEREAS**, the Prado Museum in central Madrid is an internationally acclaimed museum  
16 housing the world's finest collections of European art; and

17 **WHEREAS**, the Prado unquestionably houses the best single collection of Spanish art Spain  
18 dating from the 12th century to the early 20th century, based on the former Spanish Royal Collection;  
19 and

20 **WHEREAS**, Santa Fe is an internationally known center for the arts; and

21 **WHEREAS**, New Mexico has a long standing relationship with Spain, including  
22 native son, Ambassador Edward L. Romero who served as Ambassador to Spain from 1998 to 2001;  
23 and

24 **WHEREAS**, Jim Long, the founder of Heritage Hotels, a New Mexico based hotel company  
25 with four hotels in Santa Fe, has served on the international board of directors of the Prado as well as

1 the board of Directors for the Spanish Colonial Arts Society; and

2 **WHEREAS**, the Prado has a desire to offer Santa Fe the opportunity for a curated exhibit of  
3 reproductions of some of the finest are of the Prado; and

4 **WHEREAS**, the outdoor display presents an opportunity for Santa Fe to highlight its  
5 relationship to the global art community.

6 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
7 **CITY OF SANTA FE** that the City Manager directs staff to facilitate an outdoor display in Santa Fe  
8 from May through October, 2017.

9 **BE IT FURTHER RESOLVED** that staff takes the following into consideration in support  
10 of the project:


- 11 1. Location of exhibit;
- 12 2. Cost of project;
- 13 3. Funding source; and
- 14 4. Execution plan.

15 **BE IT FURTHER RESOLVED** that the display shall be part of a larger marketing effort  
16 highlighting art of a global reach at local arts institutions.


17 **BE IT FURTHER RESOLVED** that upon adoption of this resolution, staff shall immediately
