Councilor Villarreal appreciated this and wanted the project to continue but it shouldn't be called a pilot project any longer. She provided minor changes in a handout (attached as Exhibit 1).

Chair Ives raised a point of order for the notice issue on the caption.

Mr. Correia said it was intended to run six months and has reached that milestone. Even though not used as much as we expected, it is successful and should be made permanent.

Chair Ives said this is a fair reading of the caption to suggest changing it from pilot to permanent circumstance. Do we want to make it permanent or just extend as pilot until Mr. Correia brings back the broader parking changes?

Councilor Villarreal thought it would make more sense to extend the pilot strategy.

Mr. Correia agreed.

Councilor Villarreal moved to approve with the amendments. Councilor Rivera seconded the motion and it passed by unanimous voice vote.

Councilor Rivera pointed out that we already have policies in place for art objects in public places but with an art memorial for park or trail head, he asked if they mesh together or if there is conflict between the two.

Mr. Thompson said they would defer to the Arts Commission and work out the logistics to protect the piece. It is really not about art but about trees, benches, shrubs, etc.

Councilor Rivera mentioned the large bird in a park in his district.

Mr. Thompson confirmed that was through Arts Commission and is art in public places.

Chair Ives said some solution may be in the proposed guidelines. He quoted section 1.12. It is considered on a case-by-case in consultation with PARC and City Staff. Art work could be referenced by that for consideration. The language is broad enough to capture the other guidelines.

Councilor Rivera said "probably so." He didn't know if Ms. Garcia has any comments.

Mr. Thompson said on page 1 of the resolution line 18, it mentions the policies for real property and locating art. He agreed to meet with Debra to make sure we are aligned properly.

Councilor Rivera asked Mr. Guillen about typos.

Mr. Guillen agreed to correct the typos.

Councilor Rivera moved to approve the request. Councilor Villarreal seconded the motion and it passed by unanimous voice vote.

11. MATTERS FROM STAFF

Chair Ives hoped they would have the master list of projects for the next budget cycle and spending CIP money to look at all the needs across the city. It is not insignificant and better if considered by all together.

4.	On page 1, lines 23-24 <i>delete</i> ", attracting two vehicles on the first day, and zero vehicles on the second day" and <i>insert</i> in lieu thereof "due to delays in communication about this option with the affected parties"
5.	On page 2, line 5 after "mornings" insert ", and work with the Santa Fe Farmers' Market Institute to communicate this option with the vendors of the Farmers' Market"
