**AN ORDINANCE**

**AMENDING SECTION 24-2.6 SFCC 1987 TO ADD A TRUCK AND OTHER LARGE  
VEHICLES TRAFFIC RESTRICTION ON DEFOURI STREET.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:**

**Section 1. Section 24-2.6 SFCC 1987 (being Ord. #2006-14, §26, as amended) is  
amended to read:**

**24-2.6 Restricted Traffic.**

A. Trucks, truck trailers and other large vehicles with a gross vehicle weight of five (5)  
tons or more are prohibited from traveling on the following streets except as set forth in paragraphs B.  
and C. below:

(1) Agua Fria Street, between Siler Road and Guadalupe Street except those  
vehicles making pickups or deliveries to addresses on adjacent dead end streets;

(2) Alamo Drive;

(3) Apache Street;

(4) Armenta Street;

- 1 (5) Arroyo Chamiso, Botulph and beginning at the eastern boundary of Zia  
2 Road;
- 3 (6) Calle Angelina;
- 4 (7) Calle Atajo;
- 5 (8) Calle La Resolana;
- 6 (9) Calle Sotero;
- 7 (10) Camino Carlos Rael between West Alameda Street and the city limits;
- 8 (11) Camino Carlos Rey between Calle de Oriente Norte and Zia Road;
- 9 (12) Camino Consuelo;
- 10 (13) Camino de las Crucitas;
- 11 (14) Camino Encantado;
- 12 (15) Camino Lejo between Old Pecos Trail and Old Santa Fe Trail;
- 13 (16) Canyon Road;
- 14 (17) Catron Street;
- 15 (18) Circle Drive between Bishops Lodge Road and Camino Encantado;
- 16 (19) DeFouri Street;
- 17 (~~[19]~~20) East De Vargas Street between Paseo de Peralta and Canyon Road;

- 19 (~~[21]~~22) Espinacitas Street between St. Michael's Drive and Jay Street;

- 22 (~~[24]~~25) Galisteo Street between Paseo de Peralta and St. Michael's Drive;
- 23 (~~[25]~~26) Gonzales Road, between East Alameda and Hyde Park Road;
- 24 (~~[26]~~27) Gonzales Road, north of Hyde Park Road;

3                   (a)       From just west of Chamisa Path Road to east of Dancing Ground  
4 Street; and

5                   (b)       From west of Nizhoni Drive to the terminus of Governor Miles Road  
6 located east of Camino Carlos Rey.

10 ([53]54) West Alameda Street west of the landfill road to the city limits  
11 except those vehicles making pickups or deliveries to addresses on adjacent dead end streets;

13 ([54]55) Zia Road.

14 B. Trucks, truck trailers and other large vehicles with a gross vehicle weight of  
15 five (5) tons are not prohibited provided the following are met:

16 (1) The vehicle is making pick-up and deliveries or providing services to  
17 addresses on the specific streets or to addresses on adjacent streets served only by that  
18 specific street(s); or

19 (2) The vehicle is traveling to or from such addresses for the purposes of  
20 locating permanently or temporarily at such addresses provided they are in compliance with  
21 any other applicable city code.

22 C. Authorized emergency vehicles; any government or utility maintenance, service and  
23 transportation vehicles; and school buses, with a gross vehicle weight of five (5) tons or more, are  
24 permitted to travel on the streets specified above.
