Brief History: In the past we have had various organizations ask to allow them to provide alcohol in city parks. We have not had the specifics in the bill. The proposed ordinance will identify the best practices and specifications. Two things in the regulations, Page 7 in the bill correlates the size of pour with the amount of alcohol and amount permitted for consumption. As it pertains to public safety it specifies the threshold and the importance of the ordinance. Councilor Rivera also noted the amendment from Public Works that no alcoholic beverages in excess of 15% ABV are permitted.

Mr. Harris recommends approval of the ordinance updating and reforming the permitted locations and regulations for the sale and consumption of alcohol on city property; and revising the provisions for sale and consumption of alcohol on city property with the amendment from Public Works that no alcoholic beverages in excess of 15% ABV are permitted, second by Mr. Mizrahi, motion carried by unanimous voice vote.

Presentation by Captain Lamb – Snapshot for the entire year of 2016 Crashes (Exhibit A). Handouts to the Public Safety Committee Members to follow.

Captain Lamb will also provide information on causes of accidents as well as on DWI statistics.

Mr. Mizrahi asked, where are these statistics kept? Captain Lamb stated that they come from the S100 and SFPD/RECC share the data.

Councilor Rivera asked if there was any way to break down the statistics by age? This will be researched and reported back to the Public Safety Committee members.

Mr. Harris asked if they could report on distractive driving and would that be in the report for the accidents. Captain Lamb said the state is very specific on the items they report on.

Dr. Owen Lewis asked what Captain Lamb's recommendations are. He said he would like to bring back the STOP Program and more officers.

Who controls the speed monitors? Captain Lamb said they have two monitors strategically placed and they do document the results. They are placed based on need and heavy traffic areas.

Councilor Harris: Addressed the Public Safety Committee and stated that he would like to work on bringing the STOP Program back. Councilor Harris has also worked with Public Works to review the data they have collected. In discussion with Captain Lamb it was learned that this data does not reach SFPD for about 2-years, and this is a NMDOT process.

Mr. John Romero, Traffic Engineer

E – Enforcement, E-Engineering, E-Education

All three are very important and when you do them all it improves the protection on our roads. Mr. Romero said they work closely with the police department and share data. There are 3-years of crash data available from the Police Department and also confirmed that it is not as easy to secure up-to-date data from NMDOT. Mr. Romero stated that time permitting, he would like to have the Traffic Engineering office staff and department get more involved to cohesively work with the SFPD in reviewing data for safety. The Engineering Department also worked and evaluated the crash data and generated a list by intersections. We tried to hit the top ten crash events and we evaluated the reasons for the accident. One main area was Agua Fria/Cottonwood; we were able to determine what the problem was and we came out with a counter measure. We were able to secure highway funding to do a very intense program. We have also put a yellow back on signal heads to eliminate accidents. We would like to continue to improve and identify intersections through engineering where we can make a difference.

The Chair asked if the Traffic Engineer could come forward with the list of the top 10 intersections and let the Public Safety Committee know what has been done to correct the matter. Mr. Romero added that when an evaluation is done there is crash prevention data that can be used and they can project on national average. The data collection takes a lot of manpower to come up with these reports. The most recent 3-years of data from NMDOT is the same data. It may be more how we present the information and value of the crashes. We know what factors we know we can control and there are others that are out of our control. The information that was gathered by the interns was a valuable process. Mr. Romero said that another valuable piece of information was to discover the crash locations that may not have ever been pin pointed in the past.

Eric Johnson asked if Captain Lamb could provide the private property statistics as well. Captain Lamb noted that private property reports are not provided to NMDOT.

The Chair and Public Safety Committee members expressed their thanks for the report and request by Councilor Harris.

B. Approval of BAR to accept new grand funding and purchase new SCBA Air Compressors and Filling Stations. 2017 NMFMO Grant Award. (Chief Litzenberg)

Chief Litzenberg – The City of Santa Fe Fire Department would like approval to accept a 2-17 Fire Protection Grant Fund award sponsored by the NM State Fire Marshall's office. The grant was awarded for the SFFD to purchase a new SCBA air compression and filling stations. The cost of the new pieces of equipment will be \$126,282.21. With the acceptance of the grant award the SFFD would like permission to:

- Increase our operating budget (BAR) by the amount of the award, \$100,000.00
- Purchase the SCBA air compressors and filling stations @ \$126,252.21.

The balance of the funds (\$26,282.21) to meet the requirements of the match criteria will come from the Department's State Fire Protection Fund.

Mr. Arellano asked what the tanks are used for? Chief Litzenberg stated that they are used for breathing/air quality and they cannot be used for anything other than this purpose.

The Chair asked if any actions at the state legislature would affect this funding. Chief Litzenberg said that it will not affect the amount of \$100,000 as this amount has been allocated but it will affect a grant application for the next 2 years.

Mr. Mizrahi moved to approve the BAR to accept new grand funding and purchase new SCBA Air Compressors and Filling Stations and the 2017 NMFMO Grant Award, second by Mr. Harris, motion carried by unanimous voice vote.

C. Donation of Fire Department Apparatus – Two (2) Fire Engines

The City of Santa Fe Fire Department respectfully requests permission to donate two (2) Type 1 Fire Engines to the San Miguel County Fire Division here in New Mexico. Both units are 1998 Pierce Sabers, 18 years old and are ready to be "retired" and replaced. The process is to go through the Fire Marshall who identifies what communities would need fire equipment.

Mr. Harris moved to approve the purchase of a new one tone service truck for its fleet section as well as a new staff/command vehicle, second by Mr. Mizrahi, motion carried by unanimous voice vote.

E. Approval for the purchase of two (2) mobile video system trailers from cash balances in the property tax fund. Deputy Chief Andrew Padilla

With the recent thefts in different areas of the city, the need and use of these (2) mobile video system trailers will be extremely helpful. There is a high area identified on Canyon Road and the downtown area.

Chief Gallagher said that in addition, the trailers will be used at large-scale special events that occur throughout the year in the city (i.e., Zozobra, Fiestas, Farolito Walk, etc.). In this role, the trailers will serve as a valuable force multiplier, aid in the detection and prevention of crime and enhance the overall security posture of said events.

Lt. Paul Joye provided information on the use of some of the cameras that at different parks. The quality of the camera solution doesn't provide clear information.

The goal is to have one location of monitoring from the police station. The trailers are solar powered. Once the system is up and running data retention will be evaluated once the program is more specific on attributes. There is an anti-level monitoring of the trailer itself that would notify the Santa Fe Police Department if there is an attempt to tip over the trailer.

Chief Johnson asked if for live events, the reports could be done in real time? Deputy Chief Padilla said that is correct.

Chief Johnson moved to approve the purchase of 2 mobile video system trailers from cash balances in the Property Tax Fund, second by Mr. Arellano, motion carried by unanimous voice vote.

Deputy Chief Padilla asked for approval for the purchase of 40 laptops and 6 tablets to replace 10-year old units that are used by the Operations Division and the Traffic Unit. The current laptops and tablets are currently operating on Windows XP and, as a result, have experienced viruses and multiple other computer attacks. The replacement laptops and tablets will run on Windows 7 and will allow access to NCIC and other programs that are needed by field personnel to perform their duties. In the past purchases have been made with federal funding and grants. SFPD has now included this purchase as an in-house budget item.

The computers that have been identified for replacement are 10 years old. IT Governance committee has reviewed this request.

Mr. Mizrahi moved to approve the purchase of 46 replacement in-car computers from cash balances in the Property Tax Fund, second by Chief Johnson, motion carried by unanimous voice vote.

Announced the Retirement of Captain Jerome Sanchez, 20 years of service. Chief Gallagher complimented Captain Sanchez and talked about successful arrests and service that the team under Captain Sanchez were involved in.

\$34,000 grant from Firehouse Subs allowed for purchase of the AED units.

Chief Salbidrez provided the Holiday Patrol Report
Stocking Operations – Patrol Division - \$24,000 for the operation and it only spent \$18,000, starting on black Friday and ended December 31, 2016. Hard copy report provided to the committee members to follow as Chief Salbidrez presented.

One crime that is increasing is simple batteries. We are currently at 402 aggravated batteries for 2016 and it is believed that annexation is impacting us.

Power Point Presentation (Exhibit B) – 7 Majors that are tracked with the mapping. Homicide, Robbery, Burglary-Commercial, Burglary Residential, Burglary-Auto, Breaking and Entering, Motor Vehicle Theft. Auto Burglaries had the most increase.

Burglary Task Force: Not active. Chief Johnson said it might be worth reactivating.

Motor Vehicle Thefts: Bait Cars – they can be deployed at the full extent per legal review.

Mr. Arellano: Bicycle Thefts – are car thefts leading back to a cartel? Chief Gallagher said presently he doesn't see a tie since the one noted in the past has been resolved. We are recovering vehicles, which is an indication that it is not cartel related.

Mr. Arellano asked, what are we looking at in Santa Fe as far as cartel organization. Chief Salbidrez said there is always a claim to fame in drug activity, it hasn't led to severe violence, there is a connection but there isn't a distinctive presence in the city of Santa Fe.

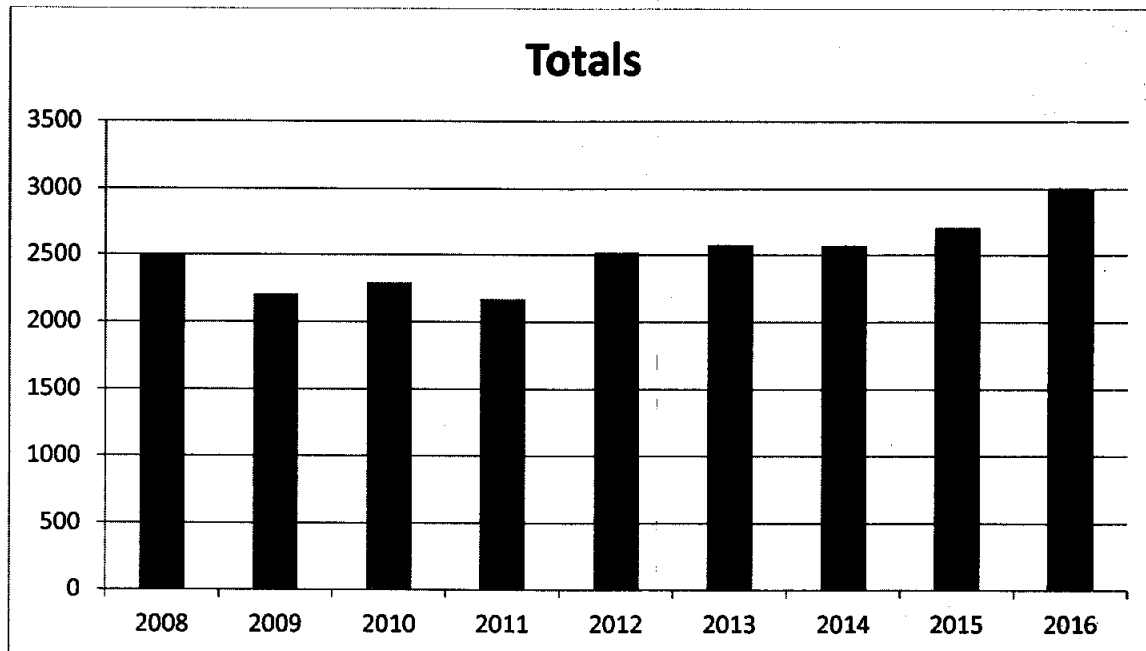
Police Crash statistics:

2016 has shown the highest rate of crashes in the past eight years despite the use of technology and proactive traffic enforcement efforts. The Santa Fe Police Traffic Unit has four officers assigned and a supervisor. Often these full time officers will be called to other duties and may work several hours to complete crash with injuries investigations. Similarly, the number of serious crashes has increased slightly. In the past three years, traffic crashes have been most notable on a few days of the week. In 2016, the number of total crashes typically span the entire work week of Monday through Friday, decreasing slightly on the weekends. Crashes can be accounted for by driver speed, driver distraction (texting, rear end collisions, right of way, etc.), and Red Light violations. Crashes coincided with where the vans were typically placed. There are not many crashes, if any attributed to roadway design or traffic signal functions.

Injury crashes are classified on reports when there is a complaint of injury, the officer calls for medical assistance or the medical need is apparent. Therefore, in review of crash reports, it is near impossible to determine if the crash attributed to the injury.

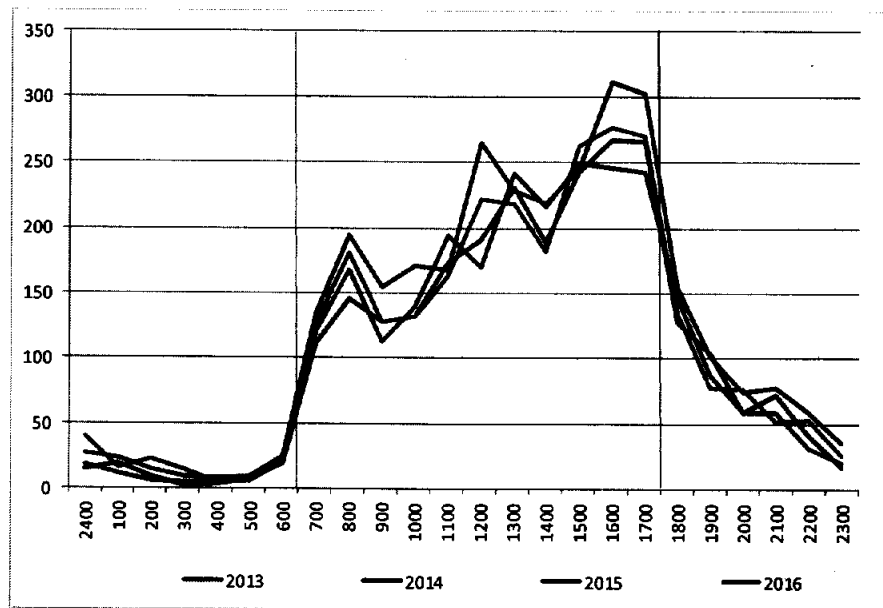


The light red area indicates the time when STOP was active. 2016 shows a significant increase in total crashes by 300.

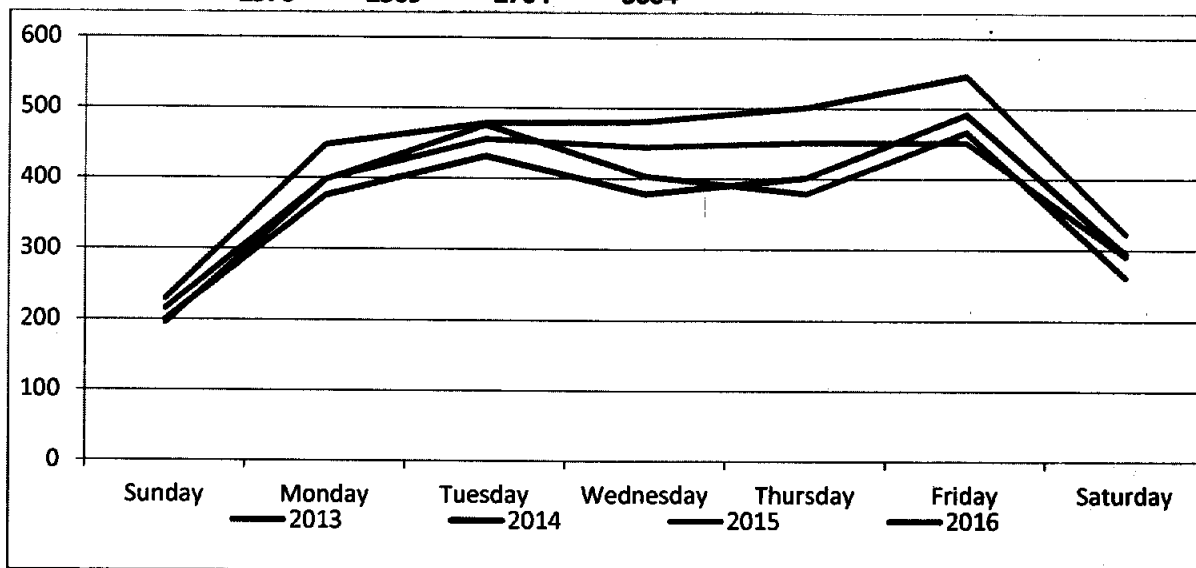

Days of the week for total crashes shows a “rounding” of the week in 2016:

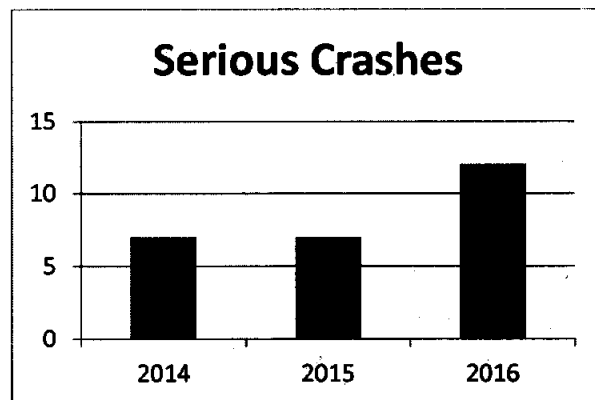

Fatal and Great Bodily Harm crashes:

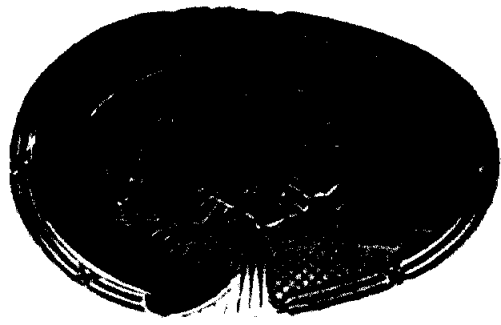
In 2014, police responded to 7 serious crashes. 2015 remained the same at seven. In 2016, police have responded to twelve (12) serious crashes. A 50% increase.

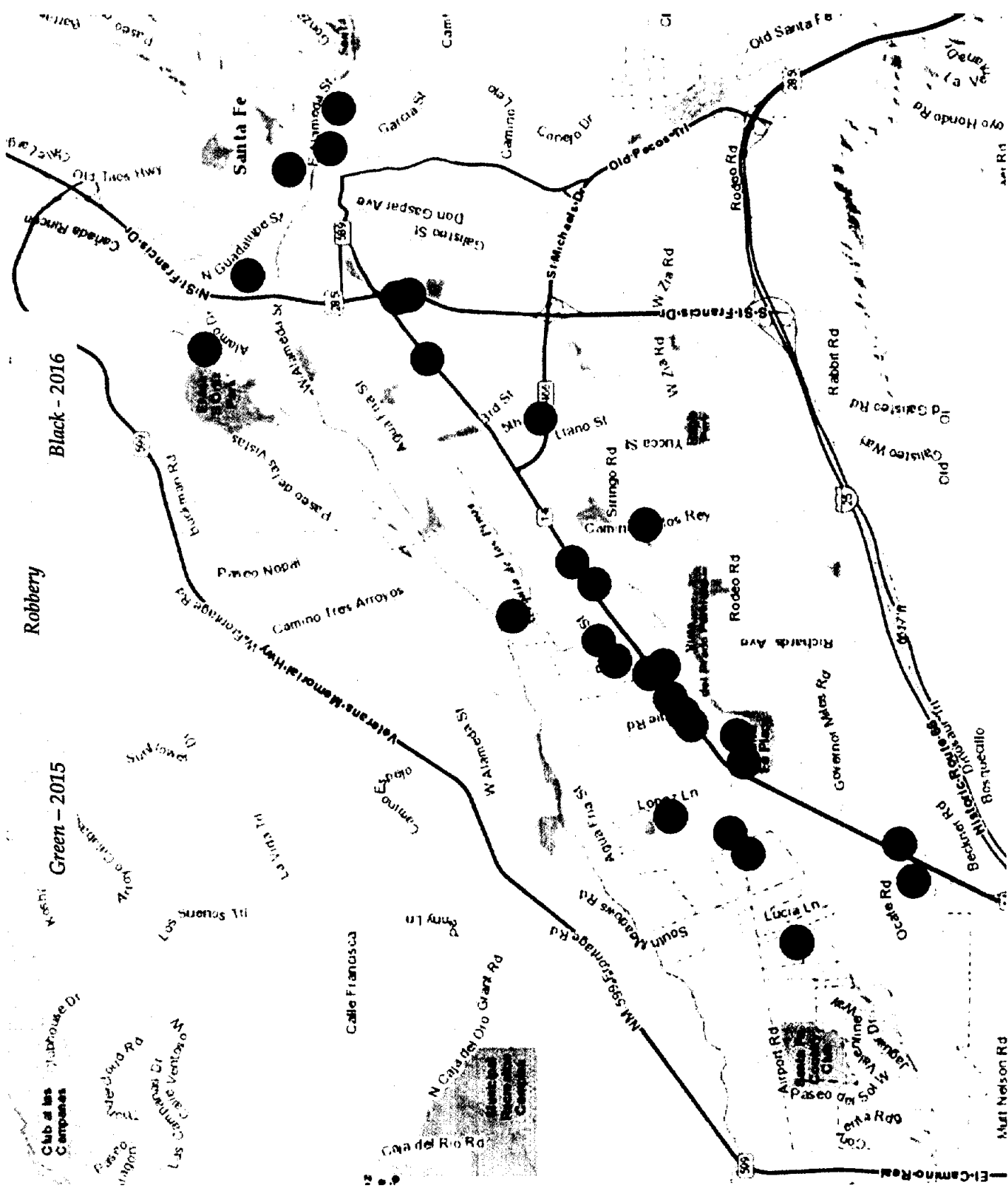
