GIFT REPORTING FORM FOR PUBLIC OFFICIALS §1-7.7A(1)(a) SFCC 1987

If relevant to the performance of his or her official duties, members of the governing body, the city manager, the city attorney, or the city clerk may receive an occasional non-pecuniary gift not to exceed two hundred and fifty dollars (\$250.00); however, such person shall report the gift, its value and the provider to the city clerk's office within ten (10) days of receipt of the gift, and such gift report shall be immediately posted by the city clerk, on the city's website.
