## 4. INFORMATION/DISCUSSION/ACTION:

## A. INTRODUCTION TO MAYOR ALAN WEBBER

## • HISTORY OF THE SANTA FE RIVER COMMISSION

Chair Isaacson introduced the Mayor and Ms. Wheeler, Director of Public Works.

Ms. Wheeler introduced herself and thanked the Commission for their work on the River the sustainability plan. Ms. Wheeler is looking forward to learning more about what they do. Mayor Webber states he enjoys keeping good people and also adding new people to keep the quality of life in Santa Fe.

Chair Isaacson introduced Mr. Jacobi who presented a power point with a short introduction on the History of the Santa Fe River Commission. (see attached)

Mr. Jacobi suggested the reading of "The Return to the River" book and a video on protecting the Santa Fe River and Upper Watershed and suggested anyone interested view them.

Mr. Jacobi states the Commission started in 1985 and again in 1995. In 2005 there were Community groups that met to discuss the concerns about the water in the River. Former Mayor Coss came into office at and helped create a Resolution written re-establishing the Santa Fe River Commission in 2007. In 2006 the Santa Fe River Fund was established.

Mr. Jacobi discussed the Watershed Coordinators that work closely with the Commission throughout the years.

Mr. Jacobi explained the important milestones that the Commission has seen. Mr. Jacobi presented some slides with photos that showed the work on the Living River Project.

Chair Isaacson asked the Commissioners to introduce themselves and give a brief background for the Mayor.

Mr. Buchser spoke on the larger idea of the River in the City. Mr. Buchser explained the structure of the Commission and the voting system of the Commission.

Mr. Bucher discussed some issues of snow pack and the timing of the release from the preserve. Mr. Buchser discussed the channel that serves the acequias for deliveries.

Mr. Buchser states there are needs from the River, the Acequias and the City. Mr. Buchser discussed his concern with nitrates and is glad to see the City cares about enforcing pet owners to clean up after their pets. Mr. Buchser discussed the water treatment that goes down stream and waters parks.

Mr. Buchser explained the complexity of the aquifers. Mr. Bucsher states the storm water offers the opportunity to keep a pool of water under the City should they need to treat it. The Buckman Direct Diversion's design didn't work as well as they'd hoped. He doesn't have a current assessment on it. The San Juan Chama changes with snow pack.

Mr. Buchser states there was a challenge with the River preserve. More data was needed. The City and County working together on many things now and that is great.

Mr. Buchser states there is concern with the Santa Fe River Traditional Communities, they meet and benefit from the output of waste water treatment plant, and it's a source for irrigating in the summer. Not sure if it can be addressed but it is a concern.

Commissioner Hansen worked with Mr. Puglisi regarding the SM4 Permit. The City, County and State NMDOT will work together on this plan. (See attachment)

Commissioner Hansen explained the current project and the work on the permit. There were 8 portions to it and concerns to complete the permit. Commissioner Hansen explained the recommendations for the plan.

Mr. Patorni states the education program with the Watershed Association has trips to show the reservoirs. The program teaches youth about the system, most of the youth have never seen that much water.

Mr. Patorni states the American River Network makes a list of most endangered Rivers in 2007 Santa Fe River was #1 on that list. The Santa Fe River has come a long way.

## GOALS OF THE SANTA FE RIVER COMMISSION

Chair Isaacson presented the goals that Mr. Bucsher started when he was Chair of the Commission. It is a good overview of where they are interested in addressing issues.

Chair Isaacson explained they would like the Commission to work on both reaches of the River the lower and upper. They hope to work on the water quality issues, find funding for more trash cans, the scoop the poop and perhaps some portable toilets for the homeless population.

Chair Isaacson states the goals act as a sounding board for the Stormwater management plan, advice on technical input on the master plan and outreach to the community. There are youths and citizens that vote and they want to introduce people to the River.

They would like to increase community use of the River. The River Trail increase the walkability. Updating or addresses a plan to remove goatheads would benefit the bike community and encourage more use of that trail.

Chair Isaacson stated they hope to provide guidance on the Santa Fe Living River Fund.

Mayor Webber appreciates the briefing of the History and the goals of the Commission.

Commissioner Hansen discussed some ideas on how the City and County can collaborate.

Mr. Pierpont discussed how the River is underutilized. The River can be an inspiring place for people in the City. The more water in the River, makes for better outdoor economy.

Commissioner Hansen mentioned the importance of restoring and keeping the culture of the acequias.

Mr. Jacobi discussed there is no way to get to the river without having to cross traffic. The access was not well planned. Ms. Doremus agrees there is no access, if you live along the River you cannot access it.

Commissioner Hansen states there are some bids on the restoration of the River Trail. The County is currently trying to negotiate it. Commissioner Hansen states the new section of the River trail could have a possible access point.

Mayor Webber briefly discussed water policy and the water scarcity.

Ms. Doremus discussed the wells in years past and how scarce the water was at one point.

Mayor Webber thanked the Commission for all of the presentations and information.

## **B. ACTION ITEM: APPROVAL OF 2019 CALENDAR**

Ms. McDonald presented the 2019 Commission meeting schedule. (see attached)

Mr. Puglisi was only on the agenda for questions. Mr. Puglisi states in 2013 the standards were implemented by the State. Mr. Jacobi was instrumental in the work it took to get the River classified.

Mr. Puglisi states that this Commission has a lot of expertise in several areas.











## RIVER RENEWAL Santa Fe River Trail and Channel Restoration




















- 1. The City, County, and NM Department of Transportation will be issued a new Small Municipal Separate Storm Sewer Systems (Small MS4) Permit under the National Pollutant Discharge Elimination System (NPDES) Permit Program. This permit will require instream monitoring and sampling, the implementation of Best Management Practices to reduce and eventually eliminate river impairment, as well as the implementation of necessary ordinances to prevent the discharge of pollutants to receiving waters such as the Santa Fe River.
- 2. The City and County will need to fully implement, and comply with, this permit and its requirements. This may require the identification and organization of programs and resources sufficient to address the regulatory drivers in the permit. This may impact staffing levels, monitoring costs, public outreach programs, infrastructure development, ordinances and other factors. Many cities/counties such as Albuquerque, Bernalillo County, Rio Rancho, Las Cruces have specific programs which address storm water and its environmental impacts. How this program will be organized in Santa Fe should be discussed and decided upon by City and County leaders. Owners/operators of regulated municipal separate storm sewer systems (MS4s) are required to develop, implement, and enforce a stormwater management program (SWMP). The focus of the SWMP is to describe how the MS4 will reduce the discharge of pollutants from its sewer system and addresses these program areas:
  - Construction Site Runoff Control
  - Illicit Discharge Detection and Elimination
  - Pollution Prevention/Good Housekeeping
  - Post-Construction Runoff Control
  - Public Education and Outreach
  - Public Involvement/Participation
  - Program Effectiveness
  - Total Maximum Daily Loads
- 3. Ecoli, PCB, and Aluminum impairment in the "metropolitan area" segments of the river. The NMED has listed these segments as impaired for these constituents in their 303(d) list and have established a Total Maximum Daily Load (TMDL) specifically for Ecoli contamination. Stormwater and erosion of soils have been named as contributing factors to this impairment. The Ecoli TMDL and subsequent TMDLs for the other pollutants will greatly affect the MS4 permit implementation by requiring the City to implement BMPs and practices to reduce the loading of these pollutants to the river. These could include improvements such as rain gardens, infiltration basins, vegetated buffers, etc. as well as steps to reduce the runoff of pollutants to the river such as a pet waste (Pooper Scooper) ordinance, ordinances to prevent the discharge of non-stormwater flows to stormwater conveyances, and public education/outreach efforts.
- 4. **Nutrient (Nitrogen and Phosphorous) impairment of lower stretch.** The Santa Fe River below the City's wastewater treatment plant has been found to be impaired even though the City is currently meeting the permit limits of its NPDES permit for Total Nitrogen and Total Phosphorous. These limits are some of the most stringent in the State excepting the limits imposed on the Village of Ruidoso for its discharge into the Rio Hondo. This will result in the

future issuance of stricter permit limits/permit requirements, including those in the MS4 permit, for the point sources such as stormwater and wastewater effluent discharges to the river.

- 5. The Living River Ordinance was intended for the maintenance of the ecological, social and cultural significance of the river, as well as to provide for the presence of flow in the river. Unfortunately, recent drought years and weather patterns have dramatically affected the availability and volume of water which can be utilized for Living River flows and other obligations such as irrigation releases to the acequias. Living River Flows, when available, can be utilized to maintain the natural hydrology and ecology of the river to the maximum extent possible through planning, continued coordination, and adaptation towards real-time water availability.
- 6. River restoration activities. River restoration and enhancement activities/projects can be implemented not only to control erosion, stabilize channels, and provide additional recreational opportunities, but also to prevent the flow of pollutants to the river from runoff and storm water discharges. They should also provide for the retention of storm flows in a manner which will enhance aquifer recharge, bank storage and ecological/hydrological function. Natural channel design techniques should be implemented wherever feasible on the river, stormwater conveyances such as arroyos and acequias. Furthermore, the use of acequias as storm water conveyances needs to be addressed in a holistic and safe manner which serves Acequia parsiantes as well as the citizens of Santa Fe, wherever possible.
- 7. .Stormwater flows/runoff. Stormwater runoff has been implicated in the current impairment of the Santa Fe River with respect to the maintenance of water quality standards and the designated-use classifications of the river. This is due to the transport of pollutants from streets, roads, commercial facilities, agriculture, etc. by the stormwater which flows to the river, as well as the use of stormwater conveyance to transport non-stormwater discharges. However, stormwater can also be managed and treated as a resource rather than a nuisance. The new Small MS4 Permit encourages the management of stormwater and the "stormwater system" in a manner which not only addresses its capacity to transport pollutants and cause erosion, but maximizes it use for the benefits of river/arroyo restoration, ecological enhancement, recreation, aquifer recharge, etc.
- 8. Ground Water Contamination in the Aquifer. Several sites of soil and groundwater contamination have been identified by the City of Santa Fe in concert with the New Mexico Environment Department. The City of Santa Fe continues to address and hasten investigations of soil and ground water contamination in the aquifer fed by the river, and flows to the river through soil and groundwater transport. Sites include the "Downtown Perchlorethylene (PCE) Plume", the PNM Santa Fe Generating Station (Baca Street Wellsite), the South College Plaza PCE site, and the County Courthouse groundwater site.

## Recommendations

The City, County, and New Mexico Department of Transportation (NMDOT) could evaluate their respective storm water infrastructure and provide for structures and projects which safely convey stormwater flows, as well as provide for ecological and beneficial uses of stormwater such as aquifer recharge. Natural channel design techniques could be implemented wherever feasible on the river and stormwater conveyances, such as arroyos and acequias. These strategies could provide for the retention of storm flows in a manner which will enhance aquifer recharge and bank storage.

The use of arroyos and acequias as storm water conveyances and storm water "infrastructure" needs to be addressed in a holistic and safe manner which serves Acequia parsiantes, as well as other citizens of Santa Fe, wherever possible.

The City, County and NMDOT could provide public outreach and promote public responsibility in reducing the prevalence of surface water contamination in the Santa Fe River, and subsequent impairment of its designated uses, due to the runoff of pollutants from city streets, trails, roadways, parks, and other land areas within the metropolitan area of Santa Fe.

The City, County, and NMDOT may want to consider stormwater management alternatives such as in-channel/off-channel and stormwater detention and infiltration basins, wetlands and bank storage projects to enhance infiltration of stormwater and reduce its erosive capacity.

The City, County and NMDOT could proactively identify organizational and programmatic strategies and plans to identify and dedicate the financial and human resources necessary to implement, and comply, with the provisions of the Small MS4 Permit, which will be issued to these organizations. A draft permit has been developed by the USEPA. Final issuance of this permit is expected soon.

The City, County, and NMDOT could implement actions to evaluate and further their "internal compliance" with the new Small MS4 permit through the development and implementation of Best Management Practices (BMPs) and stormwater controls at municipal, county and state buildings and facilities.

The City, County, and NMDOT could explore new opportunities for collaboration and the furthering of joint partnerships in the management of stormwater and the protection of water quality in the Santa Fe River. The feasibility of regional partnerships and "authorities" for the management and use of stormwater (such as the Albuquerque Metropolitan Arroyo Flood Control Authority and Southern Sandoval County Flood Control Authority) could be investigated.

City/State/private partnerships can be fostered to address soil, groundwater and surface water contamination at sites around the City and County (i.e., brownfields projects and voluntary remediation actions). Federal and State Brownfields and private remedial action funding sources could be pursued to promote cleanup and redevelopment of contaminated sites wherever possible (The Environmental Protection Agency (EPA) defines a brownfield as "real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant".)

The City and County should further pursue the development of a watershed based plan (WBP) for the protection of surface water quality in the Santa Fe River, in partnership with the New Mexico Environment Department's Surface Water Quality Bureau. The development of this plan could include extensive input/participation from public and private stakeholders.
