1. CALL TO ORDER

The meeting of the Santa Fe MPO Technical Coordinating Committee was called to order by Keith Wilson, Chair, at 1:30 pm, on Monday, April 22, 2019, at the City of Santa Fe Offices @ Market Station, 500 Market Street, Suite 200, Santa Fe, New Mexico.

2. ROLL CALL

3. APPROVAL OF AGENDA

MOTION A motion was made by Mr. Berke, seconded by Mr. Romero, to approve the agenda as presented.

VOTE The motion passed unanimously by voice vote.

4. APPROVAL OF MINUTES FEBRUARY 25, 2019

MOTION A motion was made by Mr. Berke, seconded by Mr. Romero, to approve the minutes as presented.

VOTE The motion passed unanimously by voice vote.

5. COMMUNICATIONS FROM THE PUBLIC

None.

6. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

A. AMENDMENT 7 TO THE 2018-2023 TIP; RELEASE FOR 15 DAY PUBLIC REVIEW

Mr. Aune stated that to date he has not received any amendments.

B. TRANSPORTATION IMPROVEMENT PROGRAM (TIP 2020-2025) PROJECT REVIEW, RANKING AND RELEASE FOR 30 DAY PUBLIC REVIEW

Mr. Aune reviewed the information on this item which was included in the meeting packet.

Chair Wilson said all we are doing today is reviewing projects submitted for consideration. If they are approved they go to DOT and by the 20th we will have draft TIP for review.

Mr. Aune said correct. He did have an email conversation with Mr. Quintana regarding the estimated availability of funding. We will get together on that later this week. He, if the Committee accepts this, will do a draft for consideration.

Mr. Clavio said the three projects before you are projects Santa Fe County has identified as important and were discussed with the MPO previously. They are all ranked in the Metropolitan Transportation Plan. What is unique is they all help the multimodal aspect of transportation. We are looking to expand the existing roads to allow for bicycle and walking lanes. This district is a growing area of Santa Fe County. Facilities of importance are located there. We want to provide access without a car and this is a step in that direction. He reviewed the information on these projects included in the packet.

Chair Wilson asked are you requesting Federal funds for the Avenida Del Sur extension.

- Mr. Clavio said no.
- Mr. Gomez said we have County funding for the preliminary engineering project, but not for construction and design yet.
 - Mr. Clavio said the breakdowns for funding are in the packet.

Chair Wilson said the MTP is fiscally constrained by best estimates of funding. When we get to the TIP we have to have funding identified and attached to the proposal. Only the projects with funding associated with them can be added to the TIP. His understanding is you are bringing these forward to request Federal funds for them. The preliminary engineering for Avenida Del Sur can be added now because you have funding for it.

- Mr. Gomez asked projects two and three do not have identified funding do they.
- Mr. Clavio said not at present.
- Mr. Gomez said so we can't submit them.

Chair Wilson said you can submit them and Eric and Dave will look at the available funding for consideration of Federal funding.

Mr. Aune said that is accurate. He knows in the past the County has looked at projects and tried to avoid Federal funding. At this juncture the DOT is not adding any projects so it is a bit of a leg up for the County to be considered. We can talk to Mr. Quintana about Federal funds that may be available and then communicate back to you with options.

Mr. Romero said his understanding is the State is going to come up with what funds are available from the Legislature for projects and we will see what we have.

Chair Wilson said this call for projects is primarily for the Federal highway system. Other programs have separate funding cycles. Part of the process is to check to see if these are eligible for block grants or other funds.

Mr. Romero asked for those types of funds we submit a project to be considered for the funds

Chair Wilson said you do a PIF and if they say you are good to go you do a PFF at that time.

Ms. Krueger said that is how you usually do it. The next cycle is for next year. The step by step process is on the NMDOT website.

Chair Wilson said he does not see any harm in recognizing these to be considered for inclusion in the 20-25 TIP. Make sure you are following all the Federal requirements in case you are awarded Federal funds so you don't have to double back. We can make a recommendation or if the County wants to withdraw we can do that.

MOTION A motion was made by Mr. Kavanaugh, seconded by Mr. Clavio, to include the County projects for consideration for Federal funding.

Chair Wilson said we can work with Erick on the funds you have identified for Avenida Del Sur.

Mr. Gomez said it is doubtful we would want to take Federal funding based on the experiences we have had in the past.

Mr. Aune said he has reviewed the study that NMDOT does including the scoring process. It is a multi stage process for a recommendation.

Chair Wilson said Phase A is all alternatives. Phase B is a more indepth review for the environmental phase.

Mr. Gomez said in order to get the Federal funding we have to go through that process including a location study.

Mr. Clavio said two thirds of the road already exists. It is just connecting the dots. The right of way already exists.

Mr. Romero said you have to go through the location study procedures no matter what to get Federal funding.

Chair Wilson said if the County has no intention of accepting Federal funds then there is no need to move forward for inclusion in the TIP. Once you identify your funds you can bring them forward and get added automatically. By us moving them forward for consideration the DOT may say yes and give you funds. If you are not going to accept that there is no reason to move forward.

Mr. Clavio said he submitted this because he heard in a previous meeting that you thought they were regionally significant. It was as a courtesy to the MPO constituents.

Mr. Kavanaugh withdrew his motion.

Mr. Clavio asked are we going to submit the other two projects.

Mr. Romero said this is if you want Federal funds. If you are looking for Federal funds for any projects we have to move them forward.

Mr. Gomez said the requirements for Federal funds are significant. It is more economical for the County to try to procure County funding and not Federal funding.

Mr. Aune said we still need a motion to release the draft still for public review.

MOTION A motion was made by Mr. Mortillaro, seconded by Mr. Gomez, to recommend that the draft 20-25 TIP be released for public review.

VOTE The motion passed unanimously by voice vote.

C. RECOMMENDATION FOR APPROVAL OF AMENDMENT TO THE 2015-2040 METROPOLITAN TRANSPORTATION PLAN TABLE 7.1 "REGIONAL ROADWAY PRIORITIES"; INCLUDING NEW CITY OF SANTA FE ROADWAY PROJECT - CAMINO MONTE DEL SOL (BETWEEN CRUZ BLANCA AND OLD SANTA FE TRAIL) \$120,000 FOR REPAVING AND ADDITION OF SHOULDERS

Mr. Aune reviewed the information in the packet for this item.

Mr. Escudero said the name of the road is Camino Del Monte Sol.

MOTION A motion was made by Mr. Romero, seconded by Mr. Escudero, to recommend approval with Mr. Escudero's correction as amended.

VOTE The motion passed unanimously by voice vote.

D. 2019 BICYCLE MASTER PLAN REVIEW AND RELEASE FOR 30-DAY PUBLIC REVIEW

Mr. Aune said the MPO has been working directly over the past year to develop this draft update to the 2012 Bicycle Master Plan. It was presented to the Policy Board and there was some concern about the level of public input related to the south side, Council Districts 3 and 4 and diversity. Subsequent to that meeting we reopened a survey focused on those areas with the support of the Santa Fe Public Schools. He also had a volunteer who went out to the Genoveva Chavez Center on a Friday, set up a table and met with folks there. We did get an additional 52 responses from those efforts in that area bringing our total responses to 824 that informed this Plan. We are asking for the release of the Plan for a thirty day public review.

- Mr. Aune reviewed the Plan.
- Mr. Gomez left the meeting.
- Mr. Berke asked have you thought about, as an implementation step, talking to the Police Department about having an open space and trail division so they bike along the trail to provide safety.
- Mr. Aune said that has not come up. We have had conversations about police engagement and how they do enforcement. Also around educational components.
- Mr. Berke said a lot of other cities do it. A lot of the safety aides do that kind of thing. There are safety issues on the trails.
- Mr. Mortillaro asked the list of projects here are the same as the ones in 2012 or similar.
- Mr. Aune said there are similarities. We looked at 2012 projects and identified the ones built and in process. The ones built were removed. Then we recalculated A, B and C shifting some up to nearer terms and then looked at a reasonable amount for each. We are going through the process of ranking them now. We now have a new ranking criteria. Equitable accessibility is a priority.
- Mr. Mortillaro asked does somewhere in the plan talk about or document the successes achieved from 2012 to now so there is some kind of record of what has changed since then and successes achieved.
- Mr. Aune said yes. We took as snapshot of 2012 and today and said what has been done and described some of those successes and what the intended trajectory of success is.
 - Mr. Romero asked did you look at updating cost estimates.
- Mr. Aune said yes, we will be adding as a column an approximation by dollar signs shown.
- Mr. Romero asked if we were to program any of there projects we will need the estimated amount by dollar sign.
 - Mr. Aune said we will do that.
- Mr. Escudero said maybe you might want to put in an estimation for a Cadillac trail or just a direct trail as options. A range for the design. Per mile or foot.
 - Mr. Aune said we can look at that.

- Mr. Escudero said it would give an idea to the public of costs.
- Mr. Romero said we have built a lot of miles in previous projects. We could come up with cost estimates based on that.

Chair Wilson said we did cost estimates before along those lines. We never accounted for a retaining wall or drainage so when the project came along the costs went up considerably. It is a hard one to resolve.

Mr. Escudero said he would qualify if that is just for the trail itself or put in a contingency fee of 25%.

Chair Wilson said you could pick a variety of your trails and come up with estimated costs.

Mr. Escudero said you could also consider a low range and a high range.

Chair Wilson said it is hard to resolve. What made the 2012 plan somewhat successful was that the money followed the plan fairly quickly. We were able to finagle some Federal funds and others to fill in the cracks.

- Mr. Romero said he usually just goes off of a previous project. Maybe your methodology is good enough.
- Mr. Aune said all the data is not in a nice spread sheet. We just don't have the time and funding to do that.
- Mr. Romero said if you look at a square mile made of these materials that would cost so much and that could be a benchmark. There must be some language to say what was not factored in.

Chair Wilson said that might be covered with the dollar signs to show an incremental range of funds.

- Mr. Romero said we are going to do our own cost estimate when it comes time to program money.
- Mr. Aune said we could look at, assuming this draft moves to a final draft, if we have the resources to select the top projects and do a formal cost estimate on them.

Everyone agreed.

Mr. Aune said lets say the top ten projects and add it as an appendix.

Chair Wilson said we are looking at this for public review.

Chair Wilson said on the tool kit how do you account for new stuff going forward.

Mr. Aune said we are fortunate to have a planning team on board who infused in here those anticipated updates. We recommend when new design guidelines are formally adopted by the Federal Highway Department and so forth that we made adjustments.

Chair Wilson said this is very well put together and graphically pleasing. Great job.

MOTION A motion was made by Mr. Romero, seconded by Mr. Berke, to recommend the release of the Plan for public review.

VOTE The motion passed unanimously by voice vote.

E. UPDATE ON TRANSPORTATION IMPROVEMENT PROGRAM PROJECTS

Mr. Aune said he attended the 50% design meeting for the NE/SE connector and some key decisions made. Souder Miller is doing the work. They are looking at details as to where the intersections will be on the new roadway and potential new development. There are potential new bikeways and trails that are in discussion for interfacing and specifics as to drainage.

Mr. Kavanaugh said we are hammering out the details for the design criteria.

Ms. Anderson said on Guadalupe we are working towards 60% and identifying the right of way issues, curb ramps and some existing sidewalk and cleaning up. It is more of an extensive effort than was originally thought. Wilson and Company are working on that and additional rights of way. There are twenty four land owners or property owners we are cooperating with. There are a few more TCPs that were thought of. We will update this Committee based on the acquisitions.

Ms. Anderson said on Cottonwood we are approaching 60%. You will see a letter requesting the 50% design review. It is moving forward.

Mr. Aune said he was given update on the exchange agreements on St. Michaels. It is a continuing discussion. It looks like on St. Michaels they are going to sever out the road diet study and invite the City to take that over when the City takes over the road. Hopefully it will move forward with design options for the interchange.

Mr. Padilla said DOT is looking to repave St. Frances and do drainage work.

Then they will turn it over to us. They gave us funding to manage the Rail Trail project. We are getting traction to finish the last segment of Cerrillos. Agua Fria/South Meadows is approaching 30%. Santa Fe Engineering is working on that one. It will be a signal left turn bay and three right turn bays.

7. MATTERS FROM MPO STAFF

Mr. Aune said he has interviewed some potential staff. Hopefully they will get on board. We will be updating the website. He is looking at two things to make it more user friendly in terms of visually and how we update it. On the heels of a lot of the stuff we talked about today, we need to draft the RFP language for an updated Metropolitan Transportation Plan. Hopefully that will start this summer. A key element we are focusing on is a performance management element.

Mr. Aune said we want an element of inclusively, equity and environmental justice so we are looking at it a bit differently through that lens to focus on a public engagement process that highlights social equity and these issues. There is laser focus nationally and statewide on this issues. If you, as a member, feel there is a compelling issue of interest for you, reach out to him and let him know. We will share the scope when it is completed for comments.

8. MATTERS FROM TCC MEMBERS

Ms. Krueger said HB 694 was the Local Government Transportation Project Fund. The net funding source will be \$50 million across the state. There will be a call for projects.

Mr. Aune said he will do some research around the parameters of the funding and will share that with the TCC.

Mr. Romero said he understands they want to spend this funding soon. It is General Fund monies from the State.

Dear Erik,

This is to comment on the transportation around Camino Del Monte Sol. As you know, this small street and specifically the section from Camino de Cruz Blanca and Old Santa Fe Trail has become a major thoroughfare of our town. This segment of street provides access to 4 schools including Santa Fe Prep, St John's College, Rio Grande School and Atalaya Elementary which hosts hundreds of children and employees from across the city. In the summer, it is enjoyed by tourists who visit our town in outdoor buses. The road provides access to outdoor music festivals, sports events, overflow parking for the International Folk Art Market and more. And there are hundreds of homes that use this road everyday. Along with homes come larger vehicles for gardening, maintenance and moving trucks. This is to say that this small road is no longer sufficient to support today's traffic.

Currently, the road is degraded at the edges and too narrow, it is littered with potholes. There are drainage concerns at the stop sign and traffic that has repeatedly plowed into a neighbor's front entrance. The road requires new engineering. The road creates dangers for cars, cyclists and foot traffic especially when sharing the road with large vehicles. This situation jeopardizes walkers, motorists and school children. I am no engineer for sure, but I believe there are thoughtful and clever ways to dramatically improve the road and congestion to be safe for all levels of traffic. I am glad the city is looking into this and finding ways for improvement.

Dear Mr. Aune,

I am a homeowner in Wilderness Gate and wish to comment on the proposed amendment to the SF MPO Metropolitan Transportation Plan 2015-2041.

My concern is the section of Cam. Monte Sol between Old Santa Fe Trail and Cam. Cruz Blanca. I commute by bicycle through this section every day. The potholes at the intersection with Cam Cruz Blanca are treacherous to any bicyclist. Not only are they sufficient to blow a tire if impacted head-on, but because most cars passing here swerve to avoid them, there is additional risk for accidents and injury. Further, the shoulder on the east side of Monte Sol is a steep drop-off, and if cars pass too closely, pedestrians and bicyclists risk injury falling off the edge.

This area is quite busy with automobile traffic, particularly during drop-off and pick-up times for Santa Fe Prep. I request that the city move ahead with repaving and shoulder improvements, to ensure that this short but heavily trafficked corridor is made safer for all.

Thanks for your voicemail back. I'm sending along an email with my comments on the proposed improvements to Monte del Sol.

I have been the head of school at Santa Fe Prep for 20 years and use the intersection of MDS and Old Santa Fe Trail several times each day--as do hundreds of our families and students as they come to school. The stretch of MDS that runs from south from the intersection with Garcia Street to the T with OSF Trail has been subpar for decades: insufficient shoulder to provide pedestrians, cyclists, and drivers safety; poor drainage; ice build-up in the winters. As you likely know, the intersection of Monte del Sol and Camino Cruz Blanca is, at certain times of day, very busy, with cars coming from three directions; at other times of day, it is only somewhat busy.

We have many students and families moving through that intersection twice each day--as does St. John's College, Atalaya Elementary School, and Rio Grande School. Brining that stretch of MDS up to the quality standards of the roads it connects would be a big step forward.

I understand that you are involved with planning of potential road improvements on Camino Monte Sol between Old Santa Fe Trail and Camino Cruz Blanca.

This particular section of road has a significant volume of traffic, including Santa Fe Prep, St. John's College, The City of Santa Fe Bus Route, The Carmelite Monastery, Ordinary Residential Traffic, overflow parking for Museum Hill events and a significant biking and walking community.

The City has studied traffic volumes many times, but all it really takes to understand the treacherous nature of this section is to drive it and witness cars having to move suddenly to the shoulder to allow ordinary two way traffic any hour of the day, watch bicyclists and pedestrians dive for cover as traffic veers to the shoulders and see the rubble of so many accidents at the three way intersection of Monte Sol and Cruz Rlanca

So, I make four points:

- Traffic volumes demands a better design of the roadway.
- Water and snow management require a better subsurface drainage plan
- Maintenance of the intersection, including snow removal, scoria application and regular pot-hole repairs needs to be done to further minimize accidents and pedestrian dangers.
- High pedestrian and bicycle use require a thoughtful approach to safe bike / pedestrian corridors.

As a Wilderness Gate resident, I urge you to advance this project with the highest priority.
