1. CALL TO ORDER

The meeting of the Municipal Tree Board was called to order by Katherine O'Brien, Chair, at 11:33 am, on Wednesday, April 24, 2019, at the Parks and Recreation Conference Room, 1142 Siler Road, Santa Fe, New Mexico.

3. APPROVAL OF AGENDA

Chair O'Brien stated that the date of the Community Day is May11th, not the date on the agenda.

A. BOARD MEMBERSHIP

Chair O'Brien reported that PARC approved the expansion of the Tree Board membership to seven members and approved all three of our recommendations for new Board members. She welcomed the new Board members.

Ms. Martin gave an overview of the Open Meetings Act rules.

Mr. Thompson gave additional instructional information to the new Board members.

B. TREE INVENTORY

Ms. Touchett reported that Tree Plotter is in the process of being purchased. They did give her a user name and password so she has set up the administration of the program and the site for volunteers. She is holding a training for eight volunteers tonight at the Water History Park from 5:30 pm to 7:30 pm on how to use Tree Plotter on our tablets.

Ms. Touchett gave an overview of the tree inventory project for the new Board members.

Ms. Schruben said much of the hand done inventory data with GPS has been put on line on the Parks site. Thank you for that.

Ms. Schruben said tree inventories are one of the strategies for the Sustainability Plan that the City adopted.

C. CESAR CHAVEZ EDUCATION CLASS, TREE PLANTING

Chair O'Brien reported that she, Pam and Richard participated with the gardening class for a hour at Cesar Chavez Elementary School. We marked where the trees will be planted tomorrow at 10:00 am for Arbor Day. She invited the Mayor and City Council

to attend. She has not had a response from them. John Munoz will be there and will read the Arbor Day Proclamation.

Mr. Thompson and Ms. Wolfe praised the tree book that was given to the class.

Ms. Wolfe passed around an insect training booklet from NMSU that may be used by the Tree Board.

Chair O'Brien encouraged all the Board members to attend the tree planting.

D. EARTH DAY BOOTH AT RAILYARD PARK

Chair O'Brien said the Tree Board will have a booth for Earth Day at the Railyard Park on Saturday. Board members stated the hours they are available to volunteer at the booth.

E. MASTER GARDENER FAIR

Chair O'Brien reported that the Master Gardener Fair will be on May 4th from 9:00 am to 3:00 pm. The Board members stated the hours they are available for volunteering at the Tree Board booth there.

Ms. Wolfe explained the name tags she is making for the event for the Tree Board.

Mr. Thompson said he will be delivering tents for the event and will deliver one for the Tree Board booth along with a table and three chairs and the Tree City USA banner.

Chair O'Brien said she and Richard and Pam will coordinate on the brochures and pamphlets.

6. NEW BUSINESS AND POSSIBLE ACTION

A. COMMUNITY DAY AT PLAZA - MAY 11th

Mr. Thompson said he would like to have a Tree Board presence at this event with a table and banner if you wish or as part of the Parks and Recreation table. We will hand out wildflower seed balls and seedlings. It is on the Plaza from 8:00 am to 4:00 pm.
