VIII. MATTERS FROM THE EXECUTIVE DIRECTOR

- Mr. Kippenbrock said he had five items to discuss.
- On September 13th we had a rollover.

Commissioner Moreno asked if their insurance will cover any damages.

Mr. Kippenbrock said yes and he is in touch with Travelers Insurance.

Councilor Harris asked if the driver was an experienced driver.

Mr. Kippenbrock said he had been with them since May. He came over from NMDOT. Speed was a factor.

Councilor Harris asked about the new procedures that he is going to implement.

Mr. Kippenbrock said we are going through our procedures and updating and changing them from cradle to grave.

Councilor Harris asked if they had ever had other rollovers.

Mr. Kippenbrock said a trailer tipped over at the landfill. This was the third rollover.

2. BuRRT Trash Amnesty Day

Mr. Kippenbrock said this Saturday is Trash Amnesty Day at BuRRT.

Commissioner Roybal asked for the numbers of people that usually come for that day.

Mr. Kippenbrock said in the fall we have about 400. In the spring is could be from 600 to 700.

3. HHW (Household Hazardous Waste)

Mr. Kippenbrock said the first Saturday in November will be Household Hazardous Waste collection day. This will be our second one.

The date for the reopening of MRF (Material Recycling Facility) was discussed along with the possibility for a small ceremony.

Commissioner Moreno said he prefers that it be on a weekend.

Chair Villarreal said she agreed.

Councilor Harris suggested that they allow Mr. Kippenbrock to think it through and make a suggestion.
