MINUTES OF THE PUBLIC UTILITIES COMMITTEE MEETING WEDNESDAY, NOVEMBER 6, 2019 – 5:00 PM CITY HALL, CITY COUNCIL CHAMBERS, 200 LINCOLN AVENUE

1. CALL TO ORDER

The meeting of the Public Utilities Committee was called to order at 5:00 pm by Chairman Councilor Christopher Rivera, at City Hall, in the City Council Chambers, on Wednesday, November 6, 2019, Santa Fe, New Mexico.

2. ROLL CALL

Roll call indicated the presence of a quorum as follows:

Chair Rivera recognized Stephanie Lopez, Office Manager, Public Utilities Department. He stated that Ms. Lopez is retiring from the City of Santa Fe and this is her last Public Utilities Committee meeting. Chair Rivera presented a proclamation on behalf of the City of Santa Fe and Mayor Alan Webber in appreciation of Ms. Lopez's employment with the City.

3. APPROVAL OF AGENDA

MOTION A motion was made by Councilor Vigil Coppler, seconded by Councilor Romero Wirth, to approve the Agenda as published.

VOTE The motion passed unanimously by voice vote.

INFORMATIONAL ITEMS

6. WATER PLANNING AND REUSE STRATEGY PUBLIC MEETING UPDATE. (William Schneider)

Mr. Schneider provided a brief update on the upcoming water planning meetings which Water Division Staff will be hosting on November 12th and 14th at the Fogelson Library. The meetings start at 4:30 pm and at 6:00 pm, there will be breakout sessions. One of the primary focuses is "all things water reuse" as well as "future goals and objectives relative to water planning."

He referred to the packet that he handed out to the Committee, attached as Exhibit "1". On the second page of the handout there is a road map of how the meeting will be presented. There will be an open house with technical working sessions as well as small group discussions that will be facilitated by moderators. There will be four booths that will set the stage for water planning, water reuse and optimization. There is also going to be an open discussion on the issues pertaining to the Santa Fe River and Rio Grande as it relates to environmental benefits as well as potential impacts.

He referred to the two-page fact sheet that summarizes the sustainable water goals in the near term, attached as Exhibit "2".

After the two meetings, staff will synthesize the information with the hope that staff will develop a consistent strategy for the City in terms of embarking on critical needs with infrastructure to maximize resources and assets as it relates to water supply.

Councilor Ives asked if there has been anything that suggests that the identified priorities for water reuse have changed.

Mr. Schneider responded that the findings of the feasibility study are reinforced and validated more than ever. That's part of the public engagement process. They want to see if the public concurs with the Water Division's approach and the findings.

Chair Rivera asked who has been invited to these meetings.

Mr. Schneider said it's an exhaustive list. A broad spectrum of the community from all districts and stake holders have been invited. They've reached out to the broader community through constituent services in terms of social media, newspapers, broad email lists through the various groups, it's very extensive.

Chair Rivera asked if any Councilors would be attending.

Mr. Schneider said he's heard that Councilor Ives, Councilor Rivera and Councilor Romero-Wirth will be attending.

Chair Rivera said to make sure there is not a quorum at any time.

Councilor Romero-Wirth said she didn't think the quorum is an issue because it's not a meeting as much as it is a public outreach.

Mr. Martinez said the Open Meetings Act speaks only to when there's going to be a discussion by a public body regarding public policy or other decisions that have to made by that public body. His understanding is that staff will be the leading discussion. Governing Body members who are present will be more of attendees and listeners, like other members of the public. He said he would verify his understanding with the City Attorney.

Chair Rivera referred to Page 4, under Sustainability where it states that Katherine Mortimer and Neil Denton went to a conference in Detroit. He requested that Ms. Mortimer provide the PUC with a brief update at the next meeting regarding what they learned at the conference.

Ms. Sitton said she would let them know. The feedback she got from them was that it was so much information that is relevant and they're excited about it.

MOTION A motion was made by Chair Rivera, seconded by Councilor Vigil

Coppler, to approve the Update as presented.

VOTE The motion passed unanimously by voice vote.

10. Water Division Monthly Update. (Jesse Roach, Water Division Director, jdroach@santafenm.gov, 955-4309)

Councilor Ives referred to page 1 under *surface water storage and supply outlook*. He appreciates the numbers. He said he usually doesn't see the Santa Fe River water right quantified and he knows it's unadjudicated at this time. He asked Mr. Martinez if that's something the City has determined or is it something the State has determined. He asked what the status of the *Anaya* case is.

Mr. Martinez said the status of the *Anaya* case is that it's the same as it's been for many years. If you ask the State Engineer, it's slow but steady progress. The City has what is considered the second-best recognition of a water right, a licensed right that was granted in the 1950s or 1960s.

Councilor Ives asked Mr. Roach about San Juan Chama where it states the system reservoir is 16,464 acre-feet. That's about 2,000 acre-feet up from where we were last month on the storage figures. He wanted to know if that was correct and if so, where the water came from.

Mr. Roach referred to the figure on the next page where it does state that the San Juan Chama Water and Storage on the Chama System went from 15,848 in the middle of September to 16,463. He said Councilor Ives was correct and he will go back and check those numbers and let him know.

Councilor Ives referred to the chart on Page 2. He said the precipitous drop in Heron stored water identified appears to have gone into Abiquiu, if he's reading the chart correctly.

Mr. Roach said that's correct and it would be consistent with moving water from Heron to Abiquiu.

Councilor lves said the water amounts in various areas didn't seem to line up with water reports.

Mr. Roach said he would go back and verify the numbers.

Councilor Ives referred to the other page where it mentions the full allocation of 5600 and 5 acre-feet of San Juan Chama water. He said that number is higher than he had heard before. He asked, "what do we have"?

Mr. Martinez said that number includes the County's allocation, that's why it looks a little higher.

Councilor Ives stated that there's a huge uptick in the water in Heron in the period from May to August; and there doesn't seem to be any loss from either of the other two reservoirs. He asked if that was all San Juan Chama water.

Mr. Roach said he believes that was water that was allocated from the Federal pool in Heron.

Councilor Ives said it looks like there is about 5,000 acre-feet increase in Heron which would indicate that it's almost the entirety of the San Juan Chama water coming in at that point in time. He asked Mr. Roach to look at the numbers again.

Councilor Ives asked about progress on hiring the BDD Facility Manager.

Mr. Roach said they are preparing to repost that position. They are raising the budgeted salary and changing the way they are going to advertise that position. They will be using national search firms to assist in the search.

Councilor Ives said the BDD Board would be pleased with the progress.

Councilor Vigil Coppler complimented Mr. Roach on following the idea for providing safety information. The information is quite informative, and it shows that safety is being paid attention to. There's an eye out for safety and employee wellness. She thanked Mr. Jones for having this item addressed every month.

She also talked about the vacancies, the highest one being the BDD Director. The Buckman Direct Diversion Board is very concerned about that position. At the last BDD meeting they talked about vacancies in general. With 17 vacancies on the books, minus the director of Buckman, that's quite high. She wants to make sure that there is attention to that and that it's speedy and timely because when there's vacancies it affects everybody else. It's important to press on with filling those positions. Anything that can be done to get positions filled is critical.

Mr. Roach said he agreed with the comments and their top priority is getting those vacancies filled and they should see progress by next month.

Chair Rivera asked, related to safety, if staff is sharing the results of what was learned from near misses, with other departments.

Mr. Jones said there is a mechanism working through the City's Safety Office where we can communicate that to them. He'll make sure that happens.

Mr. Roach said with regards to his update, he has a handout that includes October, as well. The handout is attached hereto as Exhibit "3". He also had a handout in response

to Councilor Ives' question last month about what portion of our wastewater return comes from residential versus commercial. The handout is attached hereto as Exhibit "4".

MOTION A motion was made by Councilor Ives, seconded by Councilor Vigil Coppler, to approve the Update as presented.

VOTE The motion passed unanimously by voice vote.

Councilor Rivera welcome Mayor Webber to the PUC meeting and told him if he has any questions, feel free to come on up.

Councilor Vigil Coppler left the meeting at approximately 5:55 p.m.

Councilor Ives said on the second page of the memo it is noted that there are about 4,600 customers signed up on *Eye on Water*. He presumes that's out of a data base of about 31,000.

Ms. Christine Chavez she would have to get back to him on that exact number. She thinks it's between 12% and 14% of the overall customer base.

Councilor Ives referred to pages 3 through 10 in the packet and said it was wonderful work. He complimented staff and Councilor Romero Wirth and others who have worked on this.

MOTION A motion was made by Councilor Ives, seconded by Councilor Romero Worth, to approve the 3rd Quarter Scorecard Goals as presented.

DISCUSSION: Councilor Romero-Wirth asked if at the Water Planning meetings next week, if there will be *Eye on Water* material available.

Ms. Chavez said they hadn't thought about that but that would be a great place to distribute that information.

VOTE The motion passed unanimously by voice vote.

Councilor Ives said in the memo, second paragraph, under *Item*, it says "The primary objective of the JFA is to monitor surface and ground water as required for permit compliance with the OSE and the RGCC and the ISC compliance rules." He appreciates we comply with the rules and do necessary monitoring and reporting. It always begs the question in his mind of monitoring of wells across the city of Santa Fe. There are some

800+ wells and he's not aware of any efforts to meter or monitor those. He asked if there is anything that can be done about that.

Mr. Hook said domestic wells are required to turn in that information to the OSE. There are some through the Domestic Well Ordinance where we have asked for those same records. It would be comprehensive for all 800+. That's about as far as we've come on metering. We don't meter all the domestic wells in the City limits. He said citywide, that would be a big effort to require that now.

MOTION A motion was made by Councilor Ives, seconded by Councilor Romero Wirth, to approve the Joint Funding Agreement as presented.

VOTE The motion passed unanimously by voice vote.







Community members are welcome to stop by the open house and/or participate in the small group discussions.



Santa Fe Sustainable Water Future Public Availability Sessions

- The Santa Fe Sustainable Water Future public availability sessions will take place on Tuesday, Nov. 12 and Thursday, Nov. 14 from 4:30 to 7 p.m. at the Fogelson Library.
- Each session will include two elements: an open house, which will last throughout the whole evening, and small group discussions, which will take place from 6 to 7 p.m.
- The sessions will include:
 - A staffed welcome table where attendees will receive a "what you will learn at each station" handout
 - A "sticky wall" where attendees will post their answer to the question "What's important to you when you think of water supply in Santa Fe?"
 - A looping PowerPoint that will provide background on Santa Fe's water planning to date
 - o A comment/feedback table
 - o A live polling element, which attendees can use their smart devices to take and see the results of a poll about what they want to learn at the meeting, water reuse options and what residents want to know about water
 - A "mingle zone" that will include refreshments
- Open House: Upon arrival at the session, attendees will be invited to visit a series of
 information stations. This information will provide attendees with a primer to the group
 discussion. There will be 4 information stations:
 - 1. Setting the Stage: Santa Fe Water Planning
 - 2. Evaluating the Options: Santa Fe Water Reuse Optimization/Feasibility Study Alternatives
 - 3. Creating System Flexibility for the Future: Santa Fe Water Reuse Strategy
 - 4. Protecting and Enhancing Community Assets: Santa Fe River Management
 - Stations will feature posters that provide detailed information about the topic.
 - Project team members will be available at the stations to dialogue oneon-one with attendees and address questions.
 - Conversations will also be two-way getting and giving information. This
 also allows those individuals who are not comfortable speaking in a large
 group setting to have their say.
- Small Group Discussions: At 6 p.m. attendees will be invited to participate in a small group discussion activity. Participants will be split into groups of up to 10 people. The number of groups will be based on number of interested attendees. There will be a facilitator for each group, who will lead the group in discussing three questions (20 minutes will be spent on each question). The questions will be about Santa Fe's water supplies/alternatives, future water supply planning and the best uses for reclaimed water. The facilitators will write down the responses from their group (on flip charts the group can see) to share with the City Water Division team following the meeting.


WHY IS SANTA FE SUSTAINABLE **WATER FUTURE IMPORTANT?**

Santa Fe must develop new, local water supplies to address demands on existing water resources that are under threat from prolonged droughts, climate change, wildfires, and contamination. The 2015 Santa Fe Basin Study showed there will be major water shortages by 2055 if the City maintains the status quo, and that expanding existing water reuse is key to heading off future shortages.

Santa Fe Sustainable Watere Future cost-effectively heads off projected future water shortages. We will make the most of the infrastructure and systems we've already invested in and then adapt our strategies to address increasing water demands and climate change impacts.







- preserving groundwater for peak supply, drought reserve, and supply emergencies.
- Creating a "living river" from Canyon Reservoir. bypasses so the Santa Fe River flows through town and recharges the aquifer.
- > Using the Buckman Direct Diversion system to directly access imported San Juan-Chama Project (SJCP) surface water.



WHAT IS SANTA FE'S WATER REUSE STRATEGY?


After a comprehensive review of integrated water resource options, the City is exploring the Buckman Return to reclaim and reuse its SJCP return flows. The Buckman Return would transport treated SJCP water back to the Rio Grande so the City can obtain "return flow credits."

The pipeline could serve as the backbone of a long-term reuse strategy; it would enable full use of the City's imported SJCP water and potential future phases of reuse, such as direct potable reuse and managed aquifer recharge.



What are the Benefits of Santa Fe Sustainable Water Future?

- / Enhances our ability to provide a living river through town.
- Preserves and supplements our aquifers as a drought reserve.
- Sustains a healthy ecosystem throughout the Santa Fe River watershed.
- Reduces the need for costly upgrades to our existing water reclamation facility.
- Increases the amount of recycled water produced and used, benefiting the community, the environment, and helping preserve local and regional agriculture.



A RESOLUTION

ESTABLISHING CITY SANTA FE **OF** LEGISLATIVE **PRIORITIES FOR** CONSIDERATION BY THE NEW MEXICO STATE LEGISLATURE DURING THE 54TH LEGISLATURE - STATE OF NEW MEXICO - SECOND SESSION, 2020.

WHEREAS, the 30-day Legislative Session of the 2020 New Mexico State Legislature begins on January 21, 2020 and ends on February 20, 2020; and

WHEREAS, the Governing Body desires to establish City of Santa Fe legislative priorities to be considered by the City of Santa Fe Legislative Delegation and the New Mexico State Legislature; and

WHEREAS, the Governing Body has other legislative priorities they desire to be considered by the New Mexico State Legislature, including City of Santa Fe citywide capital outlay priorities, City of Santa Fe statutory priorities, City of Santa Fe general fund priorities, City of Santa Fe City Council District capital outlay priorities, and other legislative priorities beneficial to the City to be introduced during the 2020 New Mexico Legislative Session.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE

CITY OF SANTA FE that the Governing Body hereby establishes the following citywide capital outlay legislative funding priorities for consideration by the New Mexico Legislature during the 2020 Legislative Session:

- 1. For any statewide capital outlay initiative associated with economic development, the City of Santa Fe requests funding in the amount of \$10,000,000 for the expansion of the Santa Fe Regional Airport terminal building and related infrastructure, including an expansion to accommodate additional airlines, flights, increase seating, and enhance the flow of passenger traffic [in and out of the terminal building).
- 2. For any statewide capital outlay initiative associated with the construction of fa-teen eenter on the Southside Teen Center, the City of Santa Fe requests \$[3]4.000,000 for [the completion of] this project to provide essential services to help teens succeed.
- 3. For any statewide capital outlay initiative associated with economic development through infrastructure improvements associated with Midtown Santa Fe, the City of Santa Fe requests \$3,000,000 to [support-improvements to utilities, trails, and improvements to roadways and digital infrastructure to support redevelopment at Midtown Santa Fe] plan, design, and construct infrastructure to promote development within the Midtown Santa Fe property including digital, transportation, drainage, facilities, and utilities.
- 4. For any statewide capital outlay initiative associated with the extension of Paseo del Sol and spine infrastructure in the Tierra Contenta subdivision to support critically needed housing development, the City of Santa Fe requests funding in the amount of \$[8]4,000,000 that will be leveraged with other private and public financing.
- 5. For any statewide capital outlay initiative associated with drainage and watershed maintenance, the City of Santa Fe requests \$1,500,000 to plan, design, acquire rights of way, and construct storm drainage and watershed improvements within the City of Santa Fe in accordance with the City's Stormwater Master Plan.] For any statewide capital outlay initiative associated with water

conservation and public benefit infrastructure, the City of Santa Fe requests \$1,500,000 to upgrade irrigation systems at the Municipal Recreation Complex to provide increased water conservation and reliability.

6. For any statewide capital outlay initiative associated with replacing existing government internal combustion engine vehicles with electric vehicles, the City of Santa Fe requests \$500,000 to purchase approximately 25 electric fleet vehicles as a step towards achieving the City's goal of becoming carbon neutral by 2040.

BE IT FURTHER RESOLVED that the Governing body supports and endorses [any] legislation that authorizes law enforcement or family members to petition a state court to order the temporary removal of firearms from a person who may present a danger to themselves or others and an appropriation that would fund research on the cause of gun violence and the solutions to end gun violence amongst New Mexico youth. [If the Legislature does not have the political will to adopt such legislation, the Governing Body supports and endorses legislation to amend the New Mexico Constitution to permit local government to adopt their own reform measures to address public safety as it relates to firearms.]

BE IT FURTHER RESOLVED that the Governing Body requests the New Mexico State Legislature pass legislation during the 2020 Legislative Session which would amend New Mexico's tax law to allow for the imposition of gross receipts taxes on out-of-state vendors and implement a formula for calculating the distribution of gross receipts tax revenue from out-of-state vendors which ensures fair and equitable distribution to municipalities and counties.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation during the 2020 Legislative Session that would implement an additional tax on big box stores.

BE IT FURTHER RESOLVED that the Governing Body request the New Mexico State

Legislature work to ensure that the New Mexico Taxation and Revenue Department charges

administrative fees connected to the distribution of gross receipts tax revenue in accordance with applicable New Mexico state statutes which limit such fees to 3 percent and that any repayment sought by the New Mexico Taxation and Revenue Department pursuant to the overpayment of gross receipts tax revenue to a county or municipality be limited in time as provided for by applicable New Mexico state statutes.

BE IT FURTHER RESOLVED that the Governing Body requests that the New Mexico State Legislature ensure hold harmless payments to counties and municipalities are not eliminated or further reduced and returned to their original schedule and/or ensure that any tax reform continues to hold counties and municipalities harmless in lieu of the enactment of legislation reinstating the gross receipts tax on food and medical.

BE IT FURTHER RESOLVED that the Governing Body request that the New Mexico State Legislature appropriate money from the general fund to support the Santa Fe Thrive public safety program which allows law enforcement officers to work with the Santa Fe Fire Department to redirect persons suspected of involvement in non-violent, low-level crimes to community-based services in lieu of prosecution or jail.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that improves broadband infrastructure throughout the state, specifically as it relates to associated economic development.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that supports the development and construction of affordable housing to decrease and/or subsidize the cost of housing for residents of Santa Fe and New Mexico.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that would authorize the development of a community solar program that provides customers with the voluntary option of accessing solar energy produced by a community solar facility through a subscription process.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that would eliminate the 3% cap on annual property tax increases on residences that are not owner-occupied as the owner's principal place of residence.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that establishes an occupancy surtax, the proceeds of which would be used by municipalities and counties to defray the cost of providing affordable housing or to leverage federal funding for affordable housing.

BE IT FURTHER RESOLVED that the Governing Body requests the New Mexico State Legislature support legislation that promotes water reuse and water planning and other legislation designed to improve overall sustainability at the state and local level.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation or initiatives of the Legislature or Administration that would improve and expand early childhood education.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that would support municipal recycling programs; product packaging changes that reduce waste, and programs that support recycling market development.

BE IT FURTHER RESOLVED that the Governing Body supports and endorses any legislation that would increase funding for the New Mexico Tourism Department for use in advertising, a state-wide co-op grant program, and personnel expansion that restores the reduction in services at the Department between 2010-2018.

BE IT FURTHER RESOLVED that the Governing Body requests the New Mexico State Legislature adopt legislation that pertains to statewide business licensing that permit business owners to operate in all cities, counties, and municipalities provided business owners comply with local and use and safety requirements.

- For a capital outlay initiative located within City Council District 1, as identified in 1. the 2021-2025 ICIP submittal of the City, funding is requested in the total amount of \$162,000 to plan, design, acquire rights-of-way, and construct lighting and sidewalk improvements to improve pedestrian and neighborhood safety along Harrison Road from Cerrillos Road to Agua Fria, adjacent to the Interfaith Community Shelter.
- 2. For a capital outlay initiative located within City Council District 2, as identified in the 2021-2025 ICIP submittal of the City, funding is requested in the total amount of \$150,000 for sidewalk improvements to improve pedestrian safety in dense business areas on Pacheco Street from Alta, Vista to San Mateo and on Siringo Road from Pacheco Street to St. Francis Drive.
- 3. For a capital outlay initiative located within City Council District 3, as identified in the 2021-2025 ICIP submittal of the City, funding is requested in the total amount of \$150,000 for sidewalk improvements to improve pedestrian safety and access on Camino Entrada where the Southside Transit Center is being constructed and where there is business development.
- 4. For a capital outlay initiative located within City Council District 4, as identified in the 2021-2025 ICIP submittal of the City, funding is requested in the total amount of \$150,000 to design pedestrian, bicycle, and drainage improvements along Governor Miles Road.

BE IT FUTHER RESOLVED that the Governing body directs the City lobbyist to support Resolutions adopted by the Governing Body in 2018 and 2019 related to State legislation (see attached Exhibit A).
