6	AMENDING SECTION 5-13.3 TO CORRECT A REFERENCE CITATION.

8	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
9	Section 1. Section 5-13.3 of SFCC 1987 (being Ord. No. 1999-26, § 6,) is
10	amended to read:
11	5-13.3 Applicability.
12	A. All owners of animals wishing to run their dogs off -leash (except on their own
13	premises) must do so within the established limits and boundaries of an official city
14	designated dog park. It is the intent of this section for the city to designate enough dog parks
15	that owners of animals may walk to them and to not unduly impact any one (1) dog park.
16	B. Protocol for the owners of animals at dog parks or areas shall include, but not
17	be limited to the following:
18	(1) Owners of animals must clean up after their pets and dispose of all
19	feces left by their dog in accordance with subsection 5-7.6 SFCC 1987.
20	(2) No aggressive dogs shall be allowed. Dogs showing aggression
21	towards people or other dogs must be immediately leashed and removed from the dog
22	park. If an owner of animal continues to bring an aggressive dog to a dog park, such
23	individual shall be cited in accordance with subsection 5-5.3 SFCC 1987.
24	(3) Dogs must be wearing up-to-date rabies vaccination and city license
25	tags at all times.

1	(4) Owners of animals are legally responsible for their dogs and any
2	injuries caused by their dogs. Under no circumstances shall the city assume any
3	liability for the actions of dogs or the owners of animals.
4	(5) Owners of animals must remain with their dogs in the dog park, and
5	must keep their dog in sight and must carry a leash at all times.
6	(6) Leaving dogs unattended is absolutely prohibited. Dogs must be
7	leashed before entering and leaving the dog park.
8	(7) With the exception of puppies under five (5) months of age, all dog
9	using the dog park should be spayed or neutered. No dogs in heat are allowed in th
10	dog park.
l I	(8) A limit of three (3) dogs per owner of animal per visit.
12	(9) Young children must be closely supervised.
13	(10) Owners of animals must not permit their dogs to dig or to undul
14	disturb the terrain or vegetation. Any holes created by an owner of animal's dog mus
15	be filled by that person.
16	(11) Professional dog trainers may not use this facility for the conduct of
17	their business.
18	C. The governing body is authorized to designate a dog park or to rescind suc
19	designation.
