10	A RESOLUTION
11	ESTABLISHING AN OPERATIONAL PLAN FOR THE BICENTENNIAL POOL FOR
12	THE 2021 SEASON.
13	
14	WHEREAS, the City of Santa Fe ("City") owns and maintains four pools throughout the
15	city: Fort Marcy, Salvador Perez, Genoveva Chavez, and the Bicentennial outdoor pool; and
16	WHEREAS, the Bicentennial Pool is the only public outdoor swimming pool in the City,
17	located at 1121 Alto Street; and
18	WHEREAS, the Bicentennial Pool provides the opportunity for a variety of water
19	activities to the public during the summer season, including water Zumba, recreation swimming,
20	lap swimming, and special events such as the season-ending Doggie Dip; and
21	WHEREAS, the Bicentennial Pool is typically open from Memorial Day weekend to the
22	first week in September and serves approximately 200 patrons each day, generating approximately
23	\$33,000 in revenue annually; and
24	WHEREAS, various community groups utilize the Bicentennial Pool each year, including
25	the City's youth programs, Santa Fe Aquatic Club Masters program, Santa Fe and Pojoaque Boys

1 and Girls Club, and numerous other private groups and schools; and 2 WHEREAS, the Bicentennial Pool was constructed in 1976 in honor of the bicentennial 3 of the United States, and has received no major renovations since that time; and 4 WHEREAS, since the pool was built, there have been upgrades to the pump room 5 including new sand filters, pumps, filtration systems, and electrical shut-off switches as well as the 6 addition of two play structures and three shade structures; and 7 WHEREAS, on January 8, 2021, the Public Works Department became aware that 8 Recreation Department staff believed the pool was leaking approximately six inches of water per 9 day; and 10 WHEREAS, Recreation Department staff had obtained a quotation on January 5, 2021 to 11 repair the gutters and replaster the pool at an estimated cost of \$222,383; and 12 WHEREAS, Public Works Department staff established a purchase order and contractors 13 began work on February 24, 2021 to assess and propose solutions for the 2021 season with the goal 14 of performing the minimum repairs necessary, not including the repair of the gutters, to the pool to 15 open by Memorial Day, 2021; and 16 WHEREAS, contractors confirmed that the pool gutters were the primary source of 17 leakage and that the gutters could not be repaired in time for the 2021 season due to a six-month 18 lead time on procuring replacement gutters; and 19 WHEREAS, the City has contracted to repair some leaks as soon as possible, including 20 sealing the bottom drains and repairing some inlet water leaks, which staff believe will reduce the 21 rate of water loss; and 22 WHEREAS, City staff have determined that there are no safety risks to the public 23 associated with the water leaks; and 24 WHEREAS, water meter data from June through October of 2020 shows that the pool 25 complex used an average of 168,000 gallons per month; and

WHEREAS, not more than 28,000 gallons per month could be attributed to evaporation from the pool; and the remaining 140,000 gallons per month of water usage is a result of shower and bathroom use, water splashed out of the pool, and leakage, indicating the maximum size of the leak at the time it was discovered was approximately 3 gallons per minute; and

**WHEREAS,** SFCC 1987, Subsection 25-3.2(A) states that municipal facilities shall not waste water and that leaks in excess of 0.25 gallons per minute constitute wasting water; and

**WHEREAS**, SFCC 1987, Section 25-3.2(B) states that "flow resulting from temporary city water systems or malfunctions" is not wasting water, but should be minimized; and

**WHEREAS,** Santa Fe, and the broader Southwest Region is in the midst of a "mega drought" in which water resources may become even more scarce, necessitating increased conservation of this precious resource; and

WHEREAS, the Public Works Department and the Recreation Department intend to work with the Water Conservation Office to follow the same monitoring and action plan that other businesses with identified leaks would take; and

**WHEREAS,** the Santa Fe Community College has two indoor swimming pools that are available for use by the public and Defined Fitness recently opened with access to a pool; and

WHEREAS, while positions within the Recreation Department have been unfrozen and filled, the Department currently only has staff to operate three pools, but is working to add staff to be able to operate four pools; and

**WHEREAS**, the recently remodeled Salvador Perez Pool will be opened to the public before Memorial Day, 2021, to respond to community demand for pool facilities.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE that, in light of the information provided by City staff, including those from the Public Works Department, the Recreation Department, and the Water Conservation Office, the City shall keep the Bicentennial Pool closed for 2021, and once a full assessment of the pool is

2	options for next steps.
