6	AMENDING SECTION 7-1.1 SFCC 1987 AND SECTION 7-1.5 SFCC 1987 TO CLARIFY
7	THAT THE CITY HAS BUILDING PERMIT AND INSPECTION JURISDICTION WITHIN
8	THE PLANNING AND PLATTING JURISDICTION OF THE CITY.

10	BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
11	Section 1. Section 7-1.1 SFCC 1987 (being Ord. #2008-1, §3) is amended to read:
12	7-1.1 Adoption of Codes.*
13	A. For the purpose of regulating the erection, construction, enlargement, alteration,
14	repair, moving, removal, conversion, demolition, occupancy, equipment, use, height, area,
15	unobstructed maintenance of required yards, and maintenance of buildings or structures within the
16	planning and platting jurisdiction of the city, the following provisions and codes are adopted by
17	reference and incorporated as fully as if set out herein unless otherwise amended by the city:

Until such time, the 2002 National Electrical Safety Code as amended by the state of New Mexico 6 7 referred to as the 2005 New Mexico Electrical Safety Code shall apply. Any person violating or failing, neglecting or refusing to comply with the provisions 8 B. 9 of the codes set forth in paragraph A. above or this chapter shall be punished as provided for in 10 Section 1-3 SFCC 1987. A copy of the codes set forth in paragraph A. and this chapter shall be kept on file in 11 C. 12 the office of building inspections, and shall be at all reasonable times available and subject to 13 inspection. 14 D. The codes set forth in paragraph A. shall be effective February 1, 2008. Upon request of the applicant, applications for permits submitted before July 1, 2008, may be issued in compliance 15 16 with the prior codes. 17 Should the codes adopted in paragraph A. above not be current with the latest codes E. adopted by the state of New Mexico construction industries division, the city shall automatically 18 19 apply the latest codes adopted by the state. 20 Section 2. Section 7-1.5 SFCC 1987 (being Code 1953, §7-3, as amended) is 21 amended to read: 22 7-1.5 **Building Permits.** 23 Α. Except as otherwise provided in this Code, no building permit shall be issued for the 24 construction, erection or demolition of any structure of any kind within the planning and platting 25 jurisdiction of the city unless the construction, erection or demolition of such structure complies with

the terms and provisions of the codes as set forth in Section 7-1.1A. SFCC 1987 and all applicable ordinances adopted by the city. B.
