| 22 | WHEREAS, such an Act would make it illegal to barter, trade, sell or offer for sale or |
| 23 | trade any product represented as produced by local Hispanos unless the product is produced, |
| 24 | designed or created by the labor or workmanship of a local Hispano; and |
