10 AN ORDINANCE

11 AMENDING ARTICLE 23-6 SFCC 1987 REGARDING THE SALE OR CONSUMPTION
12 OF ALCOHOLIC BEVERAGES ON CITY PROPERTY.

14 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

15 Section 1 Article 23-6 SFCC 1987 (being Ord. #1981-39, §20 as amended) is
16 amended to read:

17 23-6 Sale or Consumption of Alcoholic Beverages; City Property.

18 [~~A. Sale of alcoholic beverages at locations on property owned or controlled by the city~~
19 ~~shall not be allowed unless permission therefore is received from the director of the department of~~
20 ~~alcohol beverage control pursuant to the special dispenser's permits provisions of Laws of New~~
21 ~~Mexico 1981, Chapter 39, Section 29.]~~

22 [~~B. This subsection shall not apply to the governmental license provisions of Laws of~~
23 ~~New Mexico, 1981, Chapter 39, Section 27, and in the event of sales pursuant to a governmental~~
24 ~~license, a special dispenser's permit is not necessary.]~~

25 [~~C.~~]A. The sale or consumption of alcoholic beverages on [public] property owned or

1 controlled by the city shall be prohibited [~~unless specifically authorized as follows~~] except as set
2 forth in this Article 23-6.

3 ~~[(1) All requests for consumption of alcoholic beverages must be approved by~~
4 ~~the governing body; and~~

5 ~~(2) Applicants who are granted a request are required to obtain a separate~~
6 ~~special use permit pursuant to paragraph C of subsection 23-4.7 of this chapter and pay the~~
7 ~~fee so required and in addition shall pay a fee of ten dollars (\$10.00) for each day the~~
8 ~~permittee dispenses alcoholic beverages.]~~

9 B. The sale or consumption of alcoholic beverages is permitted at the following
10 locations:

11 (1) The Santa Fe community convention center and adjacent outdoor spaces
12 under the center's control;

13 (2) That area of the Santa Fe municipal airport main terminal building and
14 adjacent areas operated as a restaurant; and

15 (3) The Marty Sanchez Links de Santa Fe (golf course).

16 C. The sale or consumption of alcoholic beverages is permitted in buildings owned by
17 another party located on land owned by the city.

18 D. The sale or consumption of alcoholic beverages is permitted on land or buildings
19 owned by the city for which the city has entered into a lease with another party for six months or
20 more except for the Railyard Park, Plaza and Alameda (as defined in the Deed of Conservation
21 Easement dated October 1, 2004) where alcohol is prohibited.


22 E. The sale or consumption of alcoholic beverages is permitted in or on railroad cars
23 located on railroad tracks except as prohibited by state or federal law.

24 F. All other applicable approvals required by state or city laws shall be obtained prior
25 to the sale or consumption of alcoholic beverages on the property described in this Article 23-6.
