21	Vargas Grant and Lying within Section 7, T.16N., R.10E., N.M.P.M. as more fully described in
22	"Exhibit A" attached hereto and incorporated by reference.
23	Section 2. The official zoning map of the City of Santa Fe adopted by Ordinance No.
24	2001-27 is amended to conform to the changes of zoning classifications for the property set forth
25	in Section 1 of this Ordinance.

1	Section 3. This rezoning action effected by this ordinance shall be published one time by
2	the title and general summary and shall become effective five days after such publication.
3	Section 4. The rezoning action with respect to the Property affected by this Ordinance is
4	subject to the time restrictions set forth in Section 14-3.5(D)(1) SFCC 2001 (Two-year
5	Review/Rescission).
