1 CITY OF SANTA FE, NEW MEXICO RESOLUTION NO. 2007- 122 2 3 INTRODUCED BY: 4 5 6 7 8 9 10 A RESOLUTION 11 DIRECTING STAFF TO PROCEED WITH NEGOTIATIONS TO PURCHASE 14 12 ACRES OF LAND ADJACENT TO THE SILER ROAD YARD AND DEVELOP 13 FINANCING OPTIONS IN THE EVENT A PURCHASE IS CONTEMPLATED. 14 15 WHEREAS, over the last 18 months Terraplen Architects and Planners of Santa Fe, 16 New Mexico and the SGS Group of Sacramento, California were contracted with to develop a 17 space needs assessment for the City's offices located in the downtown area, and Siler and Siringo 18 complexes; and 19 WHEREAS, the Governing Body directed staff to initiate an amendment to include the 20 Siler Road yard area, in addition to the administration offices; and 21 WHEREAS, currently there is a shortfall of space and there is a long term projection for 22 a continued shortfall of space; and 23 WHEREAS, the space needs assessment determined space deficiencies in the downtown 24 area, over the twenty year term of the assessment, to be 69,000 square feet, of which 26,000 25 square feet is the current amount of space deficiency to alleviate rental space and current

1	congestion; and
2	WHEREAS, the space needs assessment further determined space deficiencies at the
3	Siler and Siringo complexes, over the twenty year term of the assessment, to be 103,000 square
4	feet, of which 54,000 square feet is the current amount of space deficiency; and
5	WHEREAS, as the needs assessment evolved, an opportunity became available to
6	purchase 14 acres of land adjacent to the Siler Road Yard; and
7	WHEREAS, the acquisition of this 14 acre parcel of land by the City, will provide
8	opportunities to centralize city offices and address the immediate and future space, shop and
9	corporate yard needs of the City; and
10	WHEREAS, acquisition of this 14 acre parcel of land by the City will also provide
11	opportunities to master plan the site to include possible partnerships and collaboration with other
12	entities to consider further uses of the property that will support the City's Economic
13	Development Plan; and
14	WHEREAS, the Governing Body must address the space needs of staff to perform their
15	jobs, which is to ultimately to serve the public.
16	NOW, THERFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
17	CITY OF SANTA FE that staff is directed to pursue good faith negotiations to purchase the 14
18	acres of land adjacent to the Siler Road Yard and develop financing options in the event a
19	purchase is contemplated.
