24	Fe, Section 30, T17 N, R10E, NMPM. within the Santa Fe Grant, Santa Fe County, NM,
25	as more fully described in "Exhibit A" attached hereto and incorporated by reference.

1	Section 2. The official zoning map of the City of Santa Fe adopted by Ordinance No.
2	2001-27 is amended to conform to the changes of zoning classifications for the property set forth
3	in Section 1 of this Ordinance.
4	Section 3. This Ordinance shall be published one time by the title and general summary
5	and shall become effective five days after such publication.
6	Section 4. The rezoning action with respect to the Property affected by this Ordinance is
7	subject to the time restrictions set forth in Section 14-3.5(D)(1) SFCC 1987 (Two-year
8	Review/Rescission).
