10 **A RESOLUTION**

11 **SUPPORTING THE 75th ANNIVERSARY OF THE SOCIEDAD FOLKLORICA;**
12 **RECOGNIZING THE BAILE DE LOS CASCARONES TO BE HELD AT THE SANTA**
13 **FE COMMUNITY CONVENTION CENTER ON APRIL 10, 2010 AS AN OFFICIAL**
14 **EVENT OF THE GOVERNING BODY; AND WAIVING ALL RELATED FEES AND**
15 **CHARGES ACCORDINGLY.**

17 **WHEREAS,** Sociedad Folklorica de Santa Fe was established in 1935 to preserve the
18 culture and traditions of the people who settled in Santa Fe; and

19 **WHEREAS,** the Sociedad Folklorica de Santa Fe sponsors its annual Baile de los
20 Cascarones the first weekend after Easter; and

21 **WHEREAS,** the Baile de los Cascarones is part of the mission of the sociedad in
22 preserving the traditional northern New Mexico folklore and customs; and

23 **WHEREAS,** the Governing Body desires to recognize the Baile de los Cascarones as an
24 official event of the Governing Body; and

25 **WHEREAS,** the Santa Fe Community Convention Center policies and procedures

1 authorize the waiver of fees for official events of the Governing Body.


2 **WHEREAS**, Resolution No. 2007-109 authorizes certain waivers or reduction of fees for
3 the use of city facilities for an event of a non-profit organization upon the request of a member of
4 the governing body.

5 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
6 **CITY OF SANTA FE** that the Governing Body supports the 75th anniversary of the Sociedad
7 Folklorica and recognizes the 2010 Baile de los Cascarones to be held at the Santa Fe Community
8 Convention Center on April 10, 2010 as an official event of the Governing Body.

9 **AND BE IT FURTHER RESOLVED** that staff is directed to waive all related fees and
10 charges for the official city event including room rental and equipment use and parking; however,
11 Sociedad Folklorica will be responsible for paying for security costs and submitting the
12 refundable cleaning and damage deposit.


13 **AND BE IT FURTHER RESOLVED** that staff is directed to work with the non-profit
