10 **A RESOLUTION**

11 **APPROVING FUNDING IN THE AMOUNT OF \$20,000 FOR THE SPANISH STATE VISIT**
12 **AND THE MEXICAN PRESIDENTIAL VISIT, EVENTS PLANNED BY SANTA FE 400TH**
13 **ANNIVERSARY, INC. UPON CERTAIN CONDITIONS.**

15 **WHEREAS**, the Governing Body adopted Resolution No. 2007-59 reestablishing the
16 Santa Fe 400th Anniversary Committee which became a nonprofit organization, Santa Fe 400th
17 Anniversary, Inc.; and

18 **WHEREAS**, the city has contracted with the Santa Fe 400th Anniversary Inc. to provide
19 services on behalf of the city for the Santa Fe 400th anniversary commemoration for the years
20 2008 through 2010; and

21 **WHEREAS**, such services have included the development and implementation of
22 projects and programs, for the city of Santa Fe's 400th anniversary that are consistent with the
23 importance of the occasion and that show respect for the collective heritage of the community;
24 and

25 **WHEREAS**, the planned 400th commemoration events bring visitors to the community

1 increasing gross receipts tax received by the city; and

2 **WHEREAS**, because of the difficult economic times, the 400th Anniversary Inc.'s
3 fundraising efforts have been limited and therefore, additional city funds, in the amount of
4 \$20,000, are needed to cover the expenses for a Spanish State visit and a visit from the Mexican
5 President; and


6 **WHEREAS**, the State of New Mexico is expected to also provide funding for the
7 Spanish State visit in the amount of \$30,000 and the Mexican Presidential visit in the amount of
8 \$10,000; and

9 **WHEREAS**, these two special State visits from the Spanish sister cities and the Mexican
10 President will be of great honor to the City and its residents.

11 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
12 **CITY OF SANTA FE** that funding is approved in the amount of \$20,000 to assist Santa Fe 400th
13 Anniversary, Inc. for the Spanish State visit and the Mexican Presidential visit upon the following
14 conditions:

- 15 1. The funding shall come from the Lodgers' Tax reserves;
- 16 2. Written confirmation shall be received from the Governor's Office regarding
17 funding from the State of New Mexico in the amounts described above;
- 18 3. The city's funding shall not be used for any other purpose than the two special
19 visits; and
- 20 4. Staff is directed to prepare a budget adjustment and amend the contract with
21 Santa Fe 400th Anniversary, Inc. accordingly.


