11	OPPOSING THE TRANSFER OF THE E911 PROGRAM FROM THE DEPARTMENT
12	OF FINANCE AND ADMINISTRATION TO ANY OTHER STATE DEPARTMENT OR
13	DIVISION.
14	
15	WHEREAS, the State of New Mexico Department of Finance and Administration
16	("DFA") was assigned to administer the E911 program in order to perform a "pass through"
17	function for funding to the local governments' public safety answering points (PSAPs); and
18	WHEREAS, there were no programs or other interests within DFA that would compete
19	for the dedicated funding; and
20	WHEREAS, moving E911 to another department with other programs places the fund in
21	danger of being raided for other interests; and
22	WHEREAS, no operational efficiency will be accomplished at the state level as a result
23	of moving the 911 program since New Mexico PSAPs are owned and operated by the local
24	governments; and
25	WHEREAS, no cost savings will be realized at the state level as a result of moving the

1	911 program since it is wholly supported through the E911 fund and does not rely on any general
2	fund money; and
3	WHEREAS, New Mexico PSAPs rely on the 911 fund money since any costs not
4	covered by the E911 fund then become the responsibility of local governments and few, if any of
5	the PSAPs statewide would be able to cover the necessary equipment, training, and network costs
6	should this dedicated 911 funding be raided, reduced or lost; and
7	WHEREAS, if the 911 fund money is used for any purpose other than that for which it
8	was originally intended, any federal grant money awarded must be returned, and future eligibility
9	for federal grant funding is lost.
10	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
11	CITY OF SANTA FE that the Governing Body adamantly opposes the transfer of the E911
12	Program from the Department of Finance and Administration to any other state department or
13	division.
14	BE IT FURTHER RESOLVED that the City Clerk is directed to forward a copy of this
15	resolution to the Department of Finance and Administration and the Santa Fe Regional
16	Emergency Communications Center.
