## 1 CITY OF SANTA FE, NEW MEXICO RESOLUTION NO. 2007- 82 2 INTRODUCED BY: 3 4 Mayor Coss 5 Councilor Bushee 6 7 8 9 10 **A RESOLUTON** 11 ENDORSING THE ISSUANCE OF A 25 MILLION DOLLAR GENERAL OBLIGATION BOND BY THE SANTA FE COMMUNITY COLLEGE FOR THE PURPOSES 12 OUTLINED BY THE GOVERNING BOARD OF THE SANTA FE COMMUNITY 13 14 COLLEGE. 15 16 WHEREAS, the Governing Body of the City of Santa Fe and the Governing Board of 17 the Santa Fe Community College are committed to providing economic and educational 18 opportunities for Santa Feans and further believe that a well-trained workforce is essential to a 19 vibrant economy; and 20 WHEREAS, the Governing Board of the Santa Fe Community College District will 21 conduct a special election on September 18, 2007, to request voter approval for a 25 million 22 dollar general obligation bond issue; and 23 WHEREAS, the bond issue will NOT raise taxes; and 24 WHEREAS, the bond will provide students increased educational opportunities with a 25 health sciences facility for nursing, emergency medical technician, and other health occupations

1	training; an occupational trades facility and advanced technology center; information technology
2	upgrades; a renewable/sustainable generation facility; culinary arts and kitchen facility expansion
3	and technology and renewable sustainable energy systems; and
4	WHEREAS, the proposed Health Sciences Center will house a small dental clinic with
5	La Familia Medical/Dental Center which will provide clinical experiences for students and
6	increased access to dental care for many families and children; and
7	WHEREAS, the proposed Occupational Trades facility will provide new and expanded
8	training for students in Santa Fe seeking high-paying, skilled jobs in the plumbing and heating
9	industry, construction trades, green manufacturing and renewable/sustainable energy systems.
10	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
11	CITY OF SANTA FE AND THE GOVERNING BOARD OF THE SANTA FE
12	COMMUNITY COLLEGE that Governing Body endorses the issuance of a 25 million dollar
13	general obligation bond for the purposes outlined by the Governing Board of the Santa Fe
14	Community College and further:
15	1. Urges all Santa Feans to learn more about the bond issue and to vote in the
16	special election being held on September 18, 2007; and
17	2. Directs the city manager to distribute voting information as allowed and
18	according to City rules and regulations; and
19	3. Joins numerous civic groups, the League of Women Voters, La Familia and other
20	governmental entities in supporting the bond issue.
